I am writing this e-mail with mixed feelings. On one hand, hearing the news that the Presumptive Consent Legislation that will include Paramedics is a much needed step in the right direction in taking care of our front line responders. On the other hand, the decision to exclude the Call Takers and Dispatchers is heartbreaking, demoralizing, and quite frankly, insulting.

So far, I have not been able to get a clear answer to WHY the Call Takers and Dispatchers have been excluded from this Legislation, but I can assure you, the work we do is just as likely to cause Post Traumatic Stress Disorder. From coaching a young man on how to deliver his first born, only to transition into teaching him how to do CPR on his lifeless child, to being yelled at and sworn at by a perfectly healthy thirty six year old for not having an ambulance at his front door within ten minutes to help him with his sore knee, the stressors are very real, they are every day, and eventually, you run out of ways to deal with them.

I am not alone in feeling let down and I truly hope that our Provincial Government, Union, and Executives at BCEHS can correct this, and quickly.
