As per or telephone conversation on Friday, here is the information on the different avenues available to dispute your WCAT decision. I would highly recommend you speak to your workers adviser to see if any will work in your case.

It is important to note that WCAT decisions are final and conclusive and that there is not another level of appeal. However, as is set out below, there are limited circumstances under which WCAT can reconsider, correct or clarify a decision, or the Supreme Court of British Columbia can review a WCAT decision.

If WCAT has made a decision on your appeal, WCAT can reconsider a final decision for very limited reasons. This process is called reconsideration.

To qualify for reconsideration, you must show that there is new evidence that was not available when the vice-chair was making the decision; or that WCAT made a jurisdictional error. These are called the grounds, or the threshold, for reconsideration.

Only the appellant or the respondent (or their representatives) can apply for reconsideration of a WCAT decision. There is no time limit to apply for reconsideration. For further information on this, and other post-decision actions, please visit WCAT's webpage at: http://www.wcat.bc.ca/appeals/after/.

Although WCAT decisions are final and conclusive, WCAT can correct any accidental errors or omissions (such as typographical or arithmetic errors) that WCAT notices in their decision.

If you notice any such errors that WCAT may have missed, please let WCAT know as soon as possible by writing to WCAT and, if the vice-chair agrees, WCAT will correct these as well. WCAT tries to make all such corrections within 90 days of the date WCAT sends their decision to you. The following webpage provides WCAT's contact information:

WCAT can also clarify their decision if it is not clear to you. WCAT cannot clarify their decision unless you ask them to do so in writing within 90 days of the date that WCAT sends you their decision. The vice-chair will decide whether clarification is necessary. If the

vice-chair did not decide an issue contained in the appeal, please let WCAT know by writing to them. If the vice-chair agrees that they did not decide an issue contained in the appeal, they will finish their decision by writing an addendum.

You can ask WCAT to clarify or correct a decision, or decide a missed issue, by writing to the Tribunal Counsel Office at WCAT.

You also have the right to ask the Supreme Court of British Columbia to set aside a WCAT decision through a judicial review. The court only rules on the question of whether WCAT made a jurisdictional error. The judge will not rehear your appeal.

You need to perform two tasks when applying for a judicial review. First, file a petition and an affidavit with the Supreme Court of British Columbia. Second, serve these two documents on WCAT, the Attorney General of British Columbia, and the other respondents.

You have 60 days from the date that WCAT issues their decision to file an application for judicial review in court. Sometimes the court will grant an extension of time, but there is no guarantee that it will. The judge will consider the amount of time that has passed and the reason for missing the deadline when deciding whether to grant an extension.

If you do not have a union assisting you with this matter, I would encourage you to contact the Workers' Advisers Office (WAO) to discuss your options. The WAO provides free-of-charge services, including advice on WorkSafeBC benefits and policies, as well as the interpretation of the *Workers Compensation Act*.
