Subject: USA Section 232 – Presidential Proclamation to impose Tariffs on Canadian Steel and Aluminum Products

Sent on behalf of Dale R. MacLean, President & CEO, Tree Island Steel.

Dear Premier Horgan,

I am the President and CEO of Tree Island Steel. I have been reaching out to all levels of Government to ensure that both Federal and Provincial leaders are well informed of the negative impact and resulting injury that faces our company, employees and our industry, with the implementation and on-going application of the unwarranted steel tariffs that were imposed by the United States Government on Canada, effective June 1, 2018.

As you are aware, we have been actively engaged with Ottawa for some time now regarding this important matter. With respect to consultations on contemplated actions on retaliatory tariff countermeasures, as well as having provided alternative considerations for the Government of Canada to assist us through this difficult circumstance.

Mr. Premier, our Federal Government announced last week that it intends to analyze the effects of the new trade dispute to determine what form of assistance is most appropriate for the industry. We are hopeful that we will have a voice in this discussion and that the Province of British Columbia will be invited to participate and be able to advocate on behalf of B.C. based companies like ours through collaboration in these meetings and decision making processes, where interests of the workers and steel industry of British Columbia can be championed and defended.

I would appreciate and respectfully request the opportunity to meet with you to engage in meaningful and more fulsome discussions to ensure that our Government's leadership is fully informed on both the current and downstream implications and what this means to British Columbia. Thank you for this consideration.

I know it's length but it's great. So I would use all of the following text — subject to the Minister's approval — with a photo of him speaking to the crowd:

Many think of Labour Day as the end of summer, but to me it has always represented a beginning – the start to real change for workers. The first Labour Day in 1872 was an act of courage, since unions were still illegal and activists were jailed. Workers realized, however, that there is strength in unity, and they used this unity to advocate for fair pay and safe working conditions. The courage and sacrifice exhibited by these workers resulted in meaningful change, leading to better and safer working conditions for all workers – then and now.

This government is standing up for workers by: increasing the minimum wage each June for the next three years until we reach at least \$15.20 by 2021; engaging with WorkSafeBC to reduce preventable workplace accidents and become more worker centric in the services they provide to injured workers; and planning to introduce this fall a Temporary Foreign Worker registry to better protect vulnerable workers in B.C.

Workers deserve – and should demand – safe working conditions, and I am firmly committed to making workplaces in British Columbia the safest in Canada. That is why earlier this year, we Proclaimed May 1 as “International Workers’ Day” to recognize the contributions of workers. It is also why we remembered Ginger Goodwin on the hundredth anniversary of his death, to acknowledge the important achievements and progress made by those who stand up for fair and safe workplaces. I encourage everyone to learn about your rights to a safe workplace and the minimum standards of employment established in the legislation for which I am responsible as Minister of Labour.
