



He is trying to find full time entry level work but all the non-management positions are only being offered at very limited hours.

I'm quite certain these big corporations limit hours to employees by design in order to eliminate benefits and to ensure they have a workforce there for backup when people transition away from work.

My suggestion to my constituent is to get trained at a new skill that would support his limited mobility but have you ever heard of legislation that would force big companies (Walmart, Superstore, etc.) to hire full time employees instead of numerous part time ones? This constituent seems to think this happens in other jurisdictions outside of BC.
