Dear Sir, Dear Madame,

Mr. Trevor Hughes, Deputy Minister, Ministry of Labour (BC) to whom I have sent this email me, recommended to me to file with you my complaint about severe violations in matter of labor and other issues.

I am a Munich, Germany located director, producer, acting as that internationally since 1990.

I have been participated with my films at the most renowned international film festivals (more than 250 worldwide such as Cannes, Venice, Montreal. L.A., NYC, Huston, Melbourne, Paris, Bilbao), I was short listed for the Academy Awards (Oscars) and being awarded with more than 150 important awards and distinctions in Germany, USA, Greece, throughout the world etc.

I am a full and voting Member of the European and the German Film Academy, both in Berlin Germany (members are accepted only upon distinctions and upon invitation, recommended by two members) as well as member of the Collecting Society of Directors VG BILD-KUNST, Germany, member of the Collecting Society of Authors VG WORT, Germany, member of the Collecting Society of Producers VGF, Germany, member of the Collecting Society of Directors-Authors ATHENA, Greece and member of the Directors' Guild of Greece.

I have never encountered such a unserious business behaviour (to say the least) in my almost 30 years professional career and practice by a corporation as below described.

I was assigned to shoot in Greece, direct and produce video footage by the corporation named ELDORADO GOLD, located in Vancouver, British Columbia, Canada and its subsidiary in Greece (HELLAS GOLD S.A.) (May 2018 – July 2018) for the HEALTH & SAFETY WEEK of this corporation, which took also place simultaneously on the sites and mines of ELDORADO GOLD in Canada, Greece, Turkey.

Please be aware: all that happened in the presence of ELDORADO President George Burns and other officers of this corporation from Canada (who were visiting the sites & mines Greece) as well as General Manager and officers of its Greek subsidiary and whom we were assigned to shoot while they were proclaiming and demonstrating the HEALTH & SAFETY RULES of this corporation to the employees of HELLAS GOLD during the specific HEALTH & SAFETY WEEK.

- The daily call sheets were so scheduled by the project managers of the corporation during shooting in Greece that in order to achieve the shooting of the required footage the project manager and its officers forced me my crew to work up to almost 18hrs per day (somedays from 4:30 am 10 pm).
- The daily call sheets were so scheduled by the project managers that forced me and my crew to work with no 11 hours break between the end of one shooting day until the beginning of the next shooting day at the morning.
- During the entire shooting day they allowed us only a 20 minutes lunch break in total per day (even during the 11 hours working days).

Also during shooting this project in Halkidiki, Northern Greece, and I repeat, in the presence of ELDORADO President George Burns and other officers of this corporation and its Greek subsidiary, in order to participate and to proclaim the HEALTH AND SAFETY WEEK (what an irony), we were forced to rush from the one construction site to the other and from the one mine to the other breaking constantly the speed limits in order to shoot as much as possible material in the shortest period they had hired us as possible.

All that endangered me and my crew many times and in many ways.

Although many other violations occurred while preparing, shooting & finalizing this footage with my crew (besides the LABOR, HEALTH & SAFETY violations, also CODE OF ETHICS, CODE OF GOVERNANCE violations occurred, they offered us no working or assignment contracts to sign, which all break the rules and policies of this corporation, copyright infringement etc.), I have delivered the requested footage on time (by late July 2018) but they did not paid me in full (payment due in August 2018) for my services, rejecting to pay overtime, over length of the footage they requested to deliver them etc.

Nevertheless they have produced a video with our footage in Vancouver, Canada, uploaded it at their website last autumn 2019, at which they have incorporated my footage.

I have by early and middle of December 2019 I was forced to file twice a complaint with their President George Burns and cc'ed their officers and managers in Vancouver, British Columbia, Canada in order to pay me, besides the fact that I have informed them thoroughly in writing and orally in Canada as well as in Greece (since May 2019 until November 2018) about all those violations personally at their Greek headquarters in Athens, Greece and tried that the case may be settled but they ignored my reports and claims.

I am located in Europe and they believe I am too far away to pay attention to my complaints. But I have my crew, the magnetic cards that record our entry and exit times from their constructions sites and mines as well as the digital footage that "speaks volumes" and records the dates, hours and everything while we were working there that may witness and confirm my claims.

Additionally:

On Wednesday, December 19th and on Thursday, December 20th, 2018 I sent 5 personal emails separately to the staff of the Mining Association of Canada (MAC, www.mining.ca, http://mining.ca/about-us/mac-staff), Pierre Gratton (President and Chief Executive Officer), Justyna Laurie-Lean (Vice President, Environment and Regulatory Affairs), Ben Chalmers (Senior Vice President), Geoff Smith (Vice President, Government Relations), Tara Shea (Senior Director Sustainability and Aboriginal Affairs) (all emails available upon request) and to their central email: communications@mining.ca requesting that each of the 5 different MCA members of the board of directors and the central MAC email address advise me about the responsible departments and persons within their association who are in charge of these matters and where I could file my notices / claims about the practices of a MAC member which are not compatible with the law, i.e. hazards and severe violations of the HEALTH & SAFETY RULES, violations of CODE OF ETHICS & GOVERNANCE, and payment delays by ELDORADO GOLD / HELLAS GOLD.

For some strange reason none of those 5 members of the MAC board nor anyone from the central email: communications@mining.ca replied to me ever.

This is surprising and I wonder whether this is compatible with the agenda that the mining association of Canada (MAC) professes to promote on its site www.mining.ca and in its mission statement: "... MAC promotes (...) and works with governments on policies affecting the sector and educates the public on the value of mining.... social responsibility, etc.".

Was it by coincidence that 3 days after I had asked the MAC board members for information (on Wednesday, December 19th, 2018) about where I could file my claim with the MAC departments relating to hazards and severe violations of the HEALTH & SAFETY RULES, violations of CODE OF ETHICS & GOVERNANCE, and payment delays by ELDORADO GOLD / HELLAS GOLD and policies by ELDORADO, an extrajudicial notice from their Greek subsidiary arrived in my email inbox (on Friday, December 21st, 2018) which was full with lies, inconsistent statements, references to non-existent things and fully unacceptable notifications, requests, and also returning to me the invoice I had sent to Hellas Gold almost one month earlier on Tuesday, November 27th, 2018)!

Are there any dark forces in the universe threatening me and trying to stop me from talking after they realized that I am serious about filing my claims in Canada, Greece as I announced them I they do not react to my reports and claims?

Why was this extrajudicial notice by their subsidiary in Greece not sent to me many months earlier, since, according to them, it raises issues which arose many months before, as they claim?

Is it a coincidence, finally, that their subsidiary Hellas Gold decided to respond to me after I had sent my 6 email requests to the Mining Association of Canada because they were informed by MCA, since an ELDORADO GOLD Officer sits at the MCA EXECUCUTIVE BOARD and so ELDORADO was informed and realized that I was serious when I said that I would report my claims to the Canadian governmental agencies, associations, labor and professional guilds and other related bodies in Canada, in Greece, internationally?

It is therefore not surprising at all that the Hellas Gold extrajudicial notice (sent to me on Friday, December 21st, 2018) does not even contain a single word referring to those severe violations.

Could you please advise which might be the further actions and steps that may be taken by the governmental agencies in Canada in order to force them to comply before I hire a legal counsel or resort to any other judicial actions in Canada, which is an expensive matter?

Do you have the possibility to send them a complaint letter, or is there any arbitration panel in Canada or any other governmental agency that might send them a letter or similar and remind of their obligations and duties regarding all violated policies?


