It is ultimately up to the federal and provincial labour relations boards to decide whether a particular situation is governed by federal or provincial labour relations law, which is a legal question that can depend on the facts of the situation. Having said this, the Ministry of Labour's understanding is that the airport food service workers described in Andrew MacLeod's article in the Tyee today, "Why the Person Serving You at YVR May Soon Be Jobless", would likely fall under provincial regulation, on the basis that the provincial Labour Relations Board has assumed jurisdiction in cases involving similar workers.
