Dear Members of the Labour Code Review Panel. The Honourable Mr. Harold Bains and the Honourable Premier John Horgan,

Ladies and Gentlemen. As you all know the British Columbia Labour Code represents three parties, the Employer, the Union as well as the Union Member. The Employers are represented by Mr. Barry Dong. The Unions are represented by Ms. Sandra Banister and this is all chaired by Mr. Michael Fleming. Why is there Not any Legal Representation for the Union Members on this Review Panel? *and* Are you Mr. Bains going to appoint a Legal member/delegate to represent those Unionized Employees on to this newly established Labour Code Review Panel? As it is, Unionized Employees can only attempt to vindicate themselves through the Ombudsman's office and made Whole via the Coroners office with a Public Inquiry when it involves a WCB claim and/or Human Rights complaint where a Union has inferred and blatantly violated section 12 of the Labour code in doing so.

Mr. Bains Sir, please don't tell me this Review Panel is only structured as a perfunctory courtesy and an avenue to exonerate the newly elected NDP Government from the previous Liberal Governments negligence and malice only to carry on with that perverted justice the Liberals have previously established in the past 16 years? There are a lot more feathers to ruffle in the roost here other than ^{s.22} on this one and you can start with WCAT Vice-Chairs ^{s.22} and whoever was involved in ordering the complete maceration of my WCAT audio evidence under section 35 of the ATA other than ^{s.22} himself. If you would please Sir, give WCAT Vice-Chairs ^{s.22} a call and ask him, "Just exactly what happened in your courtroom on ^{s.22}?" He's an honest man. He truthfully answered my post hearing question when I asked, "... In other words go talk to my local MLA?" "YES!"

Leave Denied BCLRB RG Properties No. B378/2003 and Leave for Reconsideration BCLRB No. 252/2003. Other issues directly related to this matter is the intentional deletion and consequences involved of Policy #96.20 from the WorkSafeBC Rehabilitations Service and Claims Manual (RSCM) that no longer exists in the current Volume II edition as well as the BCHRT's "Gate Keeper Role" when it involves Union employees pursuing a Human Rights complaint. The Union may own your Labour contract according to Weber v Ontario Hydro but they do not own your Human Rights, Civil Liberties and Rights to Health Care from work related injury with a WCB claim and this where ^{s.22} has maliciously and negligently abused his LRB Chair authority for 16 years.

The enclosed attached is my January 16, 2018 Letter/Submission to Ms. Irene Lanzinger President of the BC Federation of Labour which she has failed to respond to me personally. There are a number of issues I wish the LC Review Panel and the NDP Government to address without prejudice within that submission and this one as well. BACKGROUND:

- Since 2006, B.C.'s Civil Forfeiture Office has operated under the authority of the *Civil Forfeiture Act*. The Act and Regulation allows the Director of Civil Forfeiture (the Director) to initiate civil court proceedings against property believed to be the instruments or proceeds of unlawful activity.
- The Criminal Asset Management Fund has operated under the authority of the *Criminal Asset Management Act* (CAMF) since 2012. The Act allows the Director to manage and dispose of assets restrained, seized or forfeited under the *Criminal Code* and other criminal law statutes.
- In partnership with the Civil Forfeiture Office, the Community Safety and Crime Prevention Branch administers the Crime Prevention and Remediation Grant Program, which provides one-time funding through the proceeds from civil forfeiture.
- Priority areas for grants are established on a year-by-year basis through consideration of government's current strategic initiatives.
- The recipients of this year's grants were primarily selected through an open call for proposals that was announced in November 2018.
- This year's grant funding streams were:
 - (1) Crime Reduction and Crime Prevention
 - (2) Indigenous Healing and Rebuilding
 - (3) Restorative Justice
 - (4) Violence Against Women - Domestic Violence and Sexual Assault
 - (5) Human Trafficking, Sexual Exploitation and Vulnerable Women in the Sex Trade
 - (6) Child and Youth Advocacy Centres
- The Crime Prevention and Remediation Grant Program received over 440 proposals in 2018/2019 totalling approximately \$16M in funding requested.
- A small number of direct award grants will be issued to meet government priorities related to victim services and violence against women including training for front line service providers.
- A formalized review and assessment process is in place for the evaluation of all grant applications. (See attached Appendix A for details on grant review process).
