Viv,

As per our discussion I think there is more at play than the simple transparency of an agency LDB does business with (i.e., the building owner). I would typically advise that the name of a person/company who owns a building that we lease is required to be released as a matter of course, as we release this in response any FOI request for building lease documents. Particularly related to the safety of buildings and persons involved with the cannabis warehouse, we must err on the side of caution and perhaps not – as a matter of routine release – provide the name of the building owner to the media, particularly without consulting with them first.

My preference is to defer Mr. Mackin to making an FOI request (Note: he may now request far more than just the name). In doing so, the formal response from Government's FOI branch (Information Access Operations) will be provided, and if he is provided the name so be it.

As advised, I defer to Blain to make the determination of whether to engage with the owner and get his agreement to release his name to the media, or request that Mr. Mackin make an FOI request.

I trust this will be helpful. Please let me know what Blain's decision is on this matter.
