



## **LIQUOR DISTRIBUTION BRANCH**

The list provided is all positions that were open between May 2020 to January 20, 2021. This includes positions that permanent and temporary greater than 7 months. Temporary less than 7 vacancies may be filled via relief outside of a formal competitive process. Expressions of Interest (EOIs) that were posted and managed by individual departments, EOIs or projects are paid at home rate of the employee's position, so we do not have a way to track or find that information.

Relief is determined by individual departments and relief is claimed by inputting a relief code that indicates classification level but not the position being relieved for. There is no report that can be pulled showing this information by position type as that information is not inputted into PPIIMS.

Since March 2020, the LDB has followed Provincial Health Orders and advice for workplaces and adapted workplace safety plans as needed. (Measures including but not limited to things like: limit the number of people in your workplace where possible by implementing work-from-home arrangements where operationally possible, establishing occupancy limits) As the LDB remained open across all worksite, there is no tracking of the number of people who work from home when operationally possible.

The number of accommodations where employees were unable to work at a worksite between January 22, 2016 and January 22, 2021 are not tracked in a system that produces reports. Accommodations are reviewed on an individual basis, based on the specific factors of that situation. There is an extensive spectrum when it comes to accommodations ranging from 1 hour/day that is managed by the work location to a situation impacting an Employee's ability to perform their job duties. As a result, the LDB is unable to respond more specifically to the request.

Across all worksites at the LDB 50 employees requested an accommodation for medical reasons made due to the Coronavirus. Of the 50, 2 employees were granted general leave, and 2 were denied general leave. The remaining 46 employees are at varying levels of determination of eligibility for STIIP, general leave, or a variety of other possible outcomes. There is no system that tracks this output, so we can't provide more specific details.
