- 3. Ride Sharing (Uber) both support but not at the expense of the existing industry

As reported in the Vancouver Sun:

- Do everything in the government's power to oppose the expansion of the Kinder Morgan pipeline, including withholding relevant provincial permits for the project and engaging in court action.
- Introducing legislation to ban corporate and union donations in the first sitting of the next session and put limits on donations.
- Introduce legislation to call a referendum on proportional representation to coincide with the fall municipal elections in 2018, and if possible introduce in time for the 2021 provincial election.
- Extend the term of the government to four and a half years, by moving the legislated spring election date to the fall of 2021.
- Immediately refer Site C dam to the B.C. Utilities Commission for review, but not pause or halt construction during that review.
