

After my initial review I have a number of items that need clarification before I may proceed:

 As you hold a food primary licence and the main focus of your license class is the service of food I will require you to draw in a table next to each one of the 40 loungers. Hand drawn is fine as long as it is legible.

Tables drawn in on the attached layout

2. I will also require the floor plan to be stamped showing occupant load as determined by your local government. This generally is provided by the local building or fire authorities. I note that you have these plans stamped by a qualified architect which is fine, however I will require confirmation from your local government that the numbers are acceptable.... ie a note on the plan, an email or letter from a building inspector or Fire official or a stamp similar to the one on your current floor plan:

Fire Chief has not provided me with the stamped occupant load. I will follow up with him tomorrow

2. Please tell me what the *Wait Station Service Area* is? Is this a liquor service bar? If not, please describe how liquor will be served on the beach patio?

The wait Station will be set up to do liquor service at the beach patio and will be managed by a server. The menu at the beach patio will be made of drinks that can be prepared at the wait station. This way we will not have to deliver drinks from the cantina. Food will be

ordered by a POS station at the wait station and the food will be delivered to wait station for the server to give to the customer.

3. Can you tell me the approximate distance of the walkway from the existing patio to the proposed beach patio?

The distance is 70 feet

4. Please tell me how the patio will be managed when in use by patrons? Will there always be staff present?

There will always be a staff member present during the service hours at the patio beach area that will be from 12pm – 7pm. The staff member will have their serving it right and will follow proper service procedures.

As this patio will be located on sand I will need to see a Health Authority stamp on the floor plan.

6. You have advised the patio is defined or bounded on three sides by 6 foot high wooden fencing with one entrance point. Please bear in mind that the patio will need to be defined on all sides. Therefore, on the lake side, you will need to bound the patio in some fashion as the water's edge is not considered appropriate. Please describe what will be used as bounding on the lake side?


