Recently, two very serious incidents occurred at Cactus Club — Nanaimo and Cactus Club — Kelowna, Banks Road.

The Nanaimo incident is currently being investigated. Two patrons were seriously assaulted resulting in hospitalization.

The Kelowna incident involved an assault. The victim succumbed to his injuries resulting in an on-going homicide investigation.

With bars and clubs using Serveall to identify patrons it appears gang member and person with a propensity for violence are making more use of restaurants for their activities. Restaurants such as Cactus Club, Earls, Joeys, etc. do not make use of identification scanning equipment. Persons with a propensity for violence use anonymity to perpetrate their crimes and as such restaurants provide that environment.

In Kelowna, we have seen a drastic reduction in violence and police calls for service in and around the bars and clubs using Serveall. This appears to have displaced persons barred from these establishments, gang members and persons with a propensity for violence to lesser security-wise

establishments. This displacement has resulted in an increase in violence at these establishments. My concern is the escalation of this violence.
