Roseanne,

Given the sensitive legal issues surrounding the province's court proceedings involving Kinder Morgan, I would like caucus members to have the following advice:

- Members of Executive Council (cabinet) should not attend rallies or demonstrations on the Kinder Morgan issue;
- Other members of caucus may attend provided they do not by words or actions suggest they are participating on behalf of the government – in practice, obviously, this is a very difficult distinction to make and probably mitigates against attending; and
- No member of caucus should condone illegal action of any sort.

Difficult as these recommendations may be, it's important to keep in mind that the government has:

- Intervened in the Federal Court, with Thomas Berger as special counsel, to challenge the NEB approval that has allowed the project to proceed on the grounds that the NEB failed to consider BC's interests; and
- Ensured, by its intervention in the provincial court case that it upholds the province's fiduciary and legal responsibilities in such a way as to safeguard the province's role as a statutory decision-maker on the project.

My office is asking George Smith, of the AG's office, and Caelie Frampton, from Minister Heyman's office, to assist in providing further information you may require.
