ADDRESSEE: Leaders of the Opposition

I am taking this opportunity to write to you to advise you regarding arrangements involving the services of the Office of Legislative Counsel (OLC) to non-government members.

This is in follow up to correspondence in October in which OLC's services were offered on a trial basis but only with respect to the drafting of House Amendments. At this time I am able to confirm that OLC will draft, at the request of a non-government party, not only House Amendments, but also Private Members Bills which the non-government party wishes to introduce.

Once again, this drafting service will be offered on a trial basis as it will be necessary for OLC to assess available drafting capacity relative to any demand for these services. OLC will designate a Deputy Chief Legislative Counsel for Members' Drafting, who, with a team of two other drafters, will handle all private members' drafting projects. The Deputy Chief (Dawn Leroy) should be contacted to initiate any drafting projects or if there are any questions.

As in my previous letter, OLC does not provide policy analysis or solicitor advice. While OLC will identify the existence of possible constitutional issues they cannot provide specialized constitutional advice. Any non-government party instructions (and the resulting drafts) will be held in strict confidence. Questions (and requests for drafting services) can be directed to Chief Legislative Counsel, Corinne Swystun (or Kevin Kohan).

We've received a couple of media queries. One from Jean Sorenson who freelances for a number of lawyer publications. Another from Ian Mulgrew. Our response to both will be the message below.

There is good news for the Legal Services Society in today's budget speech.

The Finance Minister had this to say about legal aid funding:

Safety goes hand in hand with access to affordable, quality legal services. Over the years, cuts to legal aid and reductions in family law services have left people without legal representation and torn families apart. That's why we're expanding legal aid, including Indigenous and family law services, with a \$26 million investment over the [three-year] fiscal plan.

This is the largest funding increase for legal aid since 2002 and is nearly a 12 percent lift over last year. This is a clear indication that government values the work undertaken by LSS and is a positive step toward improving the services British Columbians count on.

While LSS's budget has yet to be approved by the Ministry of Attorney General, we anticipate that it will include:

- A \$4.7 million increase for expansion of our core family and child protection services
- A \$3.8 million increase for expansion of our justice transformation initiatives (particularly the Parents Legal Centre)
- Plus a \$4.3 million increase for criminal legal aid through the federal-provincial cost sharing agreement.

The new funding will allow us to meet the priorities outlined in our mandate letter from the Attorney General to improve access to justice for indigenous peoples and to better meet the legal needs of low income families. It will also allow LSS to offer a wider range of services to low-income British Columbians and to provide more support for the lawyers who serve legal aid clients.

Details are still being finalized, but some of the many expected enhancements include: reinstating discretionary family law services that were eliminated in 2017, providing legal representation for extended families in child protection cases, additional hours for Gladue submissions in criminal cases and opening new Parents Legal Centres in several locations around the province as recommend by Grand Chief Ed John in his report on Aboriginal child welfare.

We know that lawyers regularly put more time into a file than they are paid for so LSS will also be adding hours to the tariffs to compensate lawyers for dealing with the many challenges legal aid clients present. In balancing service demands with our fiscal capacity LSS determined that expanding client services and increasing the number of hours available to lawyers should be our first priority to recognize the important work of our lawyers. We believe that by working with government we can continue to make progress on other outstanding issues

With more than \$12 million in new funding coming to LSS this year, there is a lot of work ahead of us. We will need to draft policies, make changes to the tariffs and do the necessary training. While some changes can be made immediately, many will not be in place until the fall.

We are grateful to the Attorney General for his support for legal aid and for his commitment to improving the lives of those most in need.

I will have regular updates for you as our plans develop.

In addition to the A2J information, the Minister asked for the following:

1. **Abbotsford Courthouse** – The Minister asked, Is the Abbotsford Courthouse was included in Budget 2018? It will be included in 2 places in the budget. First, the ministry service plan (tab 11 of the binder) page 22 discloses that the projected cost of Abbotsford Courthouse is \$157 million. Second, in the Budget and Fiscal Plan, it will be disclosed in the list of all government capital projects over \$50 million. It was also disclosed on this list in the September Update to Budget 2017, see link, page 40. The costs of the Abbotsford Courthouse, because it is a major capital project, is shown under (and the expenditures are charged to) the Ministry of Citizens Services, not AG.

2. **Legal Aid** – The Minister asked, For how many years was the \$8.7 million the largest increase to legal aid? This is the largest increase to legal aid since before 2001/02. To clarify, in the 2001/02, LSS was provided an increase, but this was not for an increase in programs, instead it was transition funding, as the LSS budget was significantly reduced in 2002/03.
3. **Tribunal Forecast** – Breakdown of the forecast v budget by tribunal. Please see attached latest forecast by tribunal.
4. **Ministry Forecast** – Please see attached latest forecast. As you can see on the first page of the document, the ministry is currently forecasting to be \$3.5 million over budget. This is due to overages in the IIO and Court Services offset by savings elsewhere in the ministry. This deficit has come down from earlier in the fiscal year and is expected by Treasury Board Staff. We will be doing a TB

submission in the next couple weeks to seek additional contingency access to cover the shortfall.

Wegadesk (youth role model poster attached), the "accused" has pulled himself out of a history of abuse and trauma, and is a youth leader, famous National athlete in the sport of diving and,

role model. Being highly intelligent and in the face of injustice he is no longer willing (how he must have coped when being sexually abused by his National coach) to silence his voice: he is representing himself and has made many attempts to work with the Crown prosecutor (baljinder.girn@ppsc-sppc.gc.ca) to help resolve the issues in the words of the Prime Minister through collaboration and partnership. Unacceptably he has been continuously ignored, silenced and his inherent rights as an Indigenous person diminished.^{s.22}

Background

B.C. is planning to introduce legislation on so-called anti-SLAPP lawsuits during the spring session.

The Attorney General, working side-by-side with the Aboriginal Justice Council, has initiated the development of an "Indigenous Justice Centre". An indigenous organization, the Native Courtworker and Counselling Association of British Columbia, has accepted the opportunity to take the lead on developing and operating the IJC. The NCCABC will receive support from the Legal Services Society and the Ministry of Justice. The goal of the IJC is to increase access to justice for Indigenous peoples in British Columbia. Under consideration is an integrated legal clinic model that would not only offer services by lawyers and paralegals but also by native courtworkers, mediators, advocates and housing experts.

Relevance to UNDRIP

Article 18 Indigenous peoples have the right to participate in decision-making in matters which would affect their rights, through representatives chosen by themselves in accordance with their own procedures, as well as to maintain and develop their own indigenous decisionmaking institutions.
Article 19 States shall consult and cooperate in good faith with the indigenous peoples concerned through their own representative institutions in order to obtain their free, prior and informed consent before adopting and implementing legislative or administrative measures that may affect them.

Child Protection Mediation

Work is currently underway to develop a new practicum program for adding to the roster of qualified people in the province who can work as child protection mediators to mediate between MCFD and families. One of the goals of this practicum is to increase the number of Indigenous mediators.

Parent's Legal Centre

The Parents' Legal Centre (PLC), operated by Legal Services Society with funding and oversight from the Ministry of Attorney General, provides legal aid and related services to help families

resolve their child protection matters early in the process, keeping more matters out of the courtroom where possible. In its first three years of operation, nearly half (48%) of its clients self-identify as Indigenous and 78% were single parents. The PLC is located in Robson Square, Vancouver, with a new site launching soon in Surrey, one of the locations recommended by Grand Chief Ed John in his November 2016 report in which he praised the PLC model for its effectiveness in assisting Indigenous clients.

Indigenous Parenting After Separation Course

Justice Services Branch is in the early planning stages with the Justice Institute of BC to develop the curriculum for a culturally appropriate version of the online *Parenting After Separation* course.

Memorandum of Understanding to Develop an Indigenous Justice Strategy

On September 7, 2017, the Ministries of Attorney General and Public Safety and Solicitor General and the BC Aboriginal Justice Council signed a memorandum of understanding to develop a joint Indigenous Justice Strategy. The strategy will focus on addressing key priority areas such as reconciliation, overrepresentation of Indigenous peoples within the justice system, improving the experience of Indigenous people within the justice system, addressing violence against women and girls, and improving access to justice. The ministries are providing capacity funding to sustain the BCAJC's participation in this important work and to enable joint development of the strategy over the next two years. This funding will support the BCAJC in meaningfully engaging with other Indigenous leaders, organizations and communities in the development of this strategy.

Indigenous Courts

Since the fall of 2017, two new Indigenous Courts have been created in BC bringing the provincial total to six. The Nicola Valley Indigenous Court in Merritt was launched in October 2017. The Prince George Indigenous Court will launch in March 2018. These courts have been developed to take a holistic, culturally appropriate approach to Indigenous offenders, and seek to address the underlying factors that lead to criminal behaviour, provide culturally relevant support and develop a healing plan to assist in reconciliation. Indigenous Courts have been developed in consultation with local First Nations, the community at large, police, Community Corrections, Crown counsel, defence lawyers, and the Native Courtworker and Counselling Association of British Columbia. Indigenous Courts currently sit in five communities, including New Westminster (since November 2006); North Vancouver (includes Whistler, Squamish and the North Shore, since February 2012); Kamloops (since March 2013); Duncan (since May 2013); and Merritt (October 2017).

Memorandum of Understanding to Develop a Shared Ten-Year Social Determinants of Health Strategy for First Nations Peoples in BC

The Ministry of Attorney General continues to support the Memorandum of Understanding between the Government of British Columbia and the First Nations Health Council (FNHC) to develop a shared ten-year Social Determinants of Health Strategy, which was signed in March 2016. The Ministry is working with the federal government and FNHC to develop a joint work plan to develop social determinants priority actions for the justice and public safety sector.

Please note that comprehensive information on how government is addressing the calls to action is collected and compiled periodically by MIRR staff. We recently submitted our updates, at the request of MIRR. If they have not already done so, MIRR staff can and should provide the Minister of Indigenous Relations and Reconciliation's MAs with a copy of the detailed table, populated with input by ministries, which includes examples of efforts completed and/or underway.

Request

The reporter is working on a story about a convicted financial fraudster.

There are two convictions: one in 1998 and another in 2001. Each conviction was 2 years less a day.

The reporter is asking 2 things:

1. Can we verify that the restitution/fine from a known conviction was paid, and if yes, where it was paid?
2. Is it correct that the public cannot know whether someone convicted of a crime has served their sentence or how much of their sentence they served? If so, why?

Background

CSB can answer #1 if it relates to a fine, but not if it's a case of restitution. For #2, Corrections Branch (PSSG) has jurisdiction on the administration of sentences and should provide that portion of the response.

Recommendation – provide background

Can the ministry verify that the restitution/fine from a known conviction was paid, and if yes, where it was paid?

- Court Services Branch (CSB) can only advise what the court imposed as sentence, and that depends on whether the associated disposition is restitution or a fine.
- Restitution is payable in most cases directly to a named recipient and if it is unpaid, the recipient can file a copy of the restitution order as a judgment in civil court. CSB cannot advise whether it is paid as the funds do not come through the court.
- If it is a fine, the funds are collected by CSB and we keep a record of the payment showing disposition is complete.

Is it correct that the public cannot know whether someone convicted of a crime has served their sentence or how much of their sentence they served? If so, why?

- PSSG has already informed the reporter that they cannot confirm if an individual is or has been in BC Corrections' custody for security reasons.
