



Here is some additional information from ICBC regarding the backlog and the current ICBC definition as they use it. What I see is a growing number of open files which as Chris notes may be for a variety of reasons – I will be interested in seeing the PwC report and what insight they offer on the backlog. While the case load may be going down on a per FTE basis the raw numbers are trending up per the attached spreadsheet.

Hi Shauna –

For clarity, what we believe s.22 is referring to when he says "backlog" is in fact our "pending" or "open" claims. It is important to note that the claims in the pending or open category could include files that could have been there for minutes or years – it essentially is any file that has been opened and has not yet been closed. It may not necessarily be analogous for s.22 is to use both the term "backlog" and "pending" – as there are a variety of reasons why a file is "pending" that do not have the connotations associated with backlog. As you note, part of the operational review by PwC will look at this and we are keen to see what conclusions the reviewers will find in this regard, including if there should be additional metrics on these types of files.

In just the last two years (calendar 2016 vs. calendar 2014) represented BI intake has increased 28%. In spite of this, overall BI claims closures are up 8% and represented BI closures up 15% over the same period. Additionally, less BI

claims are being resolved at trial, with 99.7% of all BI exposures successfully resolved without a trial; the number of BI exposures resolved at trial has declined by 25% since 2014.

With respect to claims staffing, we agree this has been an issue. Following the government review in 2012, a hiring freeze was implemented which focused on staffing levels and operating costs. As a result, ICBC's front-office claims staffing levels remained relatively flat from 2012 until 2015 with approximately 2,100 full-time equivalents (FTEs) each year. Prior to the hiring freeze (between 2008 and 2012), there was a decreasing trend in the number of crashes on B.C. roads. However, those numbers began to increase in 2014. The rising number of crashes also led to sharp increases in the number vehicle damage and injury claims being reported. By the end of 2015, these factors combined resulted in lower front-office claims staffing levels to service the volume of claims coming in (intake). ICBC did not respond rapidly enough. But we have been aggressively hiring to address the increased intake and have committed to do more since this summer. And there has been some success in that regard. Average pending caseload per FTE at the end of 2016 was noticeably lower than prior years, reflecting the significant hiring effort undertaken and we're currently maintaining similar results ending September 2017.

Attached is a slide deck that visualizes some of this material discussed (Attached – Closure and Pending.pdf). Of interest is slide six which shows that the average age of a pending file is reducing.

My apologies the earlier note did not address the questions you and the minister were looking for. I hope the above clarifies, but certainly I am happy to get any and all additional detail you may need further.

You're right, that's not backlog data. I would have assumed ICBC had a definition in order for |s.22 to conclude the following. "The growth in the BI claims backlog shows the effects of more claims and the staffing reduction in the claims division. From 2008 to 2010 ICBC recorded about 51,500 pending BI claims at year-end. Since then there has been a steady increase, and by 2015 there were almost 70,000 BI claims pending (up 36%)."

Below is the data that ICBC has provided. I am not sure it will completely satisfy your interest. One of the items we spoke to PWC about last week when we were scoping the contract was the claims backlog. In the TOR we reference the following:

- 1. Assess service quality and ICBC's productivity in processing claims both vehicle side and bodily injury. Is there potential for changes that could or would result in improvements to overall service quality and productivity?
 a) Conduct a qualitative review of a random sample of ~100 claims over the past two years. This sample will include lower, medium and higher-value claims; early settlements vs claims that take longer to settle (including those that went to trial). Specific claimant/adjustor interviews will not be required but rather higher-level findings and assessments;
 - b) Examine the claims backlog to the extent that one exists assess the appropriateness of the number of pending open claims and pending claims amounts within the current claims environment and best practice, trends over the last five years, and identify any further opportunities for improvement.

One of the specific requests we had for PWC was to determine a definition of a "backlog" in the ICBC context. So there can be clear understanding for many audiences of what we (ICBC) means by that word. PWC will also be doing further work on the analysis of the backlog.

Closed Claims

- ICBC is closing more injury claims a year despite an escalating number of new injury claims being reported in 2016, ICBC closed 66,400 injury claims, an increase of 19 per cent from 2012.
- Despite the rapid increase in the number of new injury claims being reported, <u>ICBC's rate of closed</u> claims stayed almost exactly the same, decreasing by just 0.01 per cent from 2012 to 2016.
- ICBC is also closing more represented claims every year in 2012, ICBC closed approximately 21,000 represented files; in 2016, ICBC closed approximately 30,000 represented files.
- ICBC is actually **closing more claims every year overall** despite an escalating number of new claims being reported in 2016, ICBC closed 746,000 claims, an increase of 17 per cent from 2012 (635,781 in 2012 compared to 745,951 in 2016).

Hello All,

Please find attached the draft working product for the operational review of ICBC. This is a work in progress, and as such will require further revisions and formatting regarding visuals and structure.

In addition to the report, we are providing to you a context summary below for the content included in this work product.

PwC has completed the Current State Review of Operations and Identification of Opportunities phases of the ICBC Operational Review. The operational review was focused on the Claims, Finance and Driver Training Compliance business areas, as the Ministry identified those as areas of the greatest of opportunity to manage costs. Previous external reviews have covered other areas of the organization extensively.

As part of the data gathering and fact-finding, PwC interviewed a cross-section of over 40 ICBC management and unionized staff, conducted file reviews of over 100 for each of closed claims files, and completed material damage estimates, reviewed recommendations from external reviews conducted from 2012 to 2017. PwC also applied its proprietary Insurance Operations Capability Model to assess ICBC's operational performance for the in-scope business areas relative to leading practices of the Canadian and international automobile insurance market.

Our review of the claim backlog indicates that though ICBC on occasion has a higher than expected backlog, in general, newly reported claims are assigned to an adjuster within 24 hours and is in line with leading industry practices. As such no significant backlog exists. In addition, we also reviewed the claims pending which refers to when a claims has been reported and the handling has been initiated by the adjuster. Claims remain pending for the duration that a claimant is receiving treatments for injuries, or their vehicle is being repaired, and the claim settlement is deliberated upon. ICBC has made significant efforts in recent times to reduce claim duration and reduce claims pending by increasing the number of injury adjusters (up from 510 in 2011 to 660 in 2016). External factors such as increasing claims frequency and claims severity increase the average claims pending because it impacts the volume and duration of claims. The current volume of claims pending files is in line with expectations given ICBC's full tort auto insurance product environment.

The summary findings for the current state of the three business areas (Claims, Finance and Driver Training Compliance) are that the processes and the way ICBC is organized to deliver these services, based on the current service model, are generally cost efficient and in most cases, at or above the industry average, but there are some opportunities to change the claims service model to make it more cost effective.

A number of opportunities were identified that could lead to reduction in overall claims costs while maintaining or improving quality service levels for ICBC customers. These have been categorized and summarized into five broad initiatives for ease of implementation:

- Optimizing vendor management and strategic sourcing changes to how ICBC manages vendors
 including legal, auto repair, and medical providers, better leveraging ICBC's buying power, adopting leading
 sourcing practices and redefining relationships with vendors based on quality of service and incentivizing
 innovation for cost efficiencies.
- Improve salvage and subrogation management to establish enhanced procedures and protocols with the overarching goal of improving the quality and quantity recoveries from salvage (unrepairable vehicles), and/or subrogation (at-fault or out-of-province third parties) to better manage these costs.
- Shifting to a proactive injury care recovery model including treatment plans similar to WorksafeBC's. ICBC can't mandate but can provide and encourage claimants to take advantage of better options and access to

defined courses of treatment specific to their respective injury(s) and ongoing guidance and support from the adjuster(s) to optimize and accelerate the rehabilitation/recovery process. This should benefit the claimants in terms of faster and better recovery outcomes and reduce overall claims costs through more effective use of medical providers.

- Shift to a more supportive claimant customer experience by augmenting strategies and refining customer interactions to be more fair and transparent, by enhancing the claimant's understanding of the claim processing and their role in achieving positive outcomes, and providing information and options for claimants to make more informed and better choices.
- Enhance automation and predictive analytics by leveraging the significant investment ICBC has already made in technology to further reduce or eliminate manual tasks and make better use ICBC's extensive provincewide and historical data to identify future trends, potential fraud, and provide more forward-looking information.

The next phase of the operational review will be to further refine the required activities within the identified initiatives and qualify and quantify the potential benefits and key implementation considerations. These will be included in the final report.

We look forward to discussing with you the draft report in our meeting on Wednesday.







 - ii. Assess reasonableness of methodologies and key assumptions; and
 - iii. Review ICBC calculations and conduct sensitivity analysis around key assumptions.
- c. With respect to investment earnings for the current and future estimated reporting years, the Contractor will:
 - i. Determine sources of key assumptions. This will include a review of November 2017 year-to-date information;
 - ii. Assess reasonableness of methodologies and key assumptions; and
 - iii. Review ICBC calculations and conduct sensitivity analysis around key assumptions.
- d. If material, conduct same procedures as a. c., in relation to accident benefits.
- e. Assess and utilize if appropriate, alternative methodologies or procedures to evaluate the consolidation of detailed forecasts prepared by ICBC and used in the Base Case Forecast.

- g. Prepare reports on section 3.7 c) as follows:
 - i. Prepare and submit to the Ministry Lead, or such person as the Ministry Lead may designate, a Draft 3-page Summary of Findings Report on Section 3.7 c) a e;
 - ii. Prepare and submit to the Ministry Lead, or such person as the Ministry Lead may designate, a Final 3-page Summary of Findings Report on Section 3.7 c) a e;
 - iii. Prepare and submit to the Ministry Lead, or such person as the Ministry Lead may designate, a Draft Summary of Findings Full Report on Section 3.7 c) a e; and
 - iv. Prepare and submit to the Ministry Lead, or such person as the Ministry Lead may designate, a Draft Summary of Findings <u>Full</u> Report on Section 3.7 c) a e;
- d) If requested, the Contractor will utilize the work on Section 3.7 c) a f to independently prepare a Contractor Base Case Forecast, utilizing same or alternative methodologies and assumptions as the Contractor believes is appropriate.
