RECOMMENDED RESPONSE:

- We believe in a fair, progressive tax system where everyone pays their fair share.
- By asking the top 2% to pay a little bit more, we can ensure that we have the kinds of schools, hospitals, housing and other services that British Columbians need.
- We are asking those who have benefited the most from skyrocketing housing prices to pay just a little bit more.

If asked: Does this increased school tax apply to apartment buildings?

BACKGROUND:

Starting in 2019, the Province will be increasing the school tax on homes assessed over \$3 million. A news release by Goodman Report sent Feb. 27 2018 mischaracterized the application of the tax, claiming that rental apartment buildings would be subject to the tax, creating confusion with stakeholders and in the media.

Effective 2019, the Province is introducing a province-wide increased school tax on high valued residential properties. This increased tax applies to the portion of a residential property's taxable assessed value that exceeds \$3 million. In the case of a mixed use property, only the residential portion is subject to the tax.

The new tax rates are as follows:

0-\$3 million	Rate varies with school district
Value over \$3 million	0.2 per cent
Value over \$4 million	0.4 per cent

The Province estimates the increased school tax will raise an additional \$50 million in 2018/19.

The tax will be administered through the existing school tax system, with municipalities and the Province's Surveyor of Taxes responsible for tax collection.

The budget bill tabled on Feb. 20, 2018 is clear that apartment buildings are not subject to the increased school tax. The increased school tax applies to dwelling properties. A dwelling property is defined as a property used as a residence for 3 or fewer families. Therefore, **properties with 4 or more families are not subject to the tax.** Stratified condos and townhomes are subject to the tax if the unit is valued over \$3 million.

Questions and Answers – School Tax Increase

What is the B.C. government doing with all these new property taxes?

- We believe in a fair, progressive tax system where everyone pays their fair share.
- By asking the top 2% to pay a little bit more, we can ensure that we have the kinds of schools, hospitals, housing and other services that British Columbians rely on.
- That's why we're asking those who have benefited the most from skyrocketing housing prices to pay just a little bit more.
- The school tax on the top 2% of homes will increase by 0.2% on values between \$3 million and \$4 million and 0.4% on values over \$4 million. This kind of progressivity is the cornerstone of a fair tax system.

What is the school tax?

- The school tax is the provincial portion of residential property taxes and applies to all residential properties in B.C.
- It is calculated based on each property's assessed value.
- School tax rates vary by school district, according to an existing formula.

Is the school tax just for schools? If yes, why does someone with no kids have to pay it? If not, what's it for?

- The school tax applies to all residential properties in B.C. It is one of the taxes on the annual property tax notice and has existed for decades.
- Revenue raised from the school tax goes into general provincial revenue, to fund schools, hospitals, housing and the services we all rely on.

What is the history of the residential school tax?

Why is the government increasing the school tax on residential property over \$3 million?

- For too long, housing prices in B.C. have soared unchecked, driving a housing affordability crisis and creating an increasing inequality gap in our province.
- Our plan is tackling the housing crisis and making the system more progressive.

 We're asking those who have benefited the most from soaring prices to pay just a little bit more.

Why was \$3 million chosen as the threshold for the school tax increase?

- This is about making the province more progressive. This change applies to the top 2% of residential properties in BC.
- We're asking those that have benefited the most from rising housing prices to contribute a little bit more.

Who has to pay the increased school tax? Does it matter if I'm a British Columbian or a foreigner?

- The additional school tax applies to the portion of a residential property's value that exceeds \$3 million.
- In the case of a mixed-use property, only the residential portion is subject to the tax.
- The tax is applied to the property, based on the assessed value. It does not take into account the homeowner's citizenship or residency.
- We have taken additional measures to decrease housing demand from BC non-residents, including expanding and increasing the foreign buyers tax and moving forward with a speculation tax.

I have a property worth \$2.99 million. Do I have to pay the tax?

- The owner of a residential property with an assessed value of \$2.99 million would not pay additional tax.
- The increased school tax only applies to property value that exceeds \$3 million.

I have a property worth \$5 million. How much tax do I have to pay?

- The owner of a property with an assessed value of \$5M would pay additional school tax at the following rate:
 - 0.2% on the value between \$3M-\$4M (\$1M) = \$2,000
 - 0.4% on the value that exceeds \$4M (\$1M) = \$4,000
 - Total additional school tax = \$6,000
- This tax can be deferred through the existing system if needed.

What are the new school tax rates?

 The additional school tax rates, which apply on top of the general school tax rates, are as follows:

Value over \$3 million	0.2 per cent
Value over \$4 million	0.4 per cent

When does the increase come into effect?

The increased school tax is effective for the 2019 tax year and subsequent tax years.

What analysis did you do to determine this rate/threshold?

- Ministry staff did extensive analysis on housing across British Columbia.
- This included consideration of housing demand and supply, housing starts and inventory, housing prices, house market behaviour and trends, interest rates, economic growth, rising population due to in-migration and geographic trends.

Does this increase unfairly impact homeowners in larger cities?

- Homeowners in urban areas such as Metro Vancouver have greatly benefitted from rising housing prices.
- Increasing the school tax helps improve the progressivity of the property tax system.

Does this increase unfairly impact people who have lived in their homes for a long time?

- Homeowners such as seniors who may have lived in their homes a long time are still able to defer their property taxes, including the increased school tax.
- Further, these individuals will have seen the greatest appreciation in home values as a result

of the housing crisis.

Can the increased school tax be deferred? Who can defer?

- Yes, eligible homeowners (seniors and families with children) can defer their property taxes, including the increased school tax if their property is assessed over \$3 million.
- The property tax deferment program is a low interest loan that allows eligible citizens and permanent residents to defer paying all or part of their property taxes on their principal residence.

Will you increase the Home Owner Grant to help offset this increase?

• Owners of the most expensive 7% of homes do not receive a grant.

Does the increased school tax apply to apartment buildings?

- The government has been clear that rental apartment buildings are not the subject of changes to the school tax.
- That's why the budget bill tabled on Feb. 20, 2018 includes this exclusion.
- The Ministry of Finance is available to answer technical questions if individuals or organizations require assistance in interpreting or understanding legislation.

I have a property worth over \$3 million comprised of 3 rental suites. Do I have to pay the increased school tax?

- A property with 3 or fewer families is subject to the increased tax.
- A dwelling property is defined as a property used or intended to be used as a residence for 3 or fewer families.
- Properties for 4 or more families are <u>not</u> subject to the tax.

How does the rate reflect assessed value?

• Property owners see their tax change, depending on the change in their home's assessed value and its location.

What is the history of rate changes on school tax?

- Successive governments have chosen a policy that sets residential school tax rates to increase by the previous year's provincial inflation rate (generally, before HOG).
- This policy has been in place since 2003. Tax rates are set using a formula that is based in equal part on:

- o The total number of residential properties in the school district; and
- The total residential assessed value in the district.

How much revenue will this increase raise for the government?

 Budget 2018 estimates that the increased school tax will raise \$50 million in 2018/19 and \$200 million in 2019/2020.

What will the government do with this increased revenue?

• The revenues from the increased school tax will help fund the health, education, housing and other services we all depend on.

How does the increased school tax fit into the 30-point housing plan?

- Increasing the school tax on B.C.'s top 2% of homes helps improve the progressivity of the property tax system and will help stabilize the market.
- We're asking those who have benefitted the most from soaring property values to give a little bit more for the services we all rely on.

Thank you to all of the volunteers and registered attendees for our scheduled Town Hall for tonight. I have some difficult news.

As you know, my job is to represent my constituents. I can only do that if I can hear from constituents. Hearing from community members is critically important to me, regardless of whether the feedback is positive or negative.

I have been meeting with constituents and I have heard the opposition and the concerns associated with an increase in the school tax that will impact those with homes valued over \$3M in my constituency of Vancouver Point Grey.

I have also heard from many others in our community about their appreciation for government funding the seismic upgrade at Bayview Elementary, increasing funding for chronically understaffed schools, and for helping them to reduce overwhelming childcare costs and MSP premiums.

I thought it would be beneficial to have a community discussion about the school tax, including accurate information about the policy, while giving people a chance to provide feedback directly to government. When tickets sold out, we considered a telephone town hall, but settled on a live streaming of the event.

In response, ads were run by two separate real estate agencies encouraging non-constituents and people without tickets to attend the event. The leader of the BC Liberals personally wrote a letter and distributed it, encouraging individuals to attend "whether you have a ticket or not."

We pressed on, knowing the importance of the event to many community members. But the tactics of the opponent groups ramped up.

The final straw was the rescheduling of the protest for "angry" people to "march on in" to the event an hour and a half before the event itself, making it impossible for us to secure the venue in advance.

We were no longer able to ensure only those with tickets could attend, which meant we could not ensure safety. We had, as we always do, scheduled high school students and seniors to help us staff the event as volunteers – not as security guards to hold the line against people trying to "march on in" without a ticket, or to escort guests with

tickets through crowds of angry people to get them to the front door. If that wasn't difficult enough, my constituency staff, as well as those identified as supporters of the tax, have now become a personal target of some individuals. For the first time in my career of hosting literally hundreds of community events on difficult topics of all kinds, I have decided to postpone the town hall until we can ensure we can hold it safely. We have a proud five-year tradition of community events in Vancouver Point Grey without incident, and I will find a way to continue this tradition. In the meantime, I will continue to engage and meet with constituents on this and many other matters, and find a way to hear from constituents in a group while assuring that this can be done in a welcoming way for everyone.

Questions:

Can the Minister comment on the creation of the BC RCMP's new position "Financial Criminal Special Adviser"?
Could amplify on a few of the comments he made to the federal finance committee in Ottawa? What evidence the province has of a direct link between illicit money being

channeled through casinos and illicit money in our real estate market? Can the Minister comment further on his comments re: FINTRAC and its lack of enforcement mechanisms?

Follow-up questions:

What's Mr. Eby's reaction to the RCMP creating this special advisor position on financial crimes?

Money laundering obviously exists across the country. For the benefit of our readers outside of BC, can Mr. Eby explain what makes the situation in BC stand out?

During his testimony in Ottawa Mr Eby stated: "Money laundering is not a victimless crime. It's also connected to the fact that we have big problems in our real estate market." Can he more precisely connect the dots? How is the laundering of money in casinos intertwined with soaring prices of real estate? Is it that drug ("dirty") money is being funnelled into casinos and then people walk out with "clean" money that is then used to purchase real estate? Where are the biggest gaps in enforcement? Is it with RCMP lacking financial crime experts? Is it FINTRAC requiring casinos and realtors to report stuff but there1s no follow-up enforcement? Is it casinos/realtors not doing their part in reporting suspicious activities in the first place? All of the above?

Background: The position RCMP position the reporter is referring to is described here:

The federal government plans to directly award the contract to John Ahern (currently a senior legal counsel at his own firm, previously worked for the Criminal Justice Branch and the RCMP.

Have been unable to identify any information about the BC-RCMP position through GPEB.

Statement has been drafted from the AG's speech to the federal finance committee, as

well as some of German's verbatim recommendations for that meeting.

Recommendation – provide statement from the Attorney General

Statement from Attorney General David Eby "The issue in British Columbia is so notorious, and so severe, that at least one international intelligence community now calls a model of money laundering the "Vancouver model." "In the Vancouver model of money laundering, a wealthy individual from China, a country with strict currency export controls, wants to gamble. A gangster will meet that gambler at a Casino, offering cash in amounts as high as hundreds of thousands of dollars. The cash is the proceeds of gang crime. To pay for the cash, the gambler agrees to transfer money in China from his bank account into a bank account under the control of the gang. The gambler walks the illicit cash into the casino, completes a FINTRAC reporting form, buys chips, gambles, and on leaving, either cashes out, receiving a cheque, or carries the chips out of the casino. "In sum, the criminal gang has successfully laundered difficult-to-manage twenty dollar bills, moving the money out of Canada while keeping their names off FINTRAC forms. Those involved in the transaction can truthfully report that everyone is following all of the reporting rules.

"In terms of gaps in enforcement, there are a range of factors at play. A major issue I raised with the federal committee in Ottawa was the need to dedicate federal RCMP resources to B.C. to support us in this fight against money laundering and transnational crime. It's a bigger issue than just B.C. It's an international issue and we need that support to deal with it.

"FINTRAC does a very good job of collecting reports and entering them into a database that's available to law enforcement. However, FINTRAC, the RCMP and Revenue Canada need the resources to

follow up on these reports. There is no question there has been a massive failure here.

"In Ottawa, I asked the federal finance committee to investigate why all these reports go to FINTRAC without seeing any prosecutions for money laundering. I asked the committee give FINTRAC and the RCMP the powers that they need to be able to investigate and prosecute this kind of activity.

"Other factors include:

 lawyers to FINTRAC is a significant
 gap in Canada and is a significant
 impediment to police investigations
 involving the movement of money
 through real estate and other
 financial sectors.

 work within FINTRAC, due to
 privacy concerns. Any opportunity to
 broaden the use of the intelligence
 housed within FINTRAC would be a
 benefit.
- <!--[if !supportLists]-->• <!--[endif]-->In 2012, the RCMP eliminated its national Proceeds of Crime and Commercial Crime Sections, in favour of a new task force orientation to investigations. Although indications are that the RCMP is now rebuilding its financial crime expertise, the gap in federal policing in this important area between 2012 and 2017, displaced responsibility for 'white collar' crime to provincial and municipal police, who generally did not have the resources or expertise to take on these complex files.
- <!--[if !supportLists]-->•<!--[endif]->Finally, the defunding of B.C.'s
 integrated casino policing team in
 2009 allowed suspicious transactions

to climb in B.C. casinos. Large, suspicious transactions continued unabated from 2009 until late 2017, when our new government instructed B.C. casinos not to accept large cash transactions unless they could confirm the legitimate source of the funds.

"Further details about enforcement will be available when we publicly share Dr. Peter German's report on British Columbia's antimoney laundering policies and practices in Lower Mainland casinos.

"At this time we don't have any details on the B.C. RCMP's new financial criminal special adviser position, but we are encouraged to hear that efforts are being taken to increase enforcement.

"Recent media reports of money laundering through real estate in British Columbia are very serious and deeply troubling. Our government will work to determine the scope of this issue, and what must be done to appropriately address it.

"Dr. German was directed to explore what connection, if any, the issue has with other areas of B.C.'s economy. We are in the process of reviewing his report and will provide government's response in due course. However, given the severity of the issue, I have asked Dr. German to take on a second round of investigation specifically around money laundering through real estate."
