At the request of the No. 10 Downing Street, the British MP David Lammy, recently conducted a review of the British justice system, specifically with regards to the over-representation of Black, Asian and Minority Ethnic individuals within the prison system. While researching the report, he visited Vancouver in January of this year and met with the previous Attorney-General.

The final report has been released and I attach a copy, in case of interest. Colleagues across the board in BC, and in the AG's office, were very helpful in providing David Lammy MP with insights into the judicial system here, particularly as regards the proportion of indigenous individuals within the justice system.

VICTORIA – Attorney General David Eby released the following statement today:

"The Trans Mountain pipeline expansion project significantly impacts British Columbia – with a disproportionate impact on B.C.'s marine coastal environment and Indigenous peoples. British Columbia has been granted intervener status to ensure our provincial interests are heard in this matter.

"The argument in our Memorandum of Fact and Law reflects our status as interveners, and not full parties to the appeal, and adheres to the submission length set by the court. It outlines the failure of the federal government to properly consider the profound economic risks associated with a bitumen spill on our coast, and does so to ensure B.C. has a voice in these proceedings.

"British Columbians can have confidence that we will continue to defend B.C.'s coast and the economic and environmental interests that are so important to us all."

The argument in our Memorandum of Fact and Law reflects our status as interveners, and not full parties to the appeal, and adheres to the submission length set by the court. It outlines the failure of the federal government to properly consider the profound economic risks associated with a bitumen spill on our coast, and does so to ensure B.C. has a voice in these proceedings.

British Columbians can have confidence that we will continue to defend B.C.'s coast and the economic and environmental interests that are so important to us all."

The EY Report is dated November 23, 2015. That audit covered the period **Oct 1, 2013 – July 31, 2015** and was a comprehensive audit of the entire AML Programme.

The FinTRAC Audit is dated July 14, 2016. That audit covered the period **September 1, 2015 to February 29, 2016** and was a comprehensive audit of the entire AML Programme.

The MNP Audit is dated July 26, 2016. That audit covered the period **September 1, 2013 to August 31, 2015**. This audit focused only on select transactions at River Rock.

In addition you may recall that MNP based its work on a data extract from our database – something which has never been done before. We were able to determine their finding that mandatory fields in a number of large cash transaction reports (LCTs) were left blank, and thus were non-compliant, was in error as a result of apparent data corruption occurring during their data extraction process. We checked the LCTs in question both in our database from which the extract was taken and the FinTRAC database. The reports were complete and compliant. We asked MNP to confirm our findings by directly auditing our database rather than the extract and/or confirming directly with FinTRAC the reports were in fact submitted in compliant form. MNP declined to follow either course and did not make any changes to their report.

One other item that was noteworthy was that despite starting off being described as an audit, when the work was concluded MNP inserted into its report on page 3 “This engagement is not an audit and did not include any control testing”.

People living with HIV continue to be singled out for unjust prosecutions in cases of alleged HIV non-disclosure, driven by misinformation, stigma and fear — even in cases where there is little or no risk of transmission. These miscarriages of justice also undermine effective public health responses.

I ask you to immediately undertake the following actions:

1. Limit the use of criminal prosecutions for HIV non-disclosure to circumstances of intentional, actual transmission of HIV, in keeping with international recommendations.

2. At the barest minimum, ensure that criminal charges are under no circumstances used against people living with HIV for not disclosing their status to sexual partners where they use a condom, practice oral sex or have condomless sex with a low or undetectable viral load.

3. Stop the use of sexual assault charges in cases of HIV non-disclosure as it constitutes a stigmatizing and harmful misuse of this offence.

For many years, community members have highlighted the injustices taking place and conveyed the unacceptable reality that such prosecutions are having a disproportionate impact on the most marginalized and vulnerable of persons living with HIV. It is time for Canada and its provinces and territories to show true leadership. Unjust and harmful prosecutions must end NOW.

In April, the reporter visited a cider festival in Vancouver where he spoke with some makers, who were brushing up against the province's taxation policy for ciders brewed in the city.

From the reporter: "the current policy lumps these smaller cider makers in with hard-liquor-based bottled drinks (like Schmirnoff Ice), while those who make cider on orchards, outside of the city, are categorized differently and subject to less taxation. The urban cider makers see the taxation policies as limiting the growth of their industry; they compare it to craft beers, which became huge once similar taxation policies were altered.

Questions:

- 1) Can the AG please clarify his position on why these small, urban cider makers are and should be subject to this extra taxation?
- 2) Does the province or AG have any plans to address the concerns of these urban cider makers and re-categorize them, or change the taxation policy in any way? And why or why not?

Recommendation: Provide background and Minister quote.

On background:

- B.C. cideries follow the same rules as B.C. wineries.
- B.C.'s land-based winery policy supports a made-in-B.C. industry that promotes traditionally-manufactured wine and cider products and agricultural and tourism opportunities.
- The Liquor Distribution Branch (LDB) undertakes a fair and thorough assessment of businesses applying to be land-based wineries/cideries to ensure they meet the necessary criteria.
- The criterion for a land based winery/cidery designation requires wineries/cideries to have at least two acres of vineyards or fruit orchards at the licensed site. In addition, a minimum of 25% of the grapes/apples used in production must come from land owned or leased by the producer.
- If a winery/cidery meets this criteria, the LDB allows them to keep the funds generated through the mandatory government mark-up on their products for direct sales. The mark-up exemption is given to land-based wineries due to the significant expenses and additional rules and criteria involved in operating a winery/cidery under the land-based winery policy and in recognition of the policy principles of supporting agricultural and tourism opportunities.
- The LDB is happy to work with manufacturers who are seeking to bring their business model in line with the land-based winery parameters.
- Manufacturers that don't qualify to be land-based wineries are classified as commercial wineries.

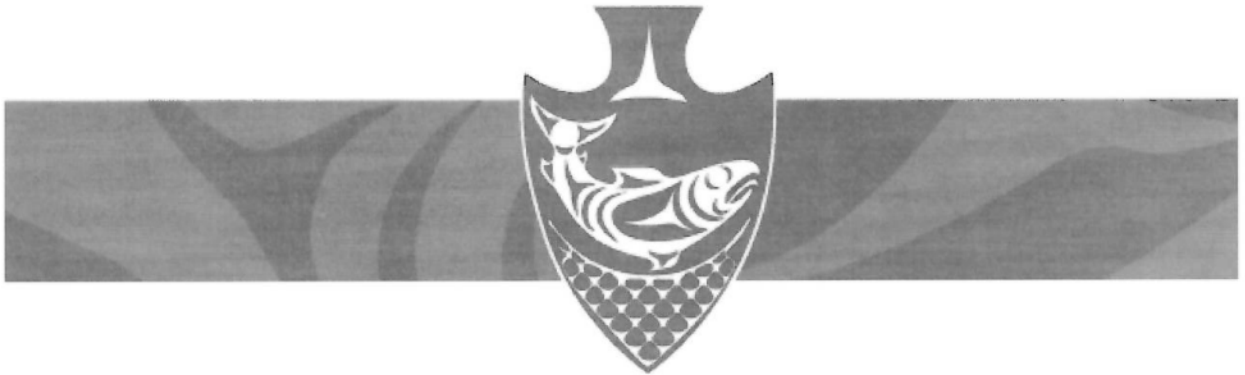

UEL neighbours, through the Community Advisory Committee have been lobbying the provincial government for many years to reform how local decisions are made in the UEL.

As your provincial representative, for the last four years, I've been presenting your concerns and demands for local government reform to the various Ministers responsible, with no apparent results. Even Freedom of Information requests I filed failed to reveal any of the work that we were told consultants were busy doing on behalf of the UEL's requests for reform.

I'm sure that many UEL residents will be aware that there has been a substantial change in Victoria since the May election. For example, instead of being an Opposition MLA, I am now BC's Attorney General, and I am also responsible for ICBC, as well as gaming and liquor policy in the province.

This change in government creates a unique opportunity for us to work together.

I am pleased to advise you that late last week, I met with your "Mayor", Selina Robinson, a former city councillor from Coquitlam. I expressed to her and her staff your unambiguous wish to be moving forward on the issue of governance reform with a full governance study.

I advised that you want to have a local voice on local issues, and that flying Assistant Deputy Ministers in from Victoria to hear variance matters was neither efficient, nor particularly sustainable given the growth in the community that will come with the Block F development.

The Minister was receptive to these concerns, and has asked her staff to identify and implement a process that moves the discussion on local government forward in a real and visible way.

I do not wish to understate the lengthy process of real local government reform and a governance study. But a journey of a thousand miles begins with the first step. I am honoured and pleased to tell you that we have heard your requests, and we are putting our walking shoes on.

Staff will be providing a report to the Minister in the Fall that will lay out a strategy to address your concerns. Both the Minister and I will work together to keep you informed about this important work.

I look forward to working with you in my new role, as part of your new government in BC.
