Dear Mr. Horgan:

My comment is mostly a question regarding ICBC's impending rate increases: have you or the body responsible for ICBC's financial situation review looked at car repair costs in BC? My personal experience in BC, as am sure for thousands of other BC residents, is that most, if not all mechanical shops working with ICBC overcharge between 200 to 800% for spare parts over and above their purchase costs. Example: yesterday a single car suspension part which can be bought, legally and with warranty, delivered to my domicile was about \$ 55; cost at a local shop (who shall remain unnamed for the time being) \$ 176, a mark-up, paid by ICBC of about 320%

If you put thousands of small transactions like this together, in a year, this overcharging (price gouging?) probably amounts to several million dollars. Which us, ICBC clients, are being forced to pay
