### Request

Can you explain what the new brand BC Cannabis Store is?

- The B.C. Government used in-house graphic services to develop the BC Cannabis Store brand, which aligns with the BC Liquor Store brand. No additional costs were incurred.
- The brand will be used as the LDB creates a new and separate business operation to support the wholesale distribution and sale of non-medical cannabis.

Will these stores be physically separate from liquor stores?

- A cannabis retail store must be a self-contained business.
- There will be exceptions for rural stores, similar to rural liquor stores. The criteria for determining rural areas are currently under development

- We're following the recommendations made by the federal government's task force, which cautioned against co-locating liquor and cannabis, a position also supported by B.C.'s Provincial Health Officer.
- They believe co-sale might be seen to condone and encourage co-use of cannabis and alcohol, which is particularly dangerous with respect to impaired driving; also, selling cannabis in liquor stores could lead to a larger proportion of the population being introduced to cannabis, including many who might not otherwise encounter it.
- Nova Scotia and the Northwest Territories are the only jurisdictions in North America that plan to co-locate alcohol and cannabis sales. No U.S. state that has legalized cannabis allows co-location.

Can you explain how online sales will work? Are there any plans to develop an app for sales as well?

- The LDB is expected to open the first government-operated retail store by late summer, and is working to implement an e-commerce solution to offer online sales to the public. The LDB is in the process of selected an eCommerce software provider, which will be announced in the near future along with more details regarding the online sale of non-medical cannabis.

How much cannabis can be sold at one time, per individual?

- Retail stores (both government and private) will only be permitted to sell a maximum of 30 grams of dried cannabis (or its equivalent in oil) to an individual at one time. BC Cannabis Stores will be the province's sole online cannabis retailer.

**Request**

The reporter is looking for more background on the two different definitions of minor injury at ICBC. The Feb. 6 press release from government had an initial definition: “The new legal definition will include things like sprains, strains, mild whiplash, cuts and bruises, anxiety and stress from a crash. It does not include broken bones, brain injuries (concussions) or other more serious impairments.” Yesterday’s backgrounder added “pain syndrome, psychological and psychiatric conditions or an injury in prescribed class of injury, even if chronic.” That wording was not in the February backgrounder.

The reporter would like to know:

- 1) What does the additional phrase add to the definition of minor injury?
- 2) The original release mentioned a requirement that doctors will diagnose that information and that if it still persists after 12 months then it will become a major injury outside of the cap. The press release yesterday did not contain that wording. In the bill, the 12-month clause and the clause on doctors remain, correct?

**Recommendation:** **provide background**

- **The amendments lay the foundation for the new legal definition for what constitutes a minor injury in B.C. and were developed after consultation with medical stakeholders, including Doctors of B.C.**

- That definition will be further refined in regulation and informed by consultation with medical treatment providers, as well as other jurisdictions that have already made similar changes as the regulations are developed.
- British Columbia's legislation has more details on the definition of a minor injury than is the case in Alberta, Nova Scotia or New Brunswick where similar limits on pain and suffering awards for minor injuries are in place.
- Putting the details into regulation will provide flexibility to update the definition, if needed, in future years, as is the case in other jurisdictions.
- Details of a prescribed class of injury, along with physiological and psychiatric conditions, will also be defined in regulations.
- Regulations provide the flexibility to update the definition, if needed in the future.
- As previously announced, it is intended that if symptoms for some injuries persist and have a significant effect on activities of daily living, such as work and school, beyond 12 months, then the injury would no longer be considered minor. At any point during recovery, a medical professional can determine if an injury diagnosis has changed and should no longer be considered minor.

The reporter has the following questions on the ICBC legislation:

- 1) The news release on the legislation says that the amendments will simplify dispute resolution processes for cases under \$50,000. However, he does not see that number in the legislation. Why is that?
- 2) The news release also mentions a limit on pain and suffering damages for minor injuries will allow ICBC to redirect resources. The reporter can not find that language in either bill and would like to be directed to where he can find it.

### Recommendation - Provide background:

- The amount for pain and suffering, as well as the amount for cases under \$50,000 that will be set for the CRT will be set in regulation. s.13

### Request

The reporter would like to know if all the things that ICBC proposed for public consultation in March – changes to auto insurance discounts, free crashes, medical benefit levels – are going to be decided later by cabinet order/regulation? Does the legislation today basically just enshrine the \$5,500 cap, as well as sets the 5 year review of medical benefits and the civil resolution tribunal?

After the minister’s scrum, the reporter asked ICBC if there is any more of a breakdown on how the \$1 billion in savings are specifically achieved?

### Recommendation – Provide background

- The limit of \$5,500, the five-year review of the medical benefits and amount of medical benefits will be set by regulation.
- Legislative amendments re: Civil Resolution Tribunal will be effective at Royal Assent, except for the amount for cases under \$50,000 that will be set in regulation.
- The government’s rate fairness engagement results will be used to inform ICBC’s BCUC filing later this year.

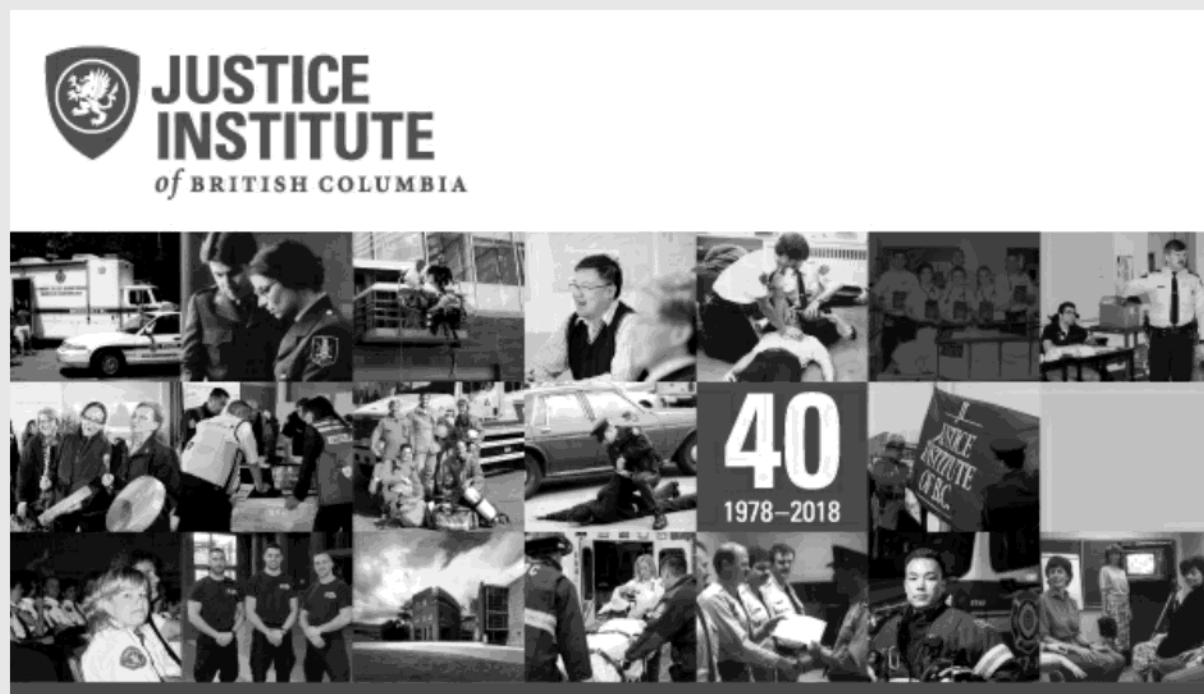

What are David's past times and hobbies?

I feel like I used to have a lot more pastimes and hobbies before taking on this job and the shared responsibility with my wife of raising a small person – life is pretty busy these days. When I have spare time, I spend it hanging out with my family, skiing, playing guitar, and catching up with pals.

Did you play a particular sport as a child or play an instrument?

I played hockey and baseball throughout my youth, and of course, basketball in high school. I took piano lessons for years, and even though I ended up playing much more guitar as an adult, that musical training was invaluable to me.

What is the last or current book you are reading?

I've got a pile of books on my night stand waiting for some summer reading. Top of my pile will be Rob Shaw and Richard Zussman's book "A Matter of Confidence"...although on reflection maybe that's a bit too close to the day-to-day for summer reading.

What are the last three movies you have watched?

My wife and I had a date night last week and saw Armando Iannouci's the Death of Stalin. So great. We tend to be Netflix centric these days, and the last series I binged was Ozark – fantastic.

What is your favorite lunch?

When I meet people for work lunch at home in the constituency, we walk up the street from my office and go to the Banana Leaf. In Victoria, it's the legislature restaurant lunch to go – I usually get the veggie melt with tomato soup.

Can you cook ? What is your best dish?

I love to cook. We lean heavily on Fresh Prep these days – they do all the sous chef work for you. It's that happy medium between cooking from scratch and managing time for a family dinner with a busy team.

What is your favorite activity to do with your family?

We love skiing together, Ezra is only three, but his mom has helped him build quite an impressive skill set.

You are married and have two children/ages? (No pressure to answer questions re family)

Yes. My wife is an RN, or rather, she was an RN, she's gone back to school and is about to graduate from Medicine at UBC. Our son is three.

As AG, you are really the top cop now, but you spent a lot of your legal career with a critical eye directed at the police. How has your history helped or hurt your current role?

My colleague the Solicitor General proudly holds the role of “top cop” in the province, but you’re right, I spend a lot more time than I expected to – for example - calling for increased resources for police to deal with our challenges with organized crime and money laundering in the province, or supporting police intervention on distracted drivers. My history with the Independent Investigation Office, which is responsible for investigating police involved deaths, has greatly assisted me in coming up to speed quickly on the challenges that office has faced in fulfilling its mandate, and to support them in getting things back on track. I’ve been pleasantly surprised by the open, frank and engaging conversations I’ve had with police representatives to date on challenges we face – I think our shared history has actually helped us get to the heart of the various issues we’re discussing more quickly.

As for the Rule of Law, I suggest the scales of justice in BC are lop-sided due to a weak LSS funding. How do you feel about this?

Our government has provided the biggest financial boost to LSS in 16 years. That’s, of course, a low bar, but we’ve already provided more funding than we committed to provide to access to justice initiatives during the election campaign. There is so much work to do in this area to ensure access to justice for British Columbians. We’re just getting started.

Where is LSS funding on the priority list of the government?

Access to Justice, with a particular emphasis on remedying the injustices faced disproportionately by indigenous people, is a significant priority for our government. For example, justice for indigenous people in BC is in every Minister’s mandate letter, and justice initiatives related to indigenous people overlaps several Ministries, including the Ministry of Children and Family Services, my Ministry, and the Solicitor General’s Ministry.

In terms of public opinion, we know there are lots polling and surveys providing information on public sentiment for government officials. Do have concern about the accuracy of the feedback you get on public opinion? Do you worry about online manipulation or distortion of the public’s opinion especially online?

After the 2013 BC election, Donald Trump, Brexit and the Alberta election, anyone paying attention has more reason to look at polls with a critical eye than ever before. I’d much rather rely on direct contact with constituents and the people I represent. Polls have their place, but direct contact with people provides a much more accurate picture of where people are at because at a minimum there’s nuance there that a poll just can’t catch.

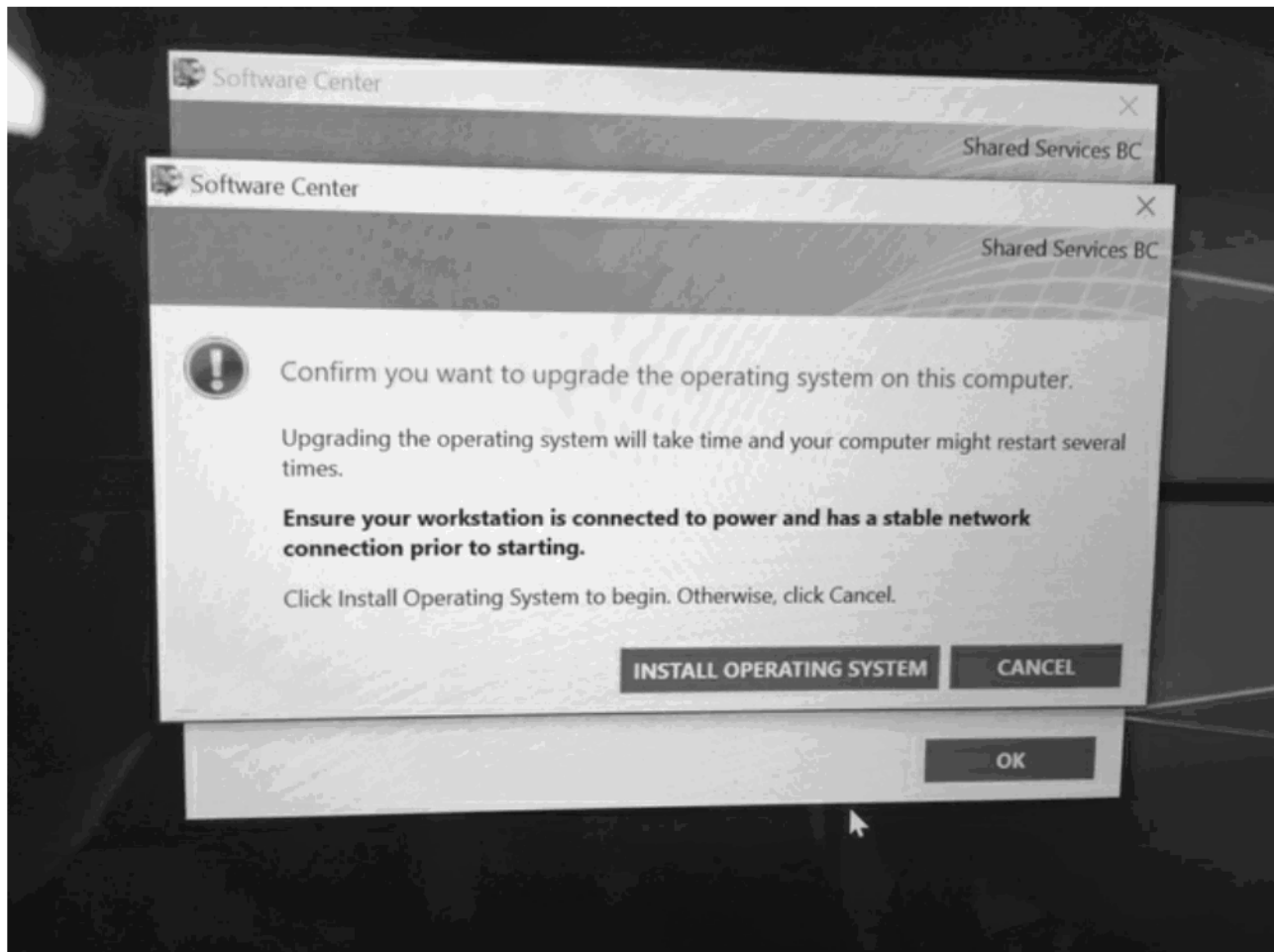
