- Off-site exemption to tied house restrictions allows for the sale and promotion of products from Deep Cove Brewers (# 305473) subject to product exclusivity and other requirements set out in policy. Licensed establishments are required to sell a range of products from a variety of manufacturers.

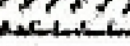
