Thank you to all of the volunteers and registered attendees for our scheduled Town Hall for tonight. I have some difficult news.

As you know, my job is to represent my constituents. I can only do that if I can hear from constituents. Hearing from community members is critically important to me, regardless of whether the feedback is positive or negative.

I have been meeting with constituents and I have heard the opposition and the concerns associated with an increase in the school tax that will impact those with homes valued over \$3M in my constituency of Vancouver Point Grey.

I have also heard from many others in our community about their appreciation for government funding the seismic upgrade at Bayview Elementary, increasing funding for chronically understaffed schools, and for helping them to reduce overwhelming childcare costs and MSP premiums.

I thought it would be beneficial to have a community discussion about the school tax, including accurate information about the policy, while giving people a chance to provide feedback directly to government. When tickets sold out, we considered a telephone town hall, but settled on a live streaming of the event.

In response, ads were run by two separate real estate agencies encouraging non-constituents and people without tickets to attend the event. The leader of the BC Liberals personally wrote a letter and distributed it, encouraging individuals to attend "whether you have a ticket or not."

We pressed on, knowing the importance of the event to many community members. But the tactics of the opponent groups ramped up.

The final straw was the rescheduling of the protest for "angry" people to "march on in" to the event an hour and a half before the event itself, making it impossible for us to secure the venue in advance.

We were no longer able to ensure only those with tickets could attend, which meant we could not ensure safety. We had, as we always do, scheduled high school students and seniors to help us staff the event as volunteers – not as security guards to hold the line against people trying to "march on in" without a ticket, or to escort guests with tickets through crowds of angry people to get them to the front door.

If that wasn't difficult enough, my constituency staff, as well as those identified as supporters of the tax, have now become a personal target of some individuals.

For the first time in my career of hosting literally hundreds of community events on difficult topics of

all kinds, I have decided to postpone the town hall until we can ensure we can hold it safely. We have a proud five-year tradition of community events in Vancouver Point Grey without incident, and I will find a way to continue this tradition.

In the meantime, I will continue to engage and meet with constituents on this and many other matters, and find a way to hear from constituents in a group while assuring that this can be done in a welcoming way for everyone.

It expresses disappointment in the new guidelines of Mar. 1 and says they are unjust and at odds with medical science and good public health practice.

The reporter is aware that Minister Eby may have met with Mr. Elliot (author of article) over the weekend.

Recommendation - Provide Statement from Minister Eby

"As Attorney General, I am not involved in the day to day operation of the BC Prosecution Service nor in the development of prosecutorial policies. The BC Prosecution Service (BCPS) manages the daily prosecution function in British Columbia on behalf of the Attorney General, and is responsible for independently developing the prosecutorial policies which guide Crown Counsel in the exercise of their discretion, including in cases about non-disclosure of HIV positive status.

"BCPS reviews its prosecution policies on an ongoing basis to ensure they accurately reflect developments in Canadian criminal law, respond appropriately to emerging issues or community needs, including scientific developments, and reasonably balance individual rights with societal interests. This ongoing review necessarily includes any relevant developments in the law or medical science relating to HIV.

"The current BCPS policy on the sexual transmission, or realistic possibility of transmission, of HIV specifically provides that:

- In assessing whether there is a realistic possibility of transmission of HIV, Crown Counsel should consider the available medical information specific to the accused and the facts of the case;
- Where there was no actual transmission, and where the risk of transmission does not meet the test in R. v. Mabior (realistic possibility), there is no fraud and no offence;
- If the evidence shows the risk was merely speculative, the infected person will not be criminally liable for failing to advise his or her sexual partner of their HIV infection;
- In completing a charge assessment, Crown Counsel should consider any medical information that the accused may provide in regard to their viral load at the time of the alleged offence; and
- Subject to specific limitations (such as the actual transmission of HIV), Crown Counsel should consider whether the public interest requires a prosecution or whether the risk to the public can be or is being effectively addressed by the accused taking proactive measures under medical supervision.

"We acknowledge that a charge of aggravated sexual assault is a blunt instrument and that is why we support further work with respect to law reform. Federal legislative reform could provide clarity and consistency across the country and provide much-needed guidance to police, prosecutors, and the judiciary.

"We look forward to continuing to work with our federal, provincial and territorial partners to consider legislative reform that addresses the unique moral culpability and medical circumstances that arise in these cases, as well as the unique risk to victims."

Money laundering obviously exists across the country. For the benefit of our readers outside of BC, can Mr. Eby explain what makes the situation in BC stand out? During his testimony in Ottawa Mr Eby stated: "Money laundering is not a victimless crime. It's also connected to the fact that we have big problems in our real estate market." Can he more precisely connect the dots? How is the laundering of money in casinos intertwined with soaring prices of real estate? Is it that drug ("dirty") money is being funnelled into casinos and then people walk out with "clean" money that is then used to purchase real estate?

Where are the biggest gaps in enforcement? Is it with RCMP lacking financial crime experts? Is it FINTRAC requiring casinos and realtors to report stuff but there¹s no follow-up enforcement? Is it casinos/realtors not doing their part in reporting suspicious activities in the first place? All of the above?

The federal government plans to directly award the contract to John Ahern (currently a senior legal counsel at his own firm, previously worked for the Criminal Justice Branch and the RCMP.

Statement has been drafted from the AG's speech to the federal finance committee, as well as some of German's verbatim recommendations for that meeting.

Recommendation – provide statement from the Attorney General

Statement from Attorney General David Eby

"The issue in British Columbia is so notorious, and so severe, that at least one international intelligence community now calls a model of money laundering the "Vancouver model."

"In the Vancouver model of money laundering, a wealthy individual from China, a

country with strict currency export controls, wants to gamble. A gangster will meet that gambler at a Casino, offering cash in amounts as high as hundreds of thousands of dollars. The cash is the proceeds of gang crime. To pay for the cash, the gambler agrees to transfer money in China from his bank account into a bank account under the control of the gang. The gambler walks the illicit cash into the casino, completes a FINTRAC reporting form, buys chips, gambles, and on leaving, either cashes out, receiving a cheque, or carries the chips out of the casino.

"In sum, the criminal gang has successfully laundered difficult-to-manage twenty dollar bills, moving the money out of Canada while keeping their names off FINTRAC forms. Those involved in the transaction can truthfully report that everyone is following all of the reporting rules.

"In terms of gaps in enforcement, there are a range of factors at play. A major issue I raised with the federal committee in Ottawa was the need to dedicate federal RCMP resources to B.C. to support us in this fight against money laundering and transnational crime. It's a bigger issue than just B.C. It's an international issue and we need that support to deal with it.

"FINTRAC does a very good job of collecting reports and entering them into a database that's available to law enforcement. However, FINTRAC, the RCMP and Revenue Canada need the resources to follow up on these reports. There is no question there has been a massive failure here.

"In Ottawa, I asked the federal finance committee to investigate why all these reports go to FINTRAC without seeing any prosecutions for money laundering. I asked the committee give FINTRAC and the RCMP the powers that they need to be able to investigate and prosecute this kind of activity.

"Other factors include:

- <!--[if !supportLists]-->• <!--[endif]-->The absence of reporting by lawyers to FINTRAC is a significant gap in Canada and is a significant impediment to police investigations involving the movement of money through real estate and other financial sectors.
- <!--[if !supportLists]-->• <!--[endif]-->Law enforcement officials do not work within FINTRAC, due to privacy concerns. Any opportunity to broaden the use of the intelligence housed within FINTRAC would be a benefit.
- <!--[if !supportLists]-->• <!--[endif]-->In 2012, the RCMP eliminated its national Proceeds of Crime and Commercial Crime Sections, in favour of a new task force orientation to investigations. Although indications are that the RCMP is now rebuilding its financial crime expertise, the gap in federal policing in this important area between 2012 and 2017, displaced responsibility for 'white collar' crime to provincial and municipal police, who

generally did not have the resources or expertise to take on these complex files.

<!--[if !supportLists]-->• <!--[endif]-->Finally, the defunding of B.C.'s integrated casino policing team in 2009 allowed suspicious transactions to climb in B.C. casinos. Large, suspicious transactions continued unabated from 2009 until late 2017, when our new government instructed B.C. casinos not to accept large cash transactions unless they could confirm the legitimate source of the funds.

"Further details about enforcement will be available when we publicly share Dr. Peter German's report on British Columbia's anti-money laundering policies and practices in Lower Mainland casinos.

"At this time we don't have any details on the B.C. RCMP's new financial criminal special adviser position, but we are encouraged to hear that efforts are being taken to increase enforcement.

"Recent media reports of money laundering through real estate in British Columbia are very serious and deeply troubling. Our government will work to determine the scope of this issue, and what must be done to appropriately address it.

"Dr. German was directed to explore what connection, if any, the issue has with other areas of B.C.'s economy. We are in the process of reviewing his report and will provide government's response in due course. However, given the severity of the issue, I have asked Dr. German to take on a second round of investigation specifically around money laundering through real estate."

Subject: Gladue Response

A Gladue report is one way for a judge to receive the information she/he needs to appropriately sentence an Indigenous offender. This same information can be provided by way of oral evidence, affidavit or in a pre-sentence report (PSR). What is important is that the judge receives information that addresses the factors identified in the *Gladue* decision: the question is whether the judge has sufficient information to adequately give attention to the particular circumstances of an Aboriginal offender. Courts in British Columbia have consistently held that a formal *Gladue* "report" is not required; again the question is whether the judge has sufficient information before him or her about the particular circumstances of the Aboriginal offender.

The courts have been clear that both Crown and defence counsel have an obligation to assist in providing this information to the sentencing judge. *Gladue* information is often contained in PSRs written by probation officers. Where an offender self identifies as an Indigenous person, the PSR will contain information to address the *Gladue* factors; these reports are provided in every case when ordered by a judge, regardless of the financial means of the offender. In cases where the judge identifies that she needs supplemental information, Crown and defence counsel work to identify how that

information can be brought to court.

Government is working with the Aboriginal Justice Council and other justice system partners to review the way *Gladue* information is brought to court to determine if changes are required. This is a government priority. To that end, we have increased funding to improve the existing system while we work with Indigenous people and organizations to determine what that system should look like.

With respect to the question of some offenders paying privately for Gladue reports, the criminal justice system already uses a means approach in terms of qualification for legal aid. In other words, government does not pay for counsel for everyone who is charged with a criminal offence; only for those who meet the eligibility criteria for legal aid.

 - First Past the Post, also known as Single Member Plurality
 - List Proportional Representation (PR)
 - Mixed Member Proportional
 - Single Transferable Vote
 - Mixed Member Majoritarian
- A number of written submissions expressed support for other proportional representation voting systems, including Rural-Urban PR, Dual Member Proportional, and Local PR, among others.
- The Attorney General is currently reviewing input collected during the engagement and preparing a report with recommendations for the referendum.
- The report will be posted on the public engagement website and presented to Cabinet for decision as soon as possible.
- After final direction is received from Cabinet later this spring, regulations containing detailed rules for the referendum will be completed.

Request

The reporter has the following questions on the proposed ICBC minor injury caps:

- 1) The legislation defines "a psychological or psychiatric condition" as minor, even if it is chronic. Does that include traumatic brain injuries and PTSD? Or is there a level at which psychological or psychiatric conditions become non-minor?
- 2) The legislation says that a claimant must seek "a diagnosis and comply with treatment in accordance with a diagnostic and treatment protocol prescribed for the injury" if they want to have the injury considered non-minor. What happens if a patient doesn't agree with the treatment prescribed? For example, if opioids are prescribed and the person does not wish to take them?

Recommendation: Provide background

- The two bills our government introduced are fundamental changes -- an independent tribunal to resolve minor injury disputes between claimants and ICBC and a limit will be placed on the maximum pain and suffering award for minor injuries.
- These changes regarding pain and suffering are not new -- every province in Canada has taken steps like this to get minor injury costs under control.
- The savings from this initiative will help get ICBC back in the black with \$1bn in savings, and will also allow ICBC to increase financial increasing support for existing accident benefits, and expand the category of covered benefits. These benefits haven't been increased for 25 years.
- Importantly, the accident benefit changes provide that for the first time ever, ICBC will
 cover the market cost of counselling for psychiatric harms arising from a collision.

The legislation defines "a psychological or psychiatric condition" as minor, even if it is chronic. Does that include traumatic brain injuries and PTSD? Or is there a level at which psychological or psychiatric conditions become non-minor?

- The proposed legislation includes the foundation for the new legal definition for what constitutes a minor injury in B.C. Brain injuries, along with anything not mentioned in the definition specifically, are not included.
- The proposed amendments list abrasions, contusions, lacerations, sprains and strains, pain syndrome, psychological and psychiatric conditions or an injury in a

prescribed class of injury, even if chronic.

- Just like lacerations and soft tissue injuries ("strains and sprains"), psychological
 and psychiatric conditions resulting from a collision can vary in impact, from
 minor to severe.
- That's why "psychological and psychiatric conditions", like "strains and sprains", and "lacerations", will be further defined and refined in regulation in detail, regulations that will be based on the best advice available from experts to ensure the law only captures what is intended, namely, less severe, minor injuries.
- As previously announced, if symptoms for any injuries, including mental health injuries from a collision, persist and have a significant effect on activities of daily living, such as work and school, beyond 12 months, then the injury would no longer be considered minor, regardless of whether or not the injury was initially diagnosed as "minor".
- At any point during recovery, a medical professional can determine if an injury diagnosis, including a mental health injury due to a collision, has changed and should no longer be considered minor.
- For the first time under these changes, ICBC will pay the market cost for counselling to treat psychiatric or psychological harm caused by an accident, for all drivers in the province.

The legislation says that a claimant must seek "a diagnosis and comply with treatment in accordance with a diagnostic and treatment protocol prescribed for the injury" if they want to have the injury considered non-minor. What happens if a patient doesn't agree with the treatment prescribed? For example, if opioids are prescribed and the person does not wish to take them?

- A claimant's medical professional not ICBC will determine the diagnosis of an injury – the same as today – and this will determine whether the injury is minor or not based on the minor injury definition.
- ICBC will look at the whole of the evidence to assess reasonableness on whether or not someone followed the treatment protocols.
- In cases where an accident victim disagrees with ICBC, they can challenge ICBC's
 decision at the independent Civil Resolution Tribunal and have the matter resolved
 in months, not years.

Reporter is looking for comment from the AG on today's news from the US Supreme Court and whether he expects there to be any pressure to allow BCLC's SportsAction to take single-game bets.

Background

Today, the U.S. Supreme Court struck down a federal law that bans gambling on sports, giving states the go-ahead to legalize betting on sports. Single-event sports betting is currently prohibited by the Criminal Code of Canada. B.C. has twice supported attempts by private member so the House of Commons to legalize single-event sports betting.

Numerous Canadian and international outlets, including CP, Toronto Star, Global, CNN, and the Guardian covered the U.S. Supreme Court decision. <u>CBC published a story</u> with the Canadian perspective on the decision. The Canadian Gaming Association issues <u>a news release on the topic</u>.

Quote from their President & CEO Paul Burns: "While this is encouraging news for U.S. operators, it further reinforces that the Canadian Parliament needs to act. Sports betting is a product enjoyed by millions of Canadians who spend billions illegally to access it. Provinces requested a simple amendment to our criminal code seven years ago, which would have provided greater regulatory oversight and control to sports wagering to protect consumers, athletes, and the integrity of sport. This request has fallen on deaf ears."

BCLC was asked for response as well and said, "It's difficult to speculate what impact the U.S. decision may have, but it may stimulate interest on the topic of single event sports betting in Canada. Parlayed sports betting, meaning players must wager on a minimum of two different events at one time, is currently the only legal form of sports betting permitted in every province in Canada, including B.C."



Hi George, this afternoon the AG asked Nicolas for a status update on the hiring of new estimators.

We can advise that we have increased the number of estimators by 75.8 FTE since the low point of December 2016 to March 2018. Since April 1 2018, we've hired an additional 39 new estimators, including 17 starting on May 22nd. These new hires are the first estimator trainee group with a full solid training program in over 20 years. We've partnered with BCIT to leverage their knowledge and expertise and more importantly accelerate our ability to provide the estimators with timely training to help them get up to speed as quickly as possible. This is our first partnership with BCIT in the automotive space.

We have done 2800 more site visits of collision repair shops than last fiscal year with a portion of the additional staffing. This is a 38.5% increase in shop visits over last fiscal year.

Appendix J – Questionnaire Methodology

Between November 23rd, 2017 and February 28th, 2018 British Columbians could access an online questionnaire to provide input on their values and preferences respecting voting and representation in the Legislature, as well as on specific topics such as ballot design/questions and the process for the referendum campaign itself. The questionnaire also offered respondents the opportunity to submit their own individual comments.

The questionnaire was divided into two parts. The questions in Part 1 asked for people's general preferences and Part 2 asked more specific and technical questions. To complete Part 2, the respondent had to first complete Part 1 of the survey. For those who did not have access to the internet, paper copies were mailed to them so that they could complete the questionnaire by hand.

In total, there were 91,725 questionnaire completions of Part 1, and 76,226 (83%) of these respondents also completed Part 2. Of the 91,725 completed questionnaire, 91,677 were submitted online and 48 were completed by hand and submitted by fax, email and mail.

One of the questions asked respondents to provide the first three digits of their postal code (FSA). Regularly during the engagement, this information was compared to BC Stats 2017 Regional District population estimates and used to target social media advertisements at districts that were under-represented in the questionnaire responses.

The online questionnaire tool implemented a number of technical and manual preventive measures to make repetitive responses from the same individual or organization unlikely, and to identify responses from outside of the province. More overtly restrictive measures such as requiring every questionnaire user to first obtain an online key or passcode were not

employed because such measures inevitably have the effect of reducing participation.

There are no technical or other safeguards that are completely effective in ensuring that every questionnaire response is from a unique individual, particularly in a time when many people own multiple electronic devices. It is in part for this reason that Ipsos Public Affairs was contracted to administer the questionnaire to a demographically-balanced group of British Columbians, so that online responses and panel responses could be compared and both could inform the results of the public engagement.

Recommendation – provide information on background Has "happy hour" ever existed in B.C. before 2017?

"Happy Hour" was introduced in June 2014. It allows
 establishments to change their liquor prices after they have
 opened for the day. The changes to the Liquor Control and
 Licensing Act that came into force Jan. 23, 2017, also included this
 authority.

There was an attempt to introduce "happy hour" in 2014. The minimum happy hour drink prices were listed above the price some bars were selling their regular drinks at. Does the law remove the minimums or is it just putting the 2014 regulations into law?

- "Happy Hour" drinks must be sold at or above the minimum drink prices as set by the Liquor Control and Licensing Branch.
- Minimum retail prices discourage alcohol abuse, overconsumption, and protect public health and safety.
- New minimum drink prices were implemented May 1, 2016, for all liquor retail outlets and by July 2016 for all liquor and food primary establishments. A liquor retailer must not, at any time, sell liquor for less than the price that the licensee paid for the liquor or the price set in the table below:

Liquor Category	Minimum Price Per Litre (not including all sales taxes)
Wine	\$6.44
Spirits	\$27.88
Liqueurs	\$20.39
Packaged Beer (bottles and tins)	\$3.19
Draught Beer (kegs 18 litres or greater)	\$1.97
Cider and Coolers	\$3.75

It is indeed accurate to state that the response you've offered neither explains nor justifies (my other complaint) how releasing details of public money spent (past tense) would or could either influence a criminal prosecution or affect an accused's privacy rights. This is especially true in the case at hand.

You've not cited any authorities or statutes which compet the withholding of this information. The explanation, as you describe it, amounts to "it is not our practice", and "we...take the position". On their face, these are arbitrary decisions unsupported by fact,

I must also point out that when I first made the simple, straightforward and noncontroversial request for public information about public money spent to a contractor about the bills he has already submitted and for which he has already been paid, this was initially not the department's position. It took some weeks before it was revealed. That suggests an evolution, provoked by my request.

Hello again Curt.

I have assumed you were primarily interested in the billings dealing with the time since Mr. Peck was appointed special Prosecutor in 2010.

As you know these matters are still before the court. It is not our practice to provide a breakdown of fees paid while the subject file is still before the court. Providing amounts of fees paid during the same period on other files would have the same effect.

The view of the BC Prosecution Service is that identifying fees paid for a specific prosecution may adversely impact the fair trial rights of any respective accused being prosecuted. We also take the position that a breakdown of the billing would constitute a harm to the personal privacy of the individuals being prosecuted as the retainer of a special prosecutor is part of the fair determination of the rights of the respective accused.

We would be able to provide an aggregate summary of the fees paid for this prosecution upon its conclusion but not while the matter is still before the court.

The conviction appeal ended in October 2017, nearly seven months ago. Mr. Millington began his sentence November 1st 2017. My understanding is that he is expected to be deemed to have served his sentence and released, as early as August.

It remains an unexplained and unjustified mystery why your department is refusing to supply a simple answer separating payments on the YVR file from anything else Richard Peck has already billed over the past many years. Clearly you have that information.

Further, it has not been demonstrated how providing this information would in any way have any impact or influence on the conduct of any matters before any court. Especially since the conviction and sentence have been carried out. Please cite the legal authority and principles which are engaged by this question. Please cite the public interest principles in keeping this public information secret.

I'd like to read an explanation, if even hypothetical, as to how knowing how much public money has been spent for Mr. Peck's services could jeopardize or influence a matter before any judge. This is simply preposterous. To use the language of one of Mr. Peck's team in the conduct of this matter, it is "absurd".



Surely that's not a secret, too? The Supreme Court of Canada issued its ruling October 30, 2017. The next day both men convicted in lower court rulings began serving their sentences. At this rate, they will be released before the public is permitted to know what it cost to administer this particular form of justice. Once again, no legitimate explanation has been given for why a simple accounting of public payments for Mr. Peck's services is being withheld. There was no obvious or apparent connection between knowing how much the prosecutions have cost, and the integrity of the prosecutions. There is even less cause to imagine any connection, now that the criminal cases are undeniably concluded. The vague, rolling promises to disclose what should have been available beginning years ago, appears to be a deliberate effort to frustrate transparency and accountability.

Subject: UPDATE & REQUESTS FROM TLABC

Minister Eby, James, Michael and Ian:

This past weekend the TLABC held its AGM and our table officers have received an updated and revised mandate from our Board Governors, particularly in light of the passing of Bills 20 and 22.

I write to advise or request as follows:

- <!--[if !supportLists]-->1. <!--[endif]-->Going forward, the TLABC asks to no longer just "observe" but participate in the Civil Justice Reform Working Group ("CJRWG"). Mike has kindly kept me cc'd on the meetings schedule but I'm unclear on when the next meeting is to be held. I trust our renewed participation is acceptable and welcome? Mike, I would also ask you to provide me with any documents or summary discussion papers that have been produced so far.
- <!--[if !supportLists]-->2. <!--[endif]-->Relative to previous matters of discussion before the CJRWG, TLABC will hopefully be allowed to make submissions to the Minister on how any proposed reforms could impact British Columbians, especially proposed reforms which may have unintended consequences. One stark example, prior to the injury caps announcement, there was discussion on limiting the number of experts in civil litigation in the context of trying to find ways to realize savings but without diminishing tort rights. In light of bills 20 and 22, most of those "modest" cases with oversized disbursements will be captured by the "minor" injury cap and the CRT, rendering any reforms on expert opinion at this juncture both premature but also even more oppressive to victims of negligence. We strongly urge the AG's office to allow the new

- regime a few years of process before the rights of injured litigants are further constricted by limiting how those with serious, 'non-minor' cases are litigated.
- <!--[if !supportLists]-->3. <!--[endif]-->Assuming we are free to participate, Mike, could you please advise when the next meeting is scheduled and the topics for discussion? I also trust it's acceptable for TLABC to provide analysis on any discussion topics that occurred during TLABC's 'observer status'.
- <!--[if !supportLists]-->4. <!--[endif]-->Minister when you and I last spoke by phone, which if I recall was February 6, 2018, you invited the TLABC to advise the government with respect to the draft regulations. Minister you also said you saw the Regulations as an opportunity to narrow the scope of the minor injury threshold and not to further expand it. Since our conversation however, the definition of minor injury was expanded as we know to include chronic pain and psychiatric injury. We are hopeful no further such expansions will be sought by ICBC and legislated through OIC by the government. There are also many other aspects of the coming injury caps regime that were left openended in the legislation to be addressed by way of regulation that the TLABC would like to be consulted on. As you can appreciate, based on fiduciary duties to our members, clients and the public, TLABC will not be able to execute any confidentiality agreements but we think it critical that government outline in detail as soon as possible the proposed regulatory, administrative and procedural frameworks so that TLABC is afforded a reasonable period of time to contemplate the proposals and provide the Attorney General of British Columbia with thoughtful, incisive expert advice about how the new caps and CRT regimes will impact the administration of – and access to- justice in BC.
- <!--[if !supportLists]-->5. <!--[endif]-->We would like to meet with the Minister and his staff at the earliest possible convenience to discuss the draft regulations.

In closing, and with the passage of Bills 20 and 22, all stakeholders have a common obligation to try and ensure that the legislative scheme coming into force in April of 2019 is more balanced, and wherever possible going forward, drafted in a way that protects and expands the rights of injured British Columbians, rather than further constricting them.

I look forward to hearing from you Minister or your office.
