As shown below, I recently learned that the BC Ministry of Education plans to take legal action against Access Copyright. That's very disappointing. Here's my insight on this.

I have been a magazine writer and author for many years. Schools use my award-winning books a lot. I value their appreciation for my work, and also value that cheque from Access Copyright that I receive each year. It's not huge, but it acknowledges that my creative work has value.

Sure, I would rather schools bought actual copies of the books. But if, for instance, a teacher wants to make a class set of photocopies of just a few pages of one of my children's books to enhance a lesson, at least I get some small payment for that use. (Under 'fair dealing', it has always been okay to make single copies for teacher use.' That's not the issue here.)

I have been an elementary teacher, so I understand the importance of having great resource material for kids. Teachers should be able to access my books for educational use. But they should do so legally – which is the whole point of Access Copyright. It helps to make the process legal, straightforward and cost-efficient.

I don't know the specifics of BC's legal challenge. I assume that as in other provinces, the BC government believes the educational sector should not have to pay to be able to use my work, or should pay much less.

I know that schools have tight budgets. Yet somehow they pay teachers, they pay for desks and whiteboards and computers and heating bills. Why should they be able to use the creative, copyrighted work of authors like me for free?

This is not some abstract legal copyright issue nobody cares about. This is a bread-and-butter issue for Canadian writers. I don't know what kind of income the average Access Copyright cheque recipient makes, but I can report that even as a successful, award-winning author, I never made as much as I did as a beginning teacher. And now an organization that supports my ability to make an income has to defend a legal challenge from my own government that doesn't think I should be able to charge for my work? Ouch.

My suggestion: Take a stand to support authors and other creators like me by continuing to negotiate fair pay for the use of our work by the educational sector. Quit taking us to court.

And I don't expect to be patronized by correspondence written by jumped up squirts from a correspondence unit. Did you read past the first paragraph of my message?? I was not talking about inside information outside of an elected official's pervue.s.22

s.22 I am fully aware that the AG does not get involved with the court and prosecution side of things, being a politician. Although I did see such involvement by an elected official and it was in BC, by the by. But that's history.

However, the AG is front and centre regarding how many judges there are, how many courtrooms there are and how many prosecutorial staff there are. That is what is meant by the 'administration of justice' and that is a provincial responsibility under the BNA Act. The situation that has occurred with

s.22 is exactly what the AG is responsible for. Not enough prosecutorial staff, not enough judges and not enough courtrooms/courtroom time.

Cases like this one involve enormous work; they take investigators and they take prosecutors months and months to put all the evidence together in a cohesive way. And to disclose that information. s.22

s.22 and his 'crew' have been responsible for an enormous share of the deaths in BC. He is not a street dealer, he heads up a large drug business. He of all accused should have been dealt with expeditiously. Obviously he was not. That fault lies either in the office of the provincial AG or with the SG, who is responsible for the lack of police numbers to do this kind of prosecution. If the province of BC, or any other province, because none put a high priority on administration of justice, has not the funds to hold people like s.22 responsible for their actions, the province should say they don't have sufficient money to do so and let the taxpayers decide what will be done about it. That is what my email was all about. And I have heard the kind of claptrap included in your reply a thousand times over. Nothing gets done if it won't get votes, and that's why there are no treatment centres for your fentanyl addicts and no money for criminals, who may also not vote. I am writing in response to your email of December 1, 2018, in which you describe your concerns about the prosecution involving s.22

It may assist you to know that as Attorney General, it is not my role to become involved in individual prosecutions. The BC Prosecution Service is responsible for the conduct and supervision of criminal

prosecutions and appeals  
in British Columbia.

As this matter is still currently before the court, I cannot provide any comment at this time. However, I can share that on December 1, 2017, the BC Supreme Court announced that an application for a stay of proceedings brought by s.22 to terminate the prosecution against him in s.22 had been granted, and the two charges on the indictment had been judicially stayed.

On December 11, 2017, the BC Prosecution Service announced that the Crown filed an appeal with the Court of Appeal for British Columbia asking that the court set aside the stay of proceedings ordered by the BC Supreme Court.  
More information is available in the BC Prosecution Service [Media Statement](#).

While I appreciate receiving your comments, as Attorney General, I have no authority over the judiciary. Under our system of law, the judicial branch of government is separate and independent from the executive branch of government.

The Ministry of Attorney General knows that we need to make improvements to court timeliness and we are continuing to make progress in this area with some of our program enhancements and technology innovations. In addition, we continue to discuss judicial appointments to the Provincial Court with the Chief Judge to address judicial vacancies. We are also planning on increasing the number of court sheriffs, expanding the use of duty counsel, and increasing staffing of the Court Services Branch.  
The Ministry of Attorney General is committed to ensuring the provision of adequate resources to manage the justice system to reduce delays and improve the timeliness of matters coming before the courts.

Public participation in the justice system is important and I appreciate being made aware of your concerns and you taking the time to share your views with respect to this matter.

Thanks for advising. Please refer to our office (CCU), and I will refer to LDB. Our office takes care of referring Minister's correspondence to the ministry. One log should suffice, I would think, but I'm not sure as Candice has created duplicate logs before – one for the meeting request portion only, and one for the draft response log. I don't understand the purpose in creating the duplicate log, though – your office always has an AG referral line in AG Draft logs which can be updated to for meeting request updates.

Other than that, here are the general steps for referring AG correspondence to us:

- Type the log action (i.e. **AG Draft Reply** [for MDE signature], **For Advice** [ministry or CCU staff to advise whether correspondence be answered by our ministry], **Reply Direct** [for ministry response], **AAA** [action as appropriate, which the branches review and determine the final action], **Filing/Information** [no response needed]) into the email subject line
- If it is a rush, note that in the subject line as well
- Then import the correspondence into the CLIFF log attachments

- Provide information on the meeting request in the CLIFF log subject line, or in the log Notes section– regarding whether the Minister will or will not be able to meet with the writer(s), and any suggested wording that the ministry should include in the draft response to address the meeting request, with meeting date & time if known

The final step is to click the CCU email button which will send the CLIFF log to our office. If the correspondence is a rush, or is further to a response that is currently in progress, the CLIFF email "high priority" flag should be selected. All MLA correspondence is treated as a rush, so the high priority flag should be routinely selected for constituency requests.

I hope this is helpful, and please let me know if you have any others questions.

Dear Minister Horgan,

Payment delays are the most significant bottleneck in B.C.'s construction industry. Cash flow problems in the construction industry discourage hiring, lower investments in capital, training of apprentices and in the worst cases, lead to small business and personal bankruptcies. As one of your constituents, I am writing to say that the problem of delayed payments is unacceptable and to express my support for the adoption of prompt payment legislation in our province.

Our province needs a prompt payment solution that works for everyone including tradespeople, contractors, government and consumers. While this serious problem is being felt now in our industry, there is a serious risk to B.C.'s competitiveness long-term if we do not take action to fix the issue. Most recently, Ontario passed Bill 142 which amended the Construction and Lien Act to require payments to sub-contractors by general contractors within seven days of receiving payment from the project owner. This measure was supported across the construction sector by general contractors, trade contractors, suppliers, and labour groups and would be a fitting blueprint for B.C. to follow.

The adoption of prompt payment legislation in British Columbia would stimulate the construction sector in our province at no cost to government, while bringing us in line with other jurisdictions. In the U.S., 49 of the 50 states have prompt payment laws. The United Kingdom, Ireland, Australia, New Zealand, and the U.S. all have federal prompt payment laws as well. These countries know that when contractors aren't paid for completed work that is not in dispute, everyone loses. This includes the provincial government, which funds substantial infrastructure projects. Taxpayers end up footing the bill for inefficiencies that could be easily addressed by passing legislation.

A prompt payment law would benefit the skilled trades by releasing cash flow in the industry: more cash would allow contractors to take a longer investment outlook and, hire more tradespeople and apprentices.

I am lending my voice to the thousands of trade contractors across British Columbia who support this initiative and calling on you to ensure the government passes prompt payment legislation before the end of its mandate. Small businesses and the people who work for them are counting on you.

Cases like this one involve enormous work; they take investigators and they take prosecutors months and months to put all the evidence together in a cohesive way. And to disclose that information.<sup>s.22</sup>

s.22 and his 'crew' have been responsible for an enormous share of the deaths in BC. He is not a street dealer, he heads up a large drug business. He of all accused should have been dealt with expeditiously. Obviously he was not. That fault lies either in the office of the provincial AG or with the SG, who is responsible for the lack of police numbers to do this kind of prosecution. If the province of BC, or any other province, because none put a high priority on administration of justice, has not the funds to hold people like <sup>s.22</sup> responsible for their actions, the province should say they don't have sufficient money to do so and let the taxpayers decide what will be done about it. That is what my email was all about. And I have heard the kind of claptrap included in your reply a thousand times over. Nothing gets done if it won't get votes, and that's why there are no treatment centres for your fentanyl addicts and no money for criminals, who may also not vote. I am writing in response to your email of December 1, 2018, in which you describe your concerns about the prosecution involving<sup>s.22</sup>

It may assist you to know that as Attorney General, it is not my role to become involved in individual prosecutions. The BC Prosecution Service is responsible for the conduct and supervision of criminal prosecutions and appeals in British Columbia.

As this matter is still currently before the court, I cannot provide any comment at this time. However, I can share that on December 1, 2017, the BC Supreme Court announced that an application for a stay of proceedings brought by s.22 to terminate the prosecution against him in s.22 had been granted, and the two charges on the indictment had been judicially stayed.

On December 11, 2017, the BC Prosecution Service announced that the Crown filed an appeal with the Court of Appeal for British Columbia asking that the court set aside the stay of proceedings ordered by the BC Supreme Court. More information is available in the BC Prosecution Service Media Statement .

While I appreciate receiving your comments, as Attorney General, I have no authority over the judiciary. Under our system of law, the judicial branch of government is separate and independent from the executive branch of government.

The Ministry of Attorney General knows that we need to make improvements to court timeliness and we are continuing to make progress in this area with some of our program enhancements and technology innovations. In addition, we continue to discuss judicial appointments to the Provincial Court with the Chief Judge to address judicial vacancies. We are also planning on increasing the number of court sheriffs, expanding the use of duty counsel, and increasing staffing of the Court Services Branch. The Ministry of Attorney General is committed to ensuring the provision of adequate resources to manage the justice system to reduce delays and improve the timeliness of matters coming before the courts.

Public participation in the justice system is important and I appreciate being made aware of your concerns and you taking the time to share your views with respect to this matter.

I am writing in response to your email of December 1, 2018, in which you describe your concerns about the prosecution involving s.22

It may assist you to know that as Attorney General, it is not my role to become involved in individual prosecutions. The BC Prosecution Service is responsible for the conduct and supervision of criminal prosecutions and appeals in British Columbia.

As this matter is still currently before the court, I cannot provide any comment at this time. However, I can share that on December 1, 2017, the BC Supreme Court announced that an application for a stay of proceedings brought by s.22 to terminate the prosecution against him in s.22 had been granted, and the two charges on the indictment had been judicially stayed.

On December 11, 2017, the BC Prosecution Service announced that the Crown filed an appeal with the Court of Appeal for British Columbia asking that the court set aside the stay of proceedings ordered by the BC Supreme Court.

While I appreciate receiving your comments, as Attorney General, I have no authority over the judiciary. Under our system of law, the judicial branch of government is separate and independent from the executive branch of government.

The Ministry of Attorney General knows that we need to make improvements to court timeliness and we are continuing to make progress in this area with some of our program enhancements and technology innovations. In addition, we continue to discuss judicial appointments to the Provincial Court with the Chief Judge to address judicial

vacancies. We are also planning on increasing the number of court sheriffs, expanding the use of duty counsel, and increasing staffing of the Court Services Branch.

The Ministry of Attorney General is committed to ensuring the provision of adequate resources to manage the justice system to reduce delays and improve the timeliness of matters coming before the courts.

Public participation in the justice system is important and I appreciate being made aware of your concerns and you taking the time to share your views with respect to this matter.

You do not seem to understand!

Although I paid for the renewal of my drivers licence in May 2006, I was refused my licence because I only could provide a Canadian Government passport and my birth certificate, which they claimed was too old!

Identification requirements are not meant to inconvenience customers. They are intended to reduce fraud and protect the identity of British Columbians.

ICBC issues official identification documents on behalf of the provincial government, such as the British Columbia driver's licence (BCDL), BC identification card (BCID), and BC Services Card (BCSC). Government identification documents are considered the most credible forms of identification due to the security screening processes used to verify an individual's identity.

National standards and best practices for identity proofing are to use the foundation documents issued either by Vital Statistics (e.g. a Canadian birth certificate), or citizenship documents issued by Immigration, Refugees and Citizenship Canada (IRCC), when establishing and verifying an individual's identity for government-issued identification cards. As there is no requirement that a passport be issued in the person's foundational name, it is considered a travel document and not a foundational document.

Thank you for your correspondence of December 7, 2017 and February 26, 2018, regarding civil litigation in which you have been involved in the United States and Canada.

As Ms. Barbara Carmichael, Legal Counsel, explained in her August 14, 2017 email, I do not -- in my role as Attorney General -- normally intervene in private legal disputes.

In your correspondence, you make numerous allegations of criminal wrongdoing against a number of individuals and entities. You also indicate that you have contacted the RCMP who told you that they would not intervene and that you should file a civil claim. You also mention that the Oak Bay Police Department has been contacted. As Attorney General, I do not authorize criminal investigations or otherwise direct the police on any specific matter. Whenever an individual has reason to believe that someone has been involved in criminal activity, the proper course of action is for that individual to report his or her allegations to the police in the community where the alleged criminal activity occurred, as you have done. If the police determine that an investigation is warranted, they will conduct one. They are also in the best position to determine whether a particular allegation involves a criminal matter.

If the police think it is advisable, they may forward a report to Crown Counsel in the Ministry of Attorney General's BC Prosecution Service recommending that a charge be laid. Crown Counsel will review the report and determine whether the evidence supports a substantial likelihood of conviction and, if so, whether a prosecution is required in the public interest.

As Attorney General, I do not have a general mandate to intervene in this established process. Each component of the justice system is independent of the other, in order to meet the legal requirements of a fair and independent prosecution process.

If you wish to pursue a complaint in relation to the RCMP's response to your allegations, the appropriate process is to first contact the police detachment directly and provide specific details in relation to the circumstances surrounding the matter. You may wish to contact the Officer-in-Charge of the particular RCMP detachment. In the event that you are not satisfied with the way your concerns have been addressed at the detachment level, you have the option of filing a formal complaint with the Civilian Review and Complaints Commission for the RCMP (the Commission). The Commission is a civilian body, independent of the RCMP, and has jurisdiction to investigate complaints against RCMP members. That office can be reached at the following address:

I also note your concerns regarding certain lawyers who have been involved in these legal matters. You indicate that you have contacted the Law Society of British Columbia regarding s.22 a lawyer practicing in British Columbia. As Attorney General, I do not have jurisdiction to investigate complaints against lawyers. Under the *Legal Profession Act*, that responsibility falls to the Law Society. The Attorney General is an appointed Benchler of the Law Society by right of office. The Attorney General in his or her elected capacity as a Member of the Legislative Assembly of British Columbia and as a member of Cabinet in the British Columbia Government is not, as a result of that role, in charge of the administration and day-to-day operations of the Law Society. The Law Society operates independently of government, and I do not have the authority to intervene in the complaint review process established by the Law Society.

Individuals who believe that they have been treated unfairly by the Law Society may consider contacting the Office of the Ombudsperson of British Columbia. As an independent Officer of the Legislature, the Ombudsperson has the authority to investigate complaints about the actions and decisions of public agencies, including the Law Society. Before considering an investigation, however, I understand that office generally requires that other avenues of complaint and appeal have first been exhausted. Every time I visit there and return home to the island, I'm blown away by the difference in driver behaviour. In s.22 photo radar is actively used - and not in marked vans like we used to have in BC. There is also active speed monitoring by live patrols. As a result, this Islander when driving 5K over the speed limit in s.22 feels reckless.

Fast forward to landing at YYJ and collecting my car. Inevitably I'm tailgated all the way from the airport to the Pat Bay where I enter the speedway, and am usually one of the slowest drivers (even if, perhaps, I'm driving a few K over the posted limit!).

The difference in driving behaviours to me is obvious - enforcement. One knows in s.22 if they speed, they will be caught. Here, there are few consequences for reckless driving and many drivers drive accordingly. One consequence of this are the ongoing losses at ICBC.

I would ask that the legislature look at bringing back photo radar, make our roads safer and help keep a cap on ICBC rate increases.

Attached please find the Certificate of Authority to Obtain Personal Information duly completed by s.22 . Please note the address provided therein is in Doug Routley's Constituency but s.22 said he lost his home as a consequence of a car accident and his dealings with ICBC has rendered him homeless. I will also attach his original email below as his account of events is recalled in his own words:

He states that ICBC has a new policy of \$740 per week and if he was receiving it instead of \$1,200 per month he could afford to get a place and continue primary custody of his s.22 but instead he is couch surfing for quite some time.

He provided ICBC with a quote for private surgery for \$10,000 (not sure what the injury is) which could take place within 3 weeks of receipt of same. In turn he could recover and be back at work in his s.22 job. A second medical opinion initiated by himself revealed that he needed surgery but ICBC he said wanted to write him off as disabled.

Can you please look into this matter with ICBC and advise this office if anything can be done to assist s.22 to the goal of surgery as requested enabling him to return to work as expeditiously as possible and receiving the suggested compensation in the meantime as outlined in his Consent and email.

My name is <sup>s.22</sup> and in June 2016 my life was ruined the first time by a junky who fell asleep behind the wheel and hit me head on. I've been unable to work and in need of surgery since. Icgc will not pay for a private clinic surgery that would happen three weeks from payment, when I was put on a year waiting list in October 2017 and icgc was given the private clinic quote. The surgery is 10,000\$ but my lost wage net income for the year I have to wait is <sup>s.22</sup> plus interest and pain and suffering. All I want is to be treated medically so I may return to work as soon as possible. Also I know the new icgc policies are meant to be more humane as currently I get 1200\$ a month to live on and have lost my house, most of my visitation of my kid and my financial security, I currently couch surf to survive. If icgc was made to pay me the new policy of 740\$ a week I could afford to get a place and have primary custody of my <sup>s.22</sup> who wants to live full time with me now. At this rate icgc is just making things worse by not letting me be a father while I recover from my injuries and procrastinating my recovery.

I have filed complaints to every level of icgc and the ombudsperson all of them did nothing as I lost my place to live after going <sup>s.22</sup> in debt trying to keep it and with it my 50% custody. I didn't know I needed surgery before I wasted my credit on rent and groceries or I would have couch surfed earlier to pay for my own surgery. I have done everything in my power to get better as fast as I can by advocating for myself and getting the second opinion that shows the needed surgery when cbi tried to write me off as disabled. I'm drowning in debt and running out of couches to surf soon I'll be on the street because someone hit me. I'm a <sup>s.22</sup> income earning tax paying citizen that's about to be homeless because of icgc, and the dumbest thing is after they're done denying me all this year they'll be paying me the 740\$ a week in 2019 as I will most likely still be off work in physio. Later on I'll get the <sup>s.22</sup> difference per year between my net income and the 14,400\$ a year icgc made me live off since 2016.

I want humane treatment a livable wage loss weekly payment and my surgery paid for so I can be a father, lower my suffering and getting better faster. Icgc has nothing to gain by destroying my life as I'm not going away so why would they treat a human being like this.

On Monday 19th Feb 2018 if my surgery isn't paid for and the new weekly amount of 740\$ isn't in my bank account I'll be sending this letter to every news station in Canada to show them what a corrupt inhumane corporation icgc is, a direct contrast to icgc's current attempt at public relations.

Honorable Minister Eby,

I'm writing to you as a <sup>s.22</sup>

<sup>s.22</sup> A few days ago (March 1), all practicing court interpreters were told to get on the phone with the staff from the court services department of the Ministry of Attorney General regarding some new updates.

I was shocked to learn of the changes proposed to the court interpreter system on that call. It's supposed to become effective on July 1 of this year, yet other than the mention of a 'consultant', no lawyers, judges, clerks and most importantly no practicing court interpreters were party to this decision.

There have been two schools of court interpreters over the past 20 years or so, namely court interpreters from Society of Translators and Interpreters of BC (STIBC) and Vancouver Community College (VCC) Court Interpreting program graduates. The VCC Court interpreting program was created in 1981 when there was an increasing demand for competent court interpreters, but before 1992 the purpose of the program was just to provide training and not accreditation. Beginning in 1992, VCC Court Interpreting Certificate program started to provide accreditation to those students. The program was about 10 months in length and students had to go through vigorous training over that time, including written translation, Canadian law system, law, consecutive interpretation and simultaneous interpretation. At the end of the process, we also had to take and pass an exam which was very similar to the one offered right now at S.T.I.B.C., if not the same. I'm not even talking about the strict enrollment process when only 1-3 students were selected out of often 50-80 something candidates through a multiple session entrance exam.

STIBC started its court interpreter classification in the 1990s. Some VCC graduates subsequently became STIBC members, but others didn't for various reasons.

One important note here is that, in 1992, the ministry of Attorney General acknowledged that both VCC court interpreting program graduates and STIBC court interpreters were recognized and accepted by the court as official court interpreters in B.C.

That's some background information. And I understand that STIBC have been working very hard over the years to get their members exclusive status in the B.C. court system. There's nothing wrong with that as they do what's best for their members; however, the court system continues to benefit from the skills and contributions from translators/interpreters from outside the STIBC umbrella. The new decision that favours STIBC will benefit their members, but is it what's best for the BC court system?

I would say, that's a big No.

1. Many VCC court interpreters have been practicing in the court system for over 10, 20 or even 30 years. <sup>s.22</sup>

<sup>s.22</sup>

is not a member of STIBC; <sup>s.22</sup>

<sup>s.22</sup>

is also not a member

of STIBC. Many STIBC members were students of <sup>s.22</sup> and <sup>s.22</sup>. So how do these

two sought-after and knowledgeable court interpreters suddenly get down-graded to 2<sup>nd</sup> class interpreters behind some of their own students, and even from those who are just passing their tests? Fair? Absolutely not.

2. <sup>s.22</sup> \_\_\_\_\_ and have been working in this field ever since. Personal feelings aside, I believe this decision will negatively affect the legal system in a profound and complicated way. Let me give you an example, I've been working with the <sup>s.22</sup> \_\_\_\_\_ police for the past few years providing interpretation and translation work in relation to some on-going investigations, some of these investigations have lasted 3-5 years and are still ongoing, possibly not completed before the July 1, 2018 STIBC deadline. But after that day, my work will be considered as that of a 2<sup>nd</sup> class interpreter. I have worked and been proud to assist in a number of completed cases in recent years, resulting in decisions that have seen justice served. Now, it would be a fantastic excuse for the defence lawyer to challenge the work simply on the interpreter's newly down-graded status. Not only would this incur new costs – if the police departments are able to pay another interpreter to process it, as well as fiscal cost of delaying such court cases – but in the end we could see investigations shelved and justice not served. And what about appeals based on that ground? In fact, any lawyer may use this as a reason to start an appeal to the higher court regarding previous cases I or any VCC graduate did. Our work is constantly being graded, questioned and thoroughly tested during a case, by both lawyers and judges. If my work does not meet a certain standard and competency then the system bears the cost. For those of us who have worked over the past decade or more, to suddenly see this experience brushed aside, with no consideration of the people of the court, is heavy-handed. The provincial courts are already backlogged and getting cases heard and processed, when proficiency and accuracy is provided, will be burdened by fewer interpreters for consideration. In fact, the service of justice is at risk with this decision with no consultation and prematurely quick transition to different levels of interpreters.

If it's just internal decision, then why? Why can't we make it public and provide the reasons of such change? This is the legal system we are talking about, any change, no matter how small it may seem to some people, it may have a huge impact on other aspects of the system.

3. Who sets those different levels? If this new proposal is to encourage non-STIBC interpreters to take the exam and become members, this is a wrong way to do so. Over the years, I did not take STIBC court interpreter exam because first of all, there was no need when our status was recognized. I, like many other VCC graduates, am not afraid of exams, but I need to know I can trust the process to be fair and transparent, and that the person assessing my exam is not in conflict of interest. Right now, the STIBC exams are administered by STIBC members on a voluntary basis; most of these people are practicing court interpreters in the system. Every year the evaluators are different.

Because the evaluations are done by volunteers, the standard the exams are graded on have been inconsistent. I know there is a criteria written down for STIBC members who assess the exams, but still the standard varies from person to person. Some have less experience than me and some have more, but they also have perceivable benefit in not letting me pass the exam because once licensed those new members are competing against jobs in an industry where the work is by-and-large part-time, with inconsistent income.

4. If there is a need to better manage and regulate court interpreters, it should be a fair process to evaluate each and every practicing court interpreters given the current composition of court interpreters. I do believe there needs to be a system so that court interpreters are regulated, but this system needs to include a complete evaluation to ensure members who have been providing a valuable service, within the justice system, are not shuffled aside because STIBC has its own agenda. Such a decision needs input from those who rely upon a strong, accurate interpreting/translation service, and hear from judges, lawyers, police and interpreters, and take into account the history and reality of the court interpreter system in this province to accurately assess the work each court interpreter does.
5. As you may know, in this line of work, experience, accuracy and skills are paramount. With this new proposal, VCC graduates with 30 or 20 or 10 years of experience will be down-graded to 2<sup>nd</sup> class while STIBC members who just passed the exam last year will immediately receive a higher rank despite the lack of experience. This is like saying, experience means nothing, a good track record means nothing and the feedback from lawyers, judges and clients means nothing.
6. The STIBC court interpreter exam takes 2 years to complete, and unfortunately we just passed the deadline of this year's registration, which means I'll have to wait for at least 3 years before I can become a STIBC member, while surrendering my privilege as an experienced member of the court system. Three years is a significant amount of time in a court interpreter's career. I have to become down-graded not due to any mistakes I made, but rather some political decision made for the benefit of STIBC members.
7. Further, I've witnessed STIBC members who do absolutely wonderful work but I've also known STIBC members who are completely incompetent. If there is going to be an evaluation process, let's all get evaluated by a competent panel of judges, by a system that has been vetted and approved by an agreed-to process involving the various stakeholders.
8. I have friends and colleagues who are STIBC certified members. They can attest to my professionalism and thoroughness as an interpreter/translator. I believe my work stands on its own and I have established a strong reputation and working relationships all throughout the court and judicial system. I can provide a lengthy list of referrals who would attest to my work and service in support of the judicial process. However, my disagreement with this unfair and sudden change to the system is not about me. It is

about ensuring our role in the justice system is strengthened and continues to help the police, judges and lawyers create a safer, just society. Let's set a merit based system. I'm ready to take on any exam, but I think it needs to be on an expedited basis for the VCC graduates and it needs to be fair and transparent.

This letter is in reference to to recent decision by the NDP government to consult the courts over our constitutional rights to protect the people and environment of BC. The consequences of oil spills are usually evaluated in terms of environmental damage, effects on marine species, and economic losses in the fisheries and tourism industries. Chemicals and vapors, both from oil and dispersants, can pose serious health risks. They can inflame the nose, throat and lungs, and aggravate asthma. When absorbed in the bloodstream, oil compounds like benzene or toluene can cause headaches and dizziness and could have long term toxic effects on the brain, liver and kidneys after prolonged, direct contact.

NS NOPE ( a north and west Vancouver residents group) have compiled this comprehensive publication on research, risks and resources of Bitumen spills and the serious health impacts it will have.

#### What are the Health Effects of Pipelines and Oil Spills? Summary

Exposure to an oil spill can cause both short and long term effects on human health. The oil contains chemicals such as volatile organic compounds (VOCs), polycyclic aromatic hydrocarbons (PAHs) as well as heavy metals which have a broad range of potential effects on human health. Exposure pathways can be from inhalation of toxic fumes, direct contact with skin or by ingestion.

Acute toxic symptoms immediately following an oil spill can include:

Respiratory symptoms such as cough, throat irritation, shortness of breath

Ocular (eye) symptoms such as redness, watering, itching and soreness

Dermal (skin) and mucous membrane symptoms such as redness, irritation, rash or blisters

Gastrointestinal symptoms such as nausea, vomiting and diarrhea

Neurological symptoms such as headache, dizziness, irritability, confusion, and weakness.

Long Term effects from an oil spill have had fewer studies completed, but the research is focused on:

Immunological and endocrine effects such as changes in hormones and immune system markers

Genotoxic effects such as changes in DNA, and effects on children of exposed parents

Carcinogenic effects such as leukemia other cancers

Hematologic effects such as changes in blood profiles and liver enzymes

Respiratory effects such as COPD (chronic obstructive lung disease)

Mental health effects such as anxiety, depression and post traumatic stress disorder.

The health effects from pipelines and oil spills in other jurisdictions have been significant, and we know that no matter how well prepared we are for a spill, have happened and will continue to happen. The proposed Kinder Morgan/Trans-Mountain (KM/TM) pipeline expansion from Alberta to the Westridge Terminal in Burnaby, BC will triple the amount of diluted bitumen being transported in the pipeline and increase the number of tankers transporting it to Asia from about 60 per year to 1-2 per day. The chance of a serious spill will increase significantly. Are we willing to take that risk in such a densely populated area with limited evacuation routes?

What is known: The KM/TM pipeline transports Dilbit which is a mixture of bitumen (tar) with condensate or diluents (solvents), mixed together so that it will flow through the pipeline. When dispersants are used to clean up an oil spill, there is an even greater mixture of chemicals. The main constituents of crude oil, bitumen, diluents, and dispersants are toxic and have had significant human health effects.

Some people are more vulnerable to toxic exposures, and first responder emergency personnel will also experience greater risks. It's important to consider our mental health as well physical health, and studies show that the mental health effects can be severe.

What is not yet known: Since there are still relatively few studies on human health effects, we can't say with certainty what the long-term effects will be. Air quality monitoring at the time of the spill is often lacking, screening of local people is not centrally coordinated, baseline evaluations are not done and the follow up health assessments are often absent. Many of the oil spills worldwide have not been studied for the impact on human health so the data is limited. There is a need for long term studies to monitor exposed individuals.

Unfortunately, research carried out after oil spill disasters have happened concern people who have already undergone a burden of disease and suffering. The people of Vancouver should not have to take that risk.

Please ensure that the health and potential loss of life risk (in vulnerable populations) are given the due care and attention when Bitumen is studied for marine environments and air born exposure as well.
