In a conversation with the Attorney General of Canada, I was directed to you. I apologize for the length of this message, however the details here are important.

Please see attached correspondence with the Prime Minister's Office last fall in regards to an established hate group named Culture Guard circulating in British Columbia hosting rallies and information sessions to incite hatred against the LGBT community and particularly transgender children. Please note CBC Dateline is currently actively working on an expose investigation on Culture Guard and Kari Simpson.

I am certain you are deeply aware of the mass amounts of misinformation surrounding the Ministry of Education's SOGI 123 resource which is circulating in our province and particularly in the Fraser Valley. Kari Simpson via Culture Guard (described in attached email) has been setting up 'SOGI Information Sessions', going town to town, preaching hateful rhetoric, promoting conversion therapy, and sharing 'information' on the SOGI resource which is a gross misrepresentation of the facts surrounding the resource, the Ministry of Education and the LGBT and specifically transgender community. She has declared 'war' on the LGBT

community and any who support them, including educators, the head of the BC Teachers' Federation and the like. She spews hate so vile I cannot sit through recordings of her rally speeches. Those non-LGBT members in attendance have described the experience as terrifying, watching a local trans woman mocked, heckled and misgendered, and some giving the Nazi salute. Recently Kari Simpson has linked with the Sons of Odin, who have been appearing at anti-SOGI rallies. At a rally last week in Langley, SOI members were seen hiding accross the street gathering counter-intelligence, filming our pro-SOGI rally attendees. Ms. Simpson has also reported to media outlets that she has invited the Hell's Angels to attend her rallies. Parents who stand up to Kari Simpson are threatened, publicly targeted and attempts to intimidate them into silence are employed. Parents who have gone to police have not received support and have been told the Crown will not support charges.

s.22 are members of this hate group and have joined in her cause, speaking out publicly against support for transgender children and denouncing supportive parents as child abusers. The hate speech has been nothing short of appalling and in direct violation of the BC Human Rights Act, and yet they retain their positions as s.22

s.22 Police advised the Crown would not support charges. At a public high school graduation ceremony last week s.22

s.22 The local activity of Culture Guard, s.22 has directly led to a number of targeted hate events in our city and at our local schools.

Most recently, two new parties who are allies of Kari Simpson have emerged and formed an organization titled the Canadian Christian Lobby. It is comprised of s.22

s.22 This group equally is booking event after event on SOGI 123.

Both groups continue to be banned for periods of time by social media platforms for hate speech, yet no charges or consequences otherwise have come their way, so they can continue on, and they are growing. We in BC seem to be seriously behind the rest of the country in prosecuting hate speech and we must do better. Most recently Bill Whatcott was arrested and charged for a hate crime in Toronto, ON. He was not charged for the exact same activity that he engaged in while in British Columbia, despite the victim's requests to police and a civil suit.

Sir, I ask that you please consider making the investigation and prosecution for hate speech of these two groups and their associates a priority. I also ask that Crowns be asked to consider charges for these groups a priority. The damage they are doing to the LGBT community is profound. LGBT children are frightened, targeted and at higher risk. Many have expressed an extreme sense of hopelessness that anti-LGBT sentiment promoted by these groups is gaining traction, reversing all the extensive work that went into building Human Rights protections around these groups for so many years. The actions of these groups have 'normalized hate' in our area, and made it a safe haven for bigotry to come out of the closet in full force. s.22

On this Transgender Day of Remembrance, I write to request your office's personal assistance in stopping a growing hate-group in the Fraser Valley of British Columbia which is targeting transgender children and their families. This group is travelling from city to city, holding rallies to fuel and grow their cause and following, and enlisting public officials in their hateful speech against this marginalized group.

The group, Culture Guard, led by a Ms. Kari Simpson, has online campaign funding, an official online site, and is being hosted by municipal venues. The group's activities and message are in direct contravention of Bill C-16, which you and we fought so hard to see passed, and in contravention of the Canadian Charter of Human Rights and Freedoms and the Criminal Code of Canada. The group targets inclusive education, parents of transgender children with personal online attacks, and spreads misinformation on transgender persons with the intent to cause fear and uprising.

Most recently, they have enlisted and bolstered a^{s.22} who posted a horrific transphobic message on social media in protest of SOGI 123 curriculum, a school curriculum set to be rolled-in which introduces inclusive language in the classroom. His post indicated he held traditional views, that those who support transgender children are committing child abuse, that this new curriculum was a weapon of propaganda, and that we in Canada should be emulating Russia in regards to LGBT persons. He further quoted a US anti-LGBT hate-group. This rant was widely publicized in the media and^{s.22} gathered a substantial following in his anti-trans message. The local LGBT community as well as families of trans children have been fighting the aftermath of this for weeks, and the movement against SOGI has barrelled forward and increased in strength.

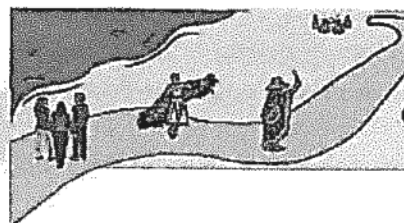

Hello Minister Eby,

As you may be aware, Chrysalis has provided specialized addictions and mental health care for women in the DTES (and marginalized women throughout BC) for 30 years, and is now BC's leading provider of trauma-specialized, trans-inclusive and residential care and advocacy for women healing from addiction, violence, poverty, homelessness and exploitation.

While we are funded primarily as a Tier 4 service through Vancouver Coastal Health, MSD and BC Gaming, in practice our specialty in working with trauma and medical/mental health complexity means we consistently serve Tier 5, "SAMI population" clients. In support of the mutual clients we collectively share, Chrysalis works collaboratively and regularly with Heartwood, St. Paul's, VGH, UBC Hospital, and all the other primary hospitals in communities throughout BC.

In support of women's safety and best long-term outcomes, our houses, Head Office and programs all remain strategically located outside of the DTES catchment; subsequently, we are ineligible for the vast majority of available government and Health Authority funding for women-serving organizations in Vancouver. As our programs are Health-Authority-funded and addiction-focussed, Chrysalis is continually deemed ineligible for violence prevention or housing funding. Our current operational budget is \$750K/year, and the limited funding grants we can access in any given year are capital or project-based, rather than operational.

Relative to the scope of the complex addiction and mental health inpatient care we provide to underserved and marginalized populations of women throughout BC (as detailed in the attached 2016-17 Annual Report), it is now widely acknowledged that Chrysalis is operationally underfunded and chronically under-resourced.


To ensure long-term sustainability and prevent the risk of closure and/or reduction of the critical services and housing we provide, Chrysalis is actively seeking new partnerships and increased operational investment and funding by government into our standalone, trauma-specialized continuum of care for women. I would welcome any opportunity to meet you at your convenience to introduce you to our homes and programs, and discuss further any possible means by which we may be able to work with you, in your role as

Opposition Spokesperson for Housing & BC Housing, to ensure Chrysalis' uniquely standalone continuum of care for women is adequately funded and otherwise freed from perpetual risk of closure or reduction.

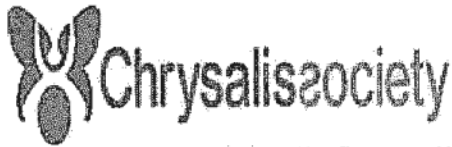
