Bad drivers should pay for the risk they create, especially However, note that they are skilled at spotting police. Only police on the street, not very visible, to spot them then get into their face – repeatedly, will identify them.

And there's a problem with sole-source-by-force insurance – drivers can reach a maximum rate and keep driving, whereas in a truly private market they would not be able to get insurance. (Granted, there's a high incidence rate of people here driving without insurance because their licence has been yanked. Quiet policing would catch some as they probably drive badly, though some may drive cautiously to avoid notice. (In ON media watched people whose license had been yanked, identify many and interviewing some.)

However I question whether a change in the period of ??? from 13 to 20 years will make much difference in rates. What's needed is to curb people like the manager with 18 serious offences on her record who killed a person on a motorcycle by short-cutting a turn for which she did not have good visibility.

Distracted driving has become the latest panacea fad – it's nonsense to compare it with drunken driving. (Also impractical to define as arguments with spouse, misbehaving children, and girlwatching are difficult to measure. Putting on makeup is easier to spot.)

Counting at-fault crashes against the vehicle owner not the driver is a stupid approach – strange. (Also note 'listing' of a driver seems awkward. I presume one case is drivers below a certain age, as the person getting insurance is supposed to say if young people will be driving the vehicle. Beware that it is the insured that matters, not the vehicle owner – for example, an elderly person may stop driving but one of their family drive the vehicle to transport the owner on errands.)

Note that some jurisdictions give a discount for married status, I don't know how valid that is, perhaps the presumption was they'd have children so be careful – Saanich police can attest to that not being true for some people (speeders in school zones, including one intoxicated mother).

I find it annoying that there's no discount for multiple vehicles – if I could afford it I'd have a city car and a travelling van. How to measure usage is a question, technically it is feasible today.

(BTW, 'punish' is the wrong word. The question is making bad drivers pay for the risk they cause.

Police and courts may punish, though the emphasis should be on re-education (by incarceration if needed to protect others, such as those who keep driving without a license and those who continue to drive drunk – such as the person who almost killed a passenger only several weeks after killing a driver by running a red light). Jails and prisons need to have better re-education processes, there are very good ones such as William Head and a prison up-island.

PS: "Fair" is a bad word in insurance here, since a fool premier changed rates in an awkward way and called it 'fair'. (Perhaps I should say 'idiot' but hey! he was a politician – you know the type that panders to potential voters.

PPS: I'm skeptical of automatic braking. You have to watch panaceas – for example hands-free cellular phone use has been shown to be riskier than hands-on-the-phone, because it removes a reminder of activity that helps to reduce risk of focusing completely on the call not on driving. (I once saw a driver with no hands on the wheel – one holding a cellular phone, the other gesturing to the caller – with a curve coming up, somehow he navigated it.



We have a group of people who are all VCC accredited court interpreters and they also would like to express their concerns. Thanks. Regards,

Dear Honorable Minister Eby,

The current situation of court interpreters:

Mostly 2 types of court interpreters:

- 1. S.T.I.B.C certified court interpreters (about 60 members of all language combinations), from 1990s up to now.
- 2. Accredited court interpreters graduated from Vancouver Community College Court Interpreting Program from 1990s to 2012. (about 200 people of all language combinations)
- 3. These 2 types of interpreters are working in the court system with pretty much the same recognition in BC.

The key issues of the newly proposed changes:

- 1. V.C.C court interpreting program graduates are going to be down graded to level 2 and S.T.I.BC. certified interpreters are going to be level 1 on the top.

 This proposed grading system is not based on any evaluation. This is not objective and may cause lots of issues:
 - If a STIBC certified court interpreter makes a mistake, the practice now is that any VCC court interpreter may challenge it and correct it. After the change that may become difficult. VCC graduates will have difficulty pointing out mistakes made by STIBC simply because they are classified as 2nd class interpreters.
- 2. This policy is said to be internal, but this is simply not realistic. A defense lawyer may choose to wait for a level 1 interpreter rather than getting a 2nd level interpreter. In many cases that would mean a long wait as there are currently only 60 some STIBC court interpreters of all language combinations, which may cause a case being thrown out because unduly delay. If this tool is available, some defense lawyer is going to use it whether you like it or not. And it's not based on any facts or merit, but rather a tactic.
- 3. For 200+ VCC court interpreters who have enjoyed equal treatment as STIBC certified court interpreters in the past, their work, including what they've done in the past, for the police, for the crown, or civil cases may be challenged or even thrown out based on the fact they are down-graded.
- 4. The VCC court interpreters have not been given sufficient time of notice, so that they may make arrangements to take the STIBC exam and pass it. It takes two years to complete an exam, not because the exam is complicated, but rather because the organization of VCC is not machined to organize more efficient exams.
- 5. There are extremely qualified court interpreters who have never taken the STIBC exam, they have 10, 20 or even 30 years of experience and a good track record under belt, but now those newly passed STIBC members who barely have any experience and who are not ready to take on more complicated cases may be considered as first choice based on the certification instead of merit.
- 6. Judges and lawyers are already confused by the court interpreter system, if any change is made, they should be consulted and informed. It shouldn't be up to the interpreters to explain the changes every time when they are in court.
- 7. On a personal level, I have 15 years of experience working as a court interpreter in BC and I can provide reference letters from lawyers, police and fellow interpreters if necessary. I always have a full schedule because of my good reputation. After the proposed change, my work load will decrease significantly, not because I provided bad service or I made any significant error in my work, but simply because I was down-graded for administrative or political reasons instead of a proper evaluation.
- 8. Talking about evaluation, I know STIBC court interpreters who are completely incompetent, so I feel an evaluation shall be given to every court interpreter equally.

- 9. The proposed change is going to become effective July 1st, there's not sufficient time for VCC accredited court interpreters to prepare for the change.
- 10. The VCC court interpreters had 10 months of intensive training and they didn't just merely pass the exam, they took an exam and passed it.
- 11. The recruitment of VCC court interpreting program students were extremely strict, often only 1-2 out of 50 to 80 candidates were selected to participate in the program. Suggestions:
- 1. VCC accredited court interpreters should be given ample notice, like 3 years, to transition to the new system. The 3 years reference is mentioned because we just missed the deadline for this year's exam, so it will take us 3 years to complete a not-so-complicated exam that contains two parts (written and spoken, simultaneous and consecutive interpretation)
- 2. STIBC may grandfather all VCC graduates in some way, or maybe arrange an expedited exam for the vcc GRADUATES.

I have offered to pay Quickpass all our savings \$6k and a promise to pay them what we owe if they allow ICBC to renew our insurance but as of today both ICBC and Quickpass have refused to negotiate.

How did this happen? how has a corporation been given this sort of power over hard working Canadians? i don't understand how this can be that ICBC can hand this unprecedented power to a corporation so that they can demand what ever they like with no recourse from BC residents?

I pay my taxes and contribute to the local economy and do not have to rely on government support but within a few months I will be homeless and bankrupt and why, because ICBC has given a corporation the power to demand immediate payment of debt with no terms regardless of their own culpability in the matter. I know I am not the only person who is in this position, our broker said that there are many people who have been driven into poverty due to similar problem with ICBC.

Can you please help? I am sure this is an totally unintended consequence of a decision made under your watch, as you were elected as part of a government of the people that protected them from the excessive power of corporations.

Can you please demand that ICBC stop doing this to BC residents before we see more people extorted with what amounts to a Seal of approval by the Provincial government.
