Dear Honorable Minister Heyman,

I am writing to request a meeting with you or your staff about an initiative that I have been working on with other business, legal and non profit partners. The initiative is aimed at working with government to make changes to the BC Companies Act to allow for companies to registered as a Public Benefit Company. The BC Companies Act would need to be amended to allow companies to be registered as a Public Benefit Company.

A Public Benefit Company (PBC) is a for profit company that is legally allowed to use their business as a force for good without concern of a shareholder challenge which could take place under the registration of a corporation under the existing BC Companies Act. Registering a corporation as a PBC protects corporations by allow a corporation to expand its purpose, from being solely profit and shareholder value driven, to one of profit and public benefit. Without this legal protection an activist shareholder could challenge the corporation's board with respect to any activities undertaken by the corporation that are not directly related to increasing profits and shareholder value. A PBC is profit driven but must give equal consideration to the impact it is having on the environment, its workers, the community, suppliers and customers and can direct profits to the public benefit versus solely to shareholders.

PBC registration is currently available in 35 US States, including California and Delaware, the

adoption by the remaining US states continues. Currently it is not possible to register as a PBC in any of the provinces or federally, in Canada. There are efforts being made on the federal level by my colleagues but my hope is for BC to be the first jurisdiction to allow for PBC registration in Canada. This would make BC a recognized leader in this movement of business being a driver of positive social and environmental change.

Please not that this form of registration does not replace or resemble the BC Community Contribution Corporation (CCC) registration. The CCC is non profit oriented and is not workable as a substitute for Public Benefit Company registration.

We have taken the liberty of preparing a draft amendment to the BC Companies Act for your reference. It is based on California and Delaware precedents and is relatively simple in nature, approximately four pages of text. Owen Bird, a prominent Vancouver law firm, drafted the amendment to align with the BC Companies Act on a pro bono basis. Owen Bird and the legal council for B Lab, a non profit, are available to provide any support the government requires to move this forward, on a pro bono basis.

I have attached information pieces to provide context and rationale for the implementation of this legislation in Canada on a federal basis. The same principles apply to provincial registration. Given that most companies in Canada are provincially registered the importance of provincial adoption is significant. Our company is a certified B Corp and can provide first hand knowledge as to the positive impact of this model on an otherwise traditional business.

I would make my self available at the earliest convenient opportunity to meet with you or your staff to discuss the value of this initiative and next steps. I thank you in advance for your consideration of this proposal.

Importance: High Honourable Minister,

Please find attached a letter I sent to Premier Horgan for your review and comment.

I can advise of the following:

- 1. My office has been in contact and is in cooperation with a group of lawyers in order to address this complex issue;
- 2. Indirect and direct lines of communication have been established between our group and hundreds of homeowners and stakeholders who have been, and will be, effected by this tax;
- 3. If your government continues to proceed with the speculation tax, you can expect legal action against the B.C. government.

The B. C. government has for years advertised to people that they should come to B.C. and partake in tourism of your province. In so doing, they have invited people to do exactly what they have done in purchasing and maintaining short term rentals. Further, as Canadians, we are encouraged to do business and make sound investments. Property is one of the most sound investments one can make. Now, the B.C. government, while still advertising for people to come to B.C., have implemented a tax that will not effect speculation, but will harshly penalize people who own and

maintain their homes. This action interferes with the contractual obligation of homeowners who rent their houses on a short term basis, and interferes with commerce generally. Depending on how you do, or do not, decide to amend or vacate this tax, this may be an act of continued tortious interference. The damage done by the manner in which this has been announced as already had a serious impact and has interfered with commerce.

This tax by the B.C. government is obviously a serious issue for my family, and for many individuals, but I also have a larger concern about the consequences of a Province unilaterally taking such an extreme stance, especially with respect to other Canadians. These actions seems contrary and antithetical to our government, charter and economic systems. While I very much appreciate the issue faced by B.C., this tax could have far reaching consequences. In a time of such extreme views, I would have at least expected the B.C. government to have carefully modeled their proposed solution and consulted stakeholders before implementation. Taken a step further and it is easy to see how policies such a these (or the lack of foresight applied to them) could result in further trade issues such as a tariff system between provinces that would fundamentally alter the economics of our country, to say nothing of our relationship with the United States. Actions such as these have the effect of chipping away at our democratic economic system.

While I am sympathetic to the serious housing issues facing many people, and am willing to assist the government in addressing them, this action by the B.C. government is wrong and should be discontinued immediately.

I hope to hear back from your government on an expedited basis. If you are unwilling to announce that the speculation tax has been amended or vacated soon, we will have little choice to take legal action and seek an injunction.

Dear Minister James,

Payment delays are the most significant bottleneck in B.C.'s construction industry. Cash flow problems in the construction industry discourage hiring, lower investments in capital, training of apprentices and in the worst cases, lead to small business and personal bankruptcies. As one of your constituents, I am writing to say that the problem of delayed payments is unacceptable and to express my support for the adoption of prompt payment legislation in our province.

Our province needs a prompt payment solution that works for everyone including tradespeople, contractors, government and consumers. While this serious problem is being felt now in our industry, there is a serious risk to B.C.'s competitiveness long-term if we do not take action to fix the issue. Most recently, Ontario passed Bill 142 which amended the Construction and Lien Act to require payments to sub-contractors by general contractors within seven days of receiving payment from the project owner. This measure was supported across the construction sector by general contractors, trade contractors, suppliers, and labour groups and would be a fitting blueprint for B.C. to follow.

The adoption of prompt payment legislation in British Columbia would stimulate the construction sector in our province at no cost to government, while bringing us in line with other jurisdictions. In the U.S., 49 of the 50 states have prompt payment laws. The United Kingdom, Ireland, Australia, New Zealand, and the U.S. all have federal prompt payment laws as well. These countries know that when contractors aren't paid for completed work that is not in dispute, everyone loses. This includes the provincial government, which funds substantial infrastructure projects. Taxpayers end up footing the bill for inefficiencies that could be easily addressed by passing legislation.

A prompt payment law would benefit the skilled trades by releasing cash flow in the industry: more cash would allow contractors to take a longer investment outlook and, hire more tradespeople and apprentices.

I am lending my voice to the thousands of trade contractors across British Columbia who support this initiative and calling on you to ensure the government passes prompt payment legislation before the end of its mandate. Small businesses and the people who work for them are counting on you.
