Dear David, Gala (and Tanera):

Somewhat later than planned, I'm following up on our discussions at the end of April regarding HIV criminalization, with two purposes:

- (1) I wanted to provide you with some additional material as discussed; and
- (2) I wanted to inquire about getting scheduled soon the follow-up meeting that we discussed. As you can appreciate, the window for making positive and necessary change on this front is open now, and we should not miss the opportunity to rectify a long-standing and ongoing injustice against people living with HIV.

### **(1) Materials**

During the course of our discussion, we said that we would share with you a number of documents that would be helpful in taking up the task of improving BC's prosecutorial stance vis-à-vis allegations of HIV non-disclosure. Therefore, I am attaching the following:

- **Canadian scientific consensus statement:** This statement was authored by 6 leading HIV scientists in Canada (including Dr. Julio Montaner) and endorsed by more than 70 others and the Association of Medical Microbiology and Infectious Disease, and published in 2014 in the peer-reviewed *Canadian Journal of Infectious Diseases and Medical Microbiology*. It was written specifically because of the concern that the criminal justice system's "poor appreciation of the science" is leading to over-application of the criminal law and miscarriages of justice. It has been used in numerous cases to secure a withdrawal or reduction of charges originally laid, and as an adjunct to the testimony of scientific experts (some of them authors/endorsers of the statement) in prosecutions. Note that the scientific case for limiting the application of the criminal law has only grown stronger in the 4 years since that statement was published, given additional research studies that have reported results. *I should note that, as mentioned at our meeting, next month, in conjunction with the International AIDS Conference (AIDS 2018) in Amsterdam, an updated, international scientific consensus statement, co-authored by 20 of the world's leading HIV scientists, will be released in the Journal of the International AIDS Society, with endorsement by many other scientists, UNAIDS, the International AIDS Society and the International Association of Providers in AIDS Care (IAPAC), reflecting a global consensus among key experts and agencies regarding the need to limit overly broad HIV criminalization.*
- Also attached is a **briefing note prepared recently for a ministerial roundtable held here in Ontario** with the Attorney General, representatives from some other relevant ministries and a number of key community stakeholders, scientific experts and HIV clinicians, etc. It was prepared by the Canadian HIV/AIDS Legal Network and the HIV & AIDS Legal Clinic Ontario (HALCO) for the Ontario Working Group on Criminal Law and HIV Exposure (CLHE). It provides the most current summary of the state of the law and prosecutions in Canada, the many concerns with the overly broad state of that law, the developments that have happened recently, and lays out what needs to happen next – including with 12 recommendations to the Province of Ontario. We submit all of those

recommendations are also entirely relevant to all other jurisdictions in Canada, including BC.

- Attached is the **original report of the CLHE in Ontario**, based on consultations around the province, with numerous recommendations for the development of guidelines for prosecutors in that province – it is a more detailed document providing more detailed rationale for the various recommendations. Again, much of the substance would be applicable in any province.
- I’m also attaching both the **2012 report of the UN’s Global Commission on HIV and the Law** (see Chapter 2 for the discussion of, and recommendations regarding, overly broad HIV criminalization), and the subsequent **2013 Guidance document from UNAIDS** laying out the various scientific, medical and legal considerations about limiting overly broad HIV criminalization, which provides much more detailed guidance on translating those recommendations into law and policy.
- Let me also draw these important cases to your attention, that have been decided since the Supreme Court of Canada’s 2012 ruling in *R v Mabior* (links provided below):
  - o 2 separate rulings in proceedings involving an HIV-positive teenager in Nova Scotia, not least because of their reasoned critique of the *Mabior* ruling’s defects and a sensible interpretation of that decision’s “realistic possibility of transmission” test for conviction:
    - *R. v. J.T.C.*, 2013 NSPC 105 (Acquittal; unprotected sex with an undetectable viral load) (also see [Summary](#))
    - *R. v. J.T.C.*, 2013 NSPC 88 (Condom use; low viral load; critical analysis of *R. v. Mabior*)
  - o *R. v. C.B.*, 2017 ONCJ 545 (CanLII) (acquittal, condomless sex with undetectable viral load)
  - o *R. v. Thompson*, 2016 NSSC 134 (condom use or low viral load or no ejaculation), and then the appeal before the NS Court of Appeal correcting the error by the trial court regarding the issue of “harm”: *R. v. Thompson*, 2018 NSCA 13
- Attached is the **updated Ontario policy guidance** issued on December 1, 2017 – which was then also distributed by the Attorney General to all police services across the province. Note the highlighted portion that represents the clear statement by the Attorney General that prosecutions will not proceed in cases where the person living with HIV has a suppressed viral load for at least six months.
- You may also be interested in this recent **study indicating the harmful public health impact** in Ontario of overly broad HIV criminalization, including by deterring some people from seeking HIV testing – an impact that of course flies directly in the face of efforts, in which BC has been a leader, to connect people to testing and to ARV treatment not only for their own well-being but also as a key element of effective HIV prevention.
- Lastly, I believe I shared this at the time it was published, but in case you didn’t see it then, here is the link to our **op-ed in the Vancouver Sun** that appeared at the time we met outlining some of our critique of the very disappointing policy on HIV non-disclosure prosecutions issued by the BC Prosecution Service on March 1<sup>st</sup>:

As discussed, it is profoundly disappointing that the new guidance adopted by the BC Prosecution Service on March 1, 2018 doesn't even clearly state – unlike the policy in Ontario – that there will be no prosecution against a person with a suppressed viral load. But as we stated in response to the new Ontario policy last December – see attached statement – that is just one very modest (and necessary) step that must be taken in modernizing prosecutorial policies in Canada. At the very least, as discussed at our meeting, any prosecutorial guidance in every jurisdiction in Canada should reflect the recommendations in the Justice Canada report released last December, including the following:

- Consistent with the relevant SCC jurisprudence, the criminal law should not apply to persons living with HIV who have engaged in sexual activity without disclosing their status if they have maintained a **suppressed viral load** (i.e., under 200 copies per ml of blood), because the realistic possibility of transmission test is not met in these circumstances. A person living with HIV who takes their treatment as prescribed is acting responsibly.
- The criminal law should generally not apply to persons living with HIV who: are **on treatment**; are not on treatment but use **condoms**; or, **engage only in oral sex** (unless other risk factors are present and the person living with HIV is aware of those risks), because the realistic possibility of transmission test is likely not met in these circumstances.

This position is also endorsed by (what is now) more than 160 organizations from the HIV sector and beyond from across Canada, in the **Community Consensus Statement** on ending unjust HIV criminalization. We shared a copy with you at the meeting, but I attach it again here for convenience, along with an **FAQ** document that provides a bit of background about how this consensus statement came to be.

We look forward to continuing to work together to ensure revisions to BC's prosecutorial stance to better reflect science, and to better respect human rights and protect public health.

## **(2) Follow-up meeting**

From our discussion at our meeting at the end of April, I understood that you planned to have some further discussions with the BC Prosecution Service, in light of concerns raised about the current

prosecutorial policy.

**We also agreed that that a follow-up meeting involving community representatives and the BC Prosecution Service would be useful. I'd like to see if we could get that scheduled as soon as possible. We had talked about June or July as possibilities for this. I'd be grateful if we could try to nail down some dates and make this happen; I'd be happy to talk with Tanera about that.**

(In the meantime, I did have a bit of follow-up discussion with colleagues locally in BC who work in the HIV sector about some key stakeholders that could be brought together for this discussion, including women living with HIV, and am happy to pick up those conversations with them and facilitate that once we can nail down some options for a meeting.)

Lastly, I did want to note that we all recognized that, as Attorney General, Minister Eby has the legal authority to issue a directive to BC prosecutors should the Prosecution Service be unwilling to adopt prosecutorial guidance that he feels is satisfactory. While we appreciate that it would be much preferable for the Prosecution Service to indeed adopt a much sounder policy, we also know from history that this may be very difficult to achieve – and certainly in a timely fashion. As noted above, we don't want to miss a window of opportunity that currently exists, with an Attorney General who understands the concerns, to get sound prosecutorial policy in place. (David, for a trip down memory lane: I stumbled upon this article from 2012 in connection with the Mabior case, in which you were commenting, as Legal Network president, about the need to not prosecute people who use condoms: <http://www.cbc.ca/news/canada/manitoba/supreme-court-hears-hiv-disclosure-case-1.1160825>.)

I've copied my colleagues Ryan (from HALCO) and Nick (from the Legal Network) here; as you recall, they were at our meeting.

I look forward to hearing from you about how we can move quickly to ensure greater justice for people living with HIV in British Columbia.

Good day

The origins of my complaint is based on the PGT acting outside of the rule of law. It is grounded in their failure to comply with 2 Freedom of Information requests and extends to the failure to abide by the rules of the court, and acting in a manner which they themselves characterization as being Bribery.

If the PGT classifies their own behaviour as "Bribery", where is the justice? How many other people are affected by this type of behaviour? I only discovered things through the intervention of 3<sup>rd</sup> parties. I have no doubt where people interacting with the PGT do not have the revelations of 3<sup>rd</sup> parties, that the PGT can act unscrupulously without fear of being discovered. I believe the failure to act fairly & in accordance with the rule of law, is a structural deficiency engrained in the PGT's office. I call upon your office review it in the context of the moral, ethical and legal implications that affect all British Columbians. It is a matter of the Public Interest. The PGT's office describe themselves as "Officers of the Court". How is it that Officers of the Court can operate in such flagrant disregard to the rules of the Court?

Since I received a copy of my s.22 letter dated November 23, 2017 and challenged the PGT on the matter which they classified as bribery, the PGT failed to appear at my s.22 a Residential Tenancy proceeding on January 10, 2018. The result was that the Landlord won the Residential Tenancy hearing on the basis of a 'no-show' rather than on the merits of the case. The PGT knew of the Residential Tenancy Jan 10 2018 hearing because they appeared at the Nov 27, 2017 hearing. The November 27<sup>th</sup> hearing was a 'cross application' by the Landlord. Obviously if there is a cross application, the PGT would know the original application still had to be heard. I understand the PGT has since acknowledged that they knew of the Jan 10 application, but they did not know when. They didn't have the courage to contact the Landlord about the time? Was the PGT expecting that the persons s.22 to do their work for them? The people of British Columbia are deserving of a PGT that can fulfill its obligations. (Note: The PGT handles both my s.22 affairs.) The province closed down Riverview and Woodlands because of client abuse. I bring to your attention that the abuse continues. Now it is out of the office of the PGT.

The PGT did not appeal the Residential Tenancy decision until it was too late. Instead the s.22 endured the stress of an unknown future for several months. I understand they are now essential homeless getting help from homeless shelters. I can't confirm their whereabouts. However what

does this say about the PGT's moral and ethical character and their legal obligations? I believe this action was vindictive because the PGT's Nov 23, 2017 letter was shared with me.

With respect to the bribery issue, **s.22** has acknowledged he received funds in addition to those identified in the November 23, 2017 letter. I emphasize it is the PGT that said these payments would be Bribery. They did not say "Yes we provide money to **s.22** for reasons A, B, C, and D". The PGT stated unequivocally that such payments would be Bribery. In summary as outlined in the attached, the PGT:

- Does not comply with FOI requests;
- Does not comply with the rules of the court; and
- Acknowledge that they engage in bribery during judicial proceedings.

These are serious matters. They are matters of public interest and need to be dealt with. An investigation is required to determine how rampant the abuses are that stem from the PGT's office. I call upon you to open an investigation. I await your response.

My latest revised claim:

The Government of Canada is bound to assent to the laws made for the Government of Canada, as section 91(25) complements the exercise of the Royal Prerogative power, in respect of the *Royal Style and Titles Act R.S.C.*, and reinforces the conclusion that all aspects of citizenship are within the exclusive and plenary authority of Parliament", as guaranteed by s. 2(2), 7(1) and (3) of the Statute of Westminster, 1931, which was enacted in regards to s. 91 of the Constitution Act, 1867.

The Minister of Justice is an elected legislator and a representative of the electors or citizen's rights and freedoms in the exercise of the prerogative powers through the Governor General. The Minister of Justice is the official legal advisor to the Governor General in respect of giving assent to the Minister's revised statutes, thus controls the Governor General to either give assent or withhold assent to whatever enactment the Minister so decides. Therefore the Governor in Council is vested with plenary powers of legislation as large and of the same nature as those of Parliament itself (Lord Selborne in *The Queen v. Burah*[46]). Within the ambit of the Act by which his authority is measured, the Governor in Council is given the same authority as is vested in Parliament itself. He has been given a law-making power. Therefore the Minister has violated s. 3 and 4 of the Charter as an elected representative who has intentionally failed to provide effective representation and as such has betrayed the voters and citizens as a whole which is not justified under s. 1 of the Charter concerning the inconsistency with the principles and the so-called values that are essential to a **free** and democratic or jural society, thus the limits prescribed by law are unjustified. Section 9 (inherent prerogatives), 12 and 18 (legislated prerogatives) of the *Constitution Act, 1867*, are all placed within the "Queen" and the house of commons (cabinet) respectively under the residuary clause of s. 91 of the *Constitution Act, 1867*, thus provides for the supreme executive and legislative authority of and over the Government of Canada through the Queen in Parliament, and evidences the breach of the legislated privileges by the Minister.

**Public office. Essential characteristics of "public office" are ( 1 ) authority conferred by law, (2) fixed tenure of office, and (3) power to exercise some portion of sovereign functions of government; key element of such test is that "officer" is carrying out sovereign function. A position whose occupant has legal authority to exercise a government's sovereign powers for a fixed period.**

**"In our system, it grew up differently. It was because the people could not act in mass, and the right to choose a representative is every man's portion of sovereign power. Suffrage is a delegation of political power to some individual. Hence the right must be guarded and protected against force or fraud."** (emphasis added)"

**As explained in the Provincial Judges Reference, supra, at para. 100, it is evident that our Constitution contemplates that Canada shall be a constitutional democracy.**

*Yet this merely demonstrates the importance of underlying constitutional principles that are nowhere explicitly described in our constitutional texts. The representative and democratic nature of our political institutions was simply assumed.* (the vagueness doctrine is the democratic principle concerning the exercise of an executive and legislative or Royal prerogative power of assent)

**Federalism** = The Minister of Justice is responsible for the making of the revised statutes under the exercise of a pretended prerogative regulation-making power. *For example, although the federal power of disallowance was included in the Constitution Act, 1867, the underlying principle of federalism triumphed early. Many constitutional scholars contend that the federal power of disallowance has been abandoned*

**Democracy** = effective representation must be provided as an elected member of Cabinet in Parliament, which is the Minister of Justice who was given a law-making power through the Governor in Council to assent upon the rule of law, which is the supreme law of the land of Canada.

**Constitutionalism** = Section 1, 2(d), 3, 4, 7, 32, 41(a), 44, 48 and 52 of the Constitution Act, 1982 and s. 9, 10, 12, 18 and 91 of the Constitution Act, 1867.

**Rule of law** = The Royal Style and Titles Act, the issued proclamation pursuant to s. 48 of the Constitution Act, and the supporting Citizenship Act, as Citizenship is a privilege not a right, thus makes the Citizenship Act, a "law of Canada" within the meaning of the Bill of rights.

## **[6] "Principles of Fundamental Justice"**

### **[6.A] Nature and Sources of the "Principles"**

Jurisprudence on s. 7 has established that **a "principle of fundamental justice" must fulfill three criteria. First, it must be a legal principle.** This serves two purposes. First, it "provides meaningful content for the s. 7 guarantee"; second, **it avoids the "adjudication of policy matters".**

**second**, there must be sufficient consensus that the alleged principle is **"vital or fundamental to our societal notion of justice".** (Democratic principle of effective representation by mutual consent through voting)

**Third**, the alleged principle must be capable of **being identified with precision and applied to situations in a manner that yields predictable results.**



The underlying values and principles of a free and democratic society are the **genesis** of the rights and freedoms guaranteed by the Charter and the ultimate standard against which a limit on a right or freedom must be shown, despite its effect, to be reasonable and demonstrably justified. [emphasis added.]
