From the reporter:

"That doesn't answer my question -- you have TNO and you would see the transcript for A-G Eby's appearance on the Jon McComb Show, where he indicated that the luxury cars and horse racing portions would be released first and the rest later.

Did A-G Eby wrongly read his briefing note? Will there be a phased release of the second German report?"

**Background**

This is a follow-up to a media request from March 25, 2019.

**REQUEST:**

The reporter heard Minister Eby on the Jon McComb show and would like to confirm:

- 1) Will the second German report be released in phases, with the horse racing and car sections being released separately, before the real estate section?
- 2) What is the schedule for public release? Late June?

**RESPONSE:**

Provided Background

- Dr. German will submit his second report to government on March 31. As we learned from the first report, the information included is often complex and will require a period of review before it can be made public. We expect that the report will be publicly available before summer. After initial review, if there is information we can provide in advance, independently of the full report, we will make every effort to do so.

**Recommendation – provide background**

- As mentioned in our initial response, Dr. German's second report will be submitted to Government on March 31<sup>st</sup>. The report will then require a review by government before details are released. There are no plans for a phased release.
- The Attorney General was correct in his interview in that if appropriate he may choose to release details related to horse racing and luxury cars in advance of the full report, if it makes sense and does not require the content of the full report. This will be decided following a review of the findings.

News 1130 is working on a story about three former employees at Parq casino who were fired last year and arrested by police. They would like to schedule a pre-taped radio interview with Minister Eby to discuss the firings and the cause of them. If no one is available to speak, they will accept background or a statement addressing:

- 1/ How did it come to the attention of Casino managers or others who reported this issue that a scheme was going on?
- 2/ What was the time period over which the offences occurred?
- 3/ Has the province requested any protocol changes in the wake of these allegations?
- 4/ How does "88 casino workers were cited for improper conduct, seventy-nine were fired" between 2016 and 2018 compare to previous years' data?
- 5/ Is this investigation ongoing?
- 6/ What is the biggest concern that has arisen out of these allegations/incidents?

The interview would be 7-8 minutes with journalist Ash Kelly.

**Recommendation – provide background**

**1) How did it come to the attention of Casino managers or others who reported this issue that a scheme was going on?**

These matters were identified by casino surveillance and security staff, who alerted Gaming Policy and Enforcement Branch (GPEB) investigators. GPEB referred the incidents to police for their investigation

or follow-up. As these investigations have been passed to the Vancouver Police Department, they are more appropriately placed to respond to any further questions on this matter.

**2) What was the time period over which the offences occurred?**

These incidents occurred in 2018.

**3) Has the province requested any protocol changes in the wake of these allegations?**

GPEB has increased its presence at lower mainland casinos as a result of Dr. Peter German's December 2017 recommendation that government regulators have a presence on-site and are available to service providers throughout the day and during peak hours. With an increased presence in lower mainland casinos, GPEB is able to be on-site in casinos to proactively investigate incidents in real-time.

**4) How does "88 casino workers were cited for improper conduct, seventy-nine were fired" between 2016 and 2018 compare to previous years' data?**

GPEB created the record referenced in the FOI request for the applicant, as GPEB didn't initially have those records in the format the applicant requested. If you would like data from previous years, you may wish to submit a FOI request.

**5) Is this investigation ongoing?**

There was an input error in the report received through FOI. For the three gaming workers whose registration was cancelled for termination related to Cheat at Play, rather than "Charged by Police," the report should have stated that GPEB referred the incidents to police for their investigation or follow-up. In cases referred to police, GPEB is available for support and further assistance as needed. As these investigations have been passed to the Vancouver Police Department, they are more appropriately placed to respond to any further questions on this matter.

**6) What is the biggest concern that has risen out of these allegations/incidents?**

These allegations or incidents of cheat at play are of concern to GPEB. Our enhanced presence in casinos will assist in prevention and will allow for immediate action/assistance to casino staff and police of jurisdiction when there are allegations of wrongdoing.

**Request**

The reporter would like to schedule a phone interview with Minister Eby to discuss the timetable for ride-hailing insurance. He would like to know when it will be ready, as he has heard from sources that it may be available very soon.

The interview would be 8-10 minutes. He will accept a statement if an interview cannot be scheduled. He has also reached out to ICBC for comment.

**Recommendation – Provide background**

- Creating an appropriate insurance framework for the new ride hailing industry in B.C. is a complex task and we are taking the time to get it right.
- Government introduced and passed the comprehensive Passenger Transportation Amendment Act in fall 2018 to enable ride hailing in B.C.
- We are now working along with the Ministries of Transportation and Infrastructure, Public Safety and Solicitor General, and Municipal Affairs, on the regulatory framework to support the industry, and we are working in partnership with ICBC to develop the right insurance product for this market.
- The insurance product will be similar to what is offered in other jurisdictions including those with private insurers. ICBC will deliver a blanket insurance certificate, that we anticipate will be usage-based.
- Once the supporting regulatory framework is in place, ICBC will make an application to the BC Utilities Commission so that it will be ready to offer an insurance product to the ride hailing industry in B.C. for fall 2019.

In short: the \$21,000 premium quoted is correct, but it isn't currently affecting the woman's insurance. She can wait to renew until September when the new rate structure comes into effect—which will allow her to have an insurance rate of around \$1900 to \$2300.

The reporter's analysis shows that when JIGIT released information on some elements of the Big Circle Boys-Jin group investigation in the summer of 2017, BCLC management, GSPs, and industry spokesman Peter Goudron were concerned that BCLC casinos were included in the police's information. This was an unwelcome surprise. Earlier records show that Jim Lightbody wanted GPEB to be concerned about illegal casinos, and had provided information to GPEB about this concern, as well as wanting further information on 10 casino gamblers using laundered bank drafts from Canadian banks.

The record below show that in the initial communications response to the JIGIT surprise, apparently Bud Smith (mentor to former GCG VP and BC Liberal political

campaigner Jacee Schaefer) and Jim Lightbody discussed seeking meeting with Minister Eby to correct the record. The reporter would like to know:

- 1) Did this meeting take place? If so, what was discussed?
- 2) 2. Is there any reasonable concern that BCLC's desired outcome was for regulation and policing to focus on illegal gaming, rather than legal gaming? In light of consideration that BCLC knew or should have known the same organized crime actors were involved in both legal and illegal casinos, and the currency of BCLC baccarat high value chips flowed between them (as alleged in a number of documents including the Jin civil forfeiture action).

The reporter originally contacted BCLC with this query but did not receive a satisfactory response.

### **Recommendation - provide background**

**1: Did this meeting take place (between Jim Lightbody and Bud Smith and then-Minister Michael de Jong regarding the subject of the Joint Illegal Gaming Investigation Team (JIGIT)'s media conference on June 13, 2017)? If so, what was discussed?**

- GPEB is not aware of whether a meeting took place as the BCLC board chair is directly accountable to the Minister.
- BCLC or former Finance Minister Mike DeJong would be best suited to answer this question as they would have been involved if a meeting occurred.

**2: Is there any reasonable concern that BCLC's desired outcome was for regulation and policing to focus on illegal gaming, rather than legal gaming? In light of consideration that BCLC knew or should have known the same organized crime actors were involved in both legal and illegal casinos, and the currency of BCLC baccarat high value chips flowed between them (as alleged in a number of documents including the Jin civil forfeiture action).**

- BCLC notified GPEB and the local police of their concern related to illegal gaming houses in the lower mainland during the timeframe in question. This was the appropriate course of action for BCLC to take.

- This information, along with police and GPEB intelligence, supported the creation of the Joint Illegal Gaming Investigation Team (JIGIT).
- JIGIT is mandated to investigate all illegal gambling activity with a special focus on disrupting organized crime and gang involvement in illegal gambling, and preventing money laundering in gambling facilities.
- JIGIT, BCLC, and GPEB work collaboratively to address money laundering and criminal activity at gambling facilities through the coordination of intelligence, investigations, and enforcement.

First off, thanks to the Attorney General for coming out to the BC Notaries Association Spring Conference. I understand that you had an opportunity to connect with Ron Usher (amongst others) during your time there. My apologies for not saying hello during the event.

As you may know, the Society of Notaries Public is separating functions of regulation and advocacy. The regulatory functions will remain with the Society and the advocacy will fall to the BC Notaries Association. I understand that the Association will be visiting Victoria in early May for the purpose of engaging the Attorney General and other Ministers in discussions about notaries and notary practice. As you heard at the conference, notaries are a passionate group who are deeply committed to their clients and the needs of their clients.

As a regulatory body, the Society does not engage in lobbying efforts. We have and will continue to set standards for the provision of legal services, identify emerging practices areas which are within the Scope of Practice and may require new or additional standards statements or guidance, implement initiatives that seek to maintain and improve the quality of services provided by notaries, and operate programs designed to protect the public. We may also, in response to the Attorney General, speak to the education and competence (or lack thereof) of Notaries to provide services that may fall within the ambit of access to justice.

I am also aware of various initiatives within the Real Estate sector and by the BC Notaries Association with respect to money laundering. <https://news.gov.bc.ca/releases/2019AG0037-000675>. While I appreciate the efforts, professional advocacy organizations lack the statutory authority to implement programs and reporting requirements upon members that would make effectual, the practical and valuable actions proposed. As you know, Notaries are fully subject to FINTRAC and, as the German report(s) appear to indicate, are if not part of the solution certainly not part of the problem with respect to money laundering.

The Society of Notaries Public funds and sponsors anti money laundering education for members, information sessions for FINTRAC auditors, and is a member on the federal Advisory Committee on Money Laundering and Terrorist Financing.



Please do let me know if there are any follow up actions that may arise from the Attorney General's session with the Notaries.

**Request**

The reporter is working on a story related to two court cases - the Council of the Haida Nation v. B.C. and Cowichan Tribes v. Canada. Both cases involve private landowners in B.C. who could be potentially impacted by claims of Aboriginal title. Court decisions in 2017 for both cases dismissed applications for those landowners to be given notice about the claims. She would like to know:

- 1) Has the province appealed either of the 2017 decisions about giving notice to private landowners?
- 2) Has the province given notice to any of the private landowners who could be potentially impacted by either of these two actions? If not, why?

## **Recommendation – Provide background**

- 1) **Has the province appealed either of the 2017 decisions about giving notice to private landowners?**
  - The Crown did not appeal either of the 2017 decisions.
- 2) **Has the province given notice to any of the private landowners who could be potentially impacted by either of these two actions? If not, why?**
  - As the private landowners have not had formal notice of these claims, the courts have indicated that any finding of Aboriginal title would not be binding upon them. In the absence of such notice, they would be free to raise all defences should the First Nation elect to make claims against them.

- 4) Just some clarification: this Bill is based on the Ontario bill of the same name, which in turn is based on the Uniform Law Conference's 2010 Uniform Prevention of Abuse of Process Act, correct?
- 5) You said in the legislature that "there likely won't be a huge number of these cases." Why is that?

The interview would be 8-10 minutes. The reporter is available until Friday afternoon. If an interview cannot be scheduled, she will accept background information.

## **Recommendation – Schedule interview or provide background**

- 1) **What was the motivation behind the legislation?**

- SLAPP suits, or strategic lawsuits against public participation, are lawsuits that either deliberately seek to or have the effect of limiting or stifling criticism or opposition on matters of public interest by imposing exhaustive and potentially costly legal action. These lawsuits often serve to silence people from engaging in public expression, due to a fear of retaliation by a party with significant financial resources.
- Our government is committed to playing a strong role in protecting people's freedom of speech and expression, the democratic process, and the integrity and appropriate use of the courts. The Protection of Public Participation Act fulfills a campaign promise we made to protect these things. This legislation strikes a balance between protecting the right of public participation and recognizing legitimate claims concerning reputation and economic interests.

**2) Why didn't it progress the first time around, when it was introduced in May 2018 as Bill 32?**

- This legislation was originally introduced in the spring 2018 session but did not proceed due to limited time. We were pleased to see it pass after we brought it forward again this year, and to announce that – despite the delay – the Act applies to lawsuits started on or after May 15, 2018 when the legislation was first introduced.

**3) In the legislature, you spoke about how this bill could benefit journalists, community organizers and activists who might get steamrolled by SLAPP suits launched by corporations. What about people who are publicly naming sexual abusers and getting sued for defamation, how might this Act affect them?**

- We cannot speak to specific matters, but if the court finds that a given lawsuit makes legitimate claims, it will be allowed to continue to trial. The legislation provides a fair, effective basis on which the court will be able to decide.
- The legislation also seeks to encourage public participation and expression on matters of public interest and reduce the risk that it will be hampered by fear of legal action.
- It allows the defendant to apply to dismiss a proceeding at any time on the grounds that it arises from an expression relating to a matter of public interest. Once the defendant brings this motion, it must be addressed before the proceeding can advance.
- If the court is satisfied, it will dismiss the proceedings. The Act would allow the court to fully indemnify the defendants for its costs.
- Alternatively, if the plaintiff successfully persuades the court that the harm they're likely to suffer as a result of the expression is serious enough, the proceedings will continue.

**4) Just some clarification: this Bill is based on the Ontario bill of the same name, which in turn is based on the Uniform Law Conference's 2010 Uniform Prevention of Abuse of Process Act, correct?**

- This model of legislation was first enacted in Ontario in 2015, then adopted by the Uniform Law Conference of Canada in 2017. This model is widely considered the best way to protect citizens against strategic lawsuits.

- B.C.'s Protection of Public Participation Act reflects Ontario's successful legislation and is a fairer and more effective legislative model than B.C.'s previous legislation.

**5) You said in the legislature that "there likely won't be a huge number of these cases." Why is that?**

- While there is no way to predict future numbers of cases, based on current observation there is no reason to conclude that cases involving the Protection of Public Participation Act will be an unduly large number.

Q. When did the requirement for a house trailer endorsement (Code 07) come into effect for Class 4 and 5 drivers who wish to tow a trailer which has a gross vehicle weight of more than 4600kg?

The requirement for a house trailer endorsement for RV trailers over 4600kg was introduced on March 14, 2003. This endorsement option was added in order to provide customers with a class 5 driver's licence an alternative to requiring a commercial class driver's licence to tow heavy trailers. Towing a larger trailer is more difficult than a smaller trailer because it requires special handling and braking techniques. B.C. also has unique geography that can require greater skill in operating these heavy combinations.

Q. How are drivers who insure a 5<sup>th</sup> wheel trailer that exceeds 4600kg notified of the Code 07 endorsement license requirement? Does ICBC send specific notices to Class 4 and 5 drivers with house trailers exceeding 4600kgs advising them of the requirement to obtain a Code 07 endorsement? Are ICBC representatives obligated to inform Class 4 and 5 drivers who present with a registration and licence plate for a house trailer that exceeds 4600kg that they must have a Code 07 endorsement in order to be qualified to tow the trailer? Are RV dealers in BC required to inform customers who purchase trailers over 4600kg of the Code 07 endorsement requirement?

- It's the responsibility of each individual to ensure they have the appropriate licence for the vehicle they're driving and its use. Drivers towing a trailer must ensure they meet driver licensing requirements.
- Customers can find information by visiting [icbc.com](https://www.icbc.com), a driver licensing office or by calling ICBC's driver licensing information line.

- ICBC and Autoplan brokers don't send out notices to drivers about trailer endorsement as each driver's scenario is unique. Vehicle dealers aren't required to provide advice on licensing requirements.
- Driver licensing requirements depend on the type of vehicle, how it's being used and what licence class/endorsements the driver has. Some drivers may need to obtain an endorsement 7 or 20, or a commercial driver's licence depending on all of these factors and some drivers may not need any additional licences/endorsements.

As an example, a 15 passenger vehicle that is used to transport family requires a class 5 but when used to transport a sports team, requires a class 4 licence.

Q. If someone in BC rents a 5<sup>th</sup> wheel or travel trailer which exceeds 4600 kg when loaded, do they need to have a Code 7 endorsement if they only hold a Class 4 or 5 driver's licence?

- Yes, a B.C. driver would be required to have an endorsement 7. If the driver holds an out of province driver's licence, at a minimum, they will need to hold a licence that is equivalent to BC's endorsement 7.

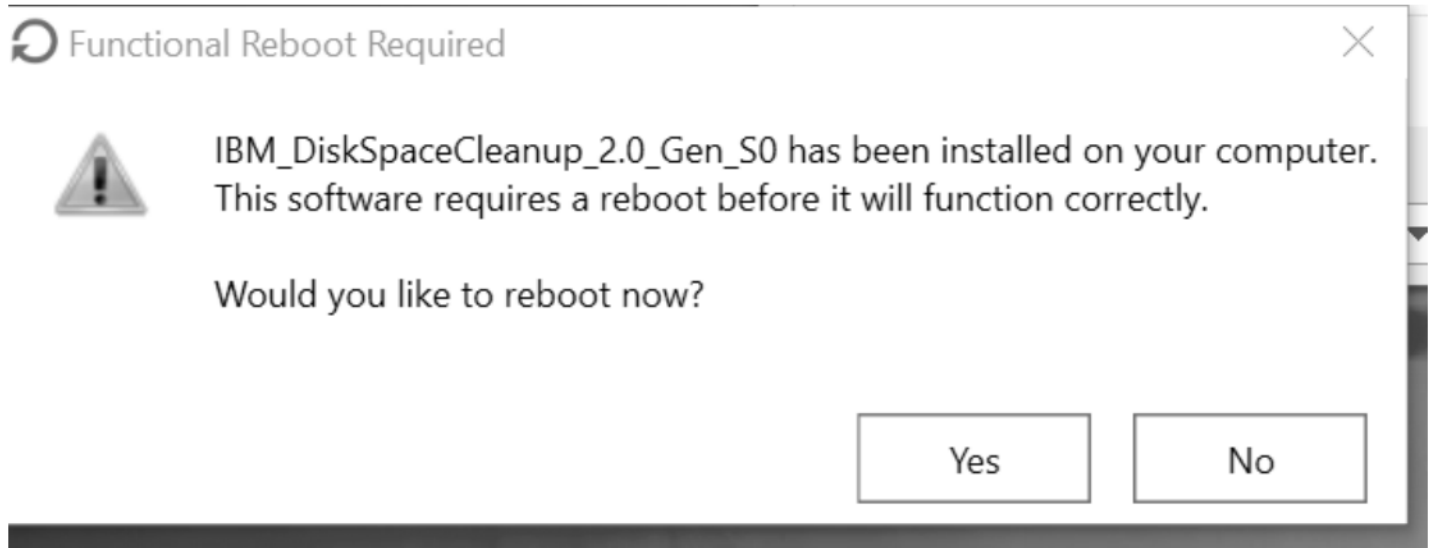

Dears.22 :

Thank you for your correspondence of April 19, 2019. I personally read all of my correspondence, including yours, and respond when possible and appropriate.

I share your concerns about the state of the family law system in Canada generally, and in BC specifically. This is not empty empathy – our government and my Ministry are taking substantive steps to try to make the system work better in the short-to-medium term, and reform it significantly in the long term.

In terms of longer range reform efforts, we have worked with the courts and with family law lawyers to redesign the family court rules in the province. We are launching a pilot project in Victoria under the new rules in a few weeks, which is aimed at supporting families better through mediation where appropriate, and family justice councillors who help people work through the issues they are facing and the paperwork they need to assemble.

All of this is to happen before a family appears in front of a provincial court judge. I am very hopeful for positive results from this pilot. If it is successful, we will deploy it across the province.

I also recently worked with my colleagues to pass a law to permit the Law Society of BC to establish a class of licensed paralegals in the family law area to provide support at more affordable rates for families in the family law court system.

In the short term, we have increased resources for legal aid to provide family “duty counsel” across the province to support people appearing without lawyers, and we are announcing the establishment of eight new clinics across BC funded by the province in partnership with the Law Foundation that will provide support to families in many different legal difficulties, including divorce.

These reforms will take some time to roll out, but we are working on, and recognize the issue. I am sorry to hear of the difficulties you experienced in our family law system.

I'd like to share with the participants in this exceptional and important report that we are partnered with the Aboriginal Justice Council to complete and implement a First Nations Justice Strategy that will reform how the justice system works with Indigenous peoples across B.C.

The release of *Red Women Rising* is perfectly timed to inform this important work; I would like to express my gratitude for the time and effort that was clearly taken by the participants to share their important stories, and for the work of those who coordinated the publication of this report, which will assist government staff in learning from these first-hand experiences of Indigenous women and girls, and ensure that the voices of these courageous women lead the way.

To date the Aboriginal Justice Council (which is the justice organization of the leadership group of the Union of BC Indian Chiefs, the BC Assembly of First Nations, and the BC Summit) has convened three separate meetings with community leaders, members of the justice system, and others to discuss the drafting and direction of the Justice Strategy.

Although they just completed two days of consultation meetings with First Nations community leaders from across B.C. on the strategy, as I understand it the Aboriginal Justice Council may be convening future meetings as we move forward together.

When they do so, I will ensure that an invitation to participate is extended to the Downtown Eastside Women's Centre as the host organization for *Red Women Rising* to ensure that representatives are able to attend to ensure critically important voices are heard at the table.

Thank you again for your consideration in sending me this report. Please pass on my thanks for the courage of the authors to share their stories, and their demands for change, with the provincial government and the people of British Columbia.
