

BEFORE STARTING THE APPLICATION

Before starting the application, ensure that:

- The corporation has a registered business number issued by the Canada Revenue Agency
- The corporation is not a federally licensed producer of cannabis
- The person filling out and submitting the application is at least 19 years old

The Province is not placing a cap on the number of non-medical cannabis stores that can operate in B.C. However, a licensee can only hold or have an interest in a maximum of eight cannabis retail store licences. For the purposes of the retail store licence cap, generally a franchisor cannot have more than 8 franchisees. This limit will be reviewed on January 1, 2021.

 - If submitting renderings, renderings may be either printed or hand-drawn (as long as they are legible)

✓ Floor Plan(s)

A **floor plan** is a document, showing a view from above, of the dimensions and relationships between rooms, spaces and other physical features on each floor of a structure. The document must measure at least 8.5" x 11" (standard letter size). A floor plan for each level of the establishment must be submitted if the proposed establishment has more than one level. Either a hand-drawn or computer-generated plan is acceptable, as long as the plan is drawn to scale and is clear and legible. A floor plan must not be submitted on graph paper or paper with gridlines.



Floor plan(s) - Continued

The floor plan must be submitted at the time of application and it must identify the proposed non-medical cannabis retail area(s) plus the following interior features of the establishment:

- Each room or area labeled with its intended use and dimensions;
- Washrooms, stairs and elevators;
- Entrances and exits (including those used by staff only);
- Cannabis storage areas;
- Sales counter and cash register locations;
- Furniture and fixture layout (e.g. shelves, display cases); and
- Identify the security system and other physical security features that secure the store.




Example of floor plan

✓ Site Plan(s)

A **site plan** is a document showing any existing and proposed building footprints, pathways of travel, parking, and landscaping elements, and the surrounding area. The document must measure at least 8.5" x 11" (standard letter size). Either a hand-drawn or computer-generated plan is acceptable, as long as the plan is drawn to scale and is clear and legible. A site plan must not be submitted on graph paper or paper with gridlines.

The site plan must include the proposed store footprint and a representation of any interior or exterior spaces surrounding the store, including:

- The location of any other buildings/businesses on the same site, each building footprint, type of businesses (e.g. gas station, office building) and building names, and their entrances and exits;
- A description of the type of separation proposed (for any adjoining businesses);
- Road access and exits, including any relevant street names; and
- Parking lots.



Example of site plan

If the proposed store is located inside a building with other businesses (e.g. a mall), submit **two** site plans:

- One site plan showing location of any other buildings/businesses on the same site, including:
 - Each building footprint, building name and a list of businesses operating inside the building
 - Road access and exits, including any relevant street names, and
 - · Parking lots
- A second site plan showing the location of the proposed store inside the building's footprint
 - All entrances and exits for the building
 - The location, name and type of businesses operating inside the building
 - o The store footprint with all entrances and exits for the store, and
- A description of the type of separation proposed for any business adjoining the proposed store

Full height walls are required for separation and no connecting doors between the cannabis retail store and the neighbouring business are permitted.

The cannabis retail store may share a vestibule with another type of business (e.g. a liquor store or grocery store) provided each business has its own controlled entrance within the vestibule. The cannabis retail store cannot share a vestibule with a business that would be contrary to public interest (i.e. business aimed at minors or a liquor consumption business).

The Applicant, Lightbox Enterprises Ltd., has applied to the Liquor and Cannabis Regulation Branch (LCRB) for a Non-Medical Cannabis Retail Store (CRS) licence proposed to be located at the above-noted address. Hello Sara,

Thank you for your email. In section 5(1)(p) of the Cannabis Regulations it states "(p) the retail store must be located in a permanent building or structure and be enclosed by floor-to-ceiling walls that are not transparent" as the mock up appears to have windows that are transparent with wooden slat blinds behind it. This wouldn't be acceptable as is; the window glass itself needs to be opaque.

Going forward, inquiries can be directed to <u>Cannabis.Licensing@gov.bc.ca</u> with the job number in the subject line. If the application is far enough in the process that it has been assigned to a SLA, your inquiry or supporting documents will be forwarded to them to review and add to the file.

My name is Sara and I work with Edna Lizotte and Bert Hick at Rising Tide. We had a few questions about store layout pertaining to the recent regulations update this month; the LRCB was asked via email the below questions, and I have also included the response when follow up by phone. The intent in asking these questions is that we want to make sure the client is complies with the regulations while making the best use of resources for their store. I appreciate any insight or feedback that you are able to provide.

Questions to the LCRB

- Can each store have a 36" stage in the front window and behind it secondary glazing that will have wood slats
 and between the slat there will be non-transparent slats that will allow light through, but will not allow sight
 lines or visual into the store itself?
- Can the window glazing have a film applid that is a mural or artwork print that is non-cannabis, non-cannabis promotional and not-appealing to the youth?

LCRB Answer:

As long as it's {window} opaque that shouldn't be a problem. LCRB said the best thing to do would be to create
a mock up so that they can review, so that there isn't any issues further down the line.

Please note that a mock up will be included, although we want to make sure that the LCRB is receiving the detailed information that is needed.







The Liquor and Cannabis Regulation Branch (LCRB) has completed the required financial integrity checks and security screenings for Lightbox Enterprises Ltd., and persons associated with Lightbox Enterprises Ltd.

Cannabis Accessories

A licensee may sell cannabis accessories as defined by the federal Cannabis Act, such as rolling papers or wraps, holders, pipes, water pipes, bongs and vaporizers. The sale of e-juice, e-liquid, or e-substance is prohibited.

A licensee is not authorized to sell snacks, tobacco (or products containing nicotine), or other items that are not related to cannabis.



I am reaching out to you in s.15: absence in the hope you will be able to assist me. I am forwarding my initial message to s.15: to give you some context about my inquiry.

I am writing to you in relation to the Hobo license name and the outstanding issue associated with the use of word "Recreational" in the name. Hobo license applications (2 in Vancouver and 1 in Kelowna) were approved with the word "Recreational" earlier this year. On July 19th, an inspector in Kelowna asked Hobo to remove "Recreational" from their name (and all signage, banners, displays, sandwich boards, etc).

As outlined in my email below, Lightbox has been waiting for a decision on the name and has removed all their signage to be compliant with LCRB. This has had a financial impact on their business as they are unable to put up any signage until a decision is reached by LCRB.

I also want to add that the reason provided by the inspector for the removal of the word "Recreational" was that the word "Recreational" refers to an outdoor sporting activity. However, the word "Recreational" in this instance was used as per the Oxford dictionary definition as meaning:

1. relating to or denoting activity done for enjoyment when one is not working.

"recreational facilities"

o relating to or denoting drugs taken on an occasional basis for enjoyment, especially when socializing.

"recreational drug use"

We are counsel for Lightbox Enterprises Ltd., the owner and operator of Hobo Recreational Cannabis Store. We write further to your correspondence with Sophie Mas regarding issues related to our client's cannabis retail licenses and pending applications.

We have reviewed your correspondence and considered it in light of the federal and provincial requirements that apply to our client as set out in the *Cannabis Act* and the *Cannabis Control and Licensing Act* and applicable regulations. In our view, our client's use of the word "recreational" does not offend the federal or provincial requirements and we write to ask that you reconsider your contrary conclusion.

The Cannabis Act prohibits the promotion of cannabis by:

presenting it or any of its brand elements in a manner that associates it or the brand element with, or evokes a positive or negative emotion about or image of, a way of life such as one that includes glamour, recreation, excitement, vitality, risk or daring.

Although the word "recreation" appears in the statute, the mere use of the word is not prohibited (and it was certainly open to Parliament to create such a prohibition if that was intended). Instead, the *Cannabis Act* is clearly focused on preventing the promotion of cannabis in a manner that evokes emotion through an association with certain ways of life. On its own, the word "recreational" as a descriptor of the type of cannabis sales available in the store does not create any such association with or evoke any emotion about a way of life.

Perhaps most importantly, our client's use of the word "recreational" is entirely consistent with both the spirit of the *Cannabis Act* and the express requirements of the provincial licensing scheme. As you are aware, the *Cannabis Control and Licensing Act* and terms and conditions imposed pursuant to it prohibit retailers from promoting cannabis in a manner, or using a name that would lead people to believe the retailer is a provider of medical cannabis. The Legislature clearly wanted to ensure that consumers are not misled about the nature of non-medical retail cannabis stores and created rules to establish a clear distinction between medical and other sales of cannabis. The use of the word "recreational" fits squarely with this legislative intent by distinguishing our client's brand and stores from those retailers selling medical cannabis.

In addition, we note that this interpretation is consistent with previous approvals received after final inspections by the Branch's licensing officials. Our client has reasonably relied on those approvals when incurring significant expense to develop and market under the Hobo Recreational Cannabis Store name.

In light of the foregoing, we ask that you reconsider the Branch's position as expressed in your email to Ms. Mas dated August 22, 2019. We look forward to confirmation that the Branch will permit the continued use of the Hobo Recreational Cannabis Store name and will not withhold approval of any future or pending license applications on the basis of that name.





Dear Camille Chisholm:

I write to you on behalf of the Liquor and Cannabis Regulation Branch (LCRB) in response to your letter dated August 28, 2019. My apologies for the brief delay in responding to your letter.

While I appreciated receiving your submission that the prohibition on the promotion of cannabis in the federal Cannabis Act does not extend to use of the word "recreational", LCRB's position on the use of the word "recreational" on retail store signage is a reasonable interpretation of the nature and scope of that prohibition.

The word "recreational" suggests, among other meanings, a leisurely, fun pastime or activity and as such readily comes within the scope of the prohibition, which refers to a brand that "evokes a positive... emotion or image of a way of life that includes... recreation...." The fact that the word "recreational" could serve to distinguish retail store cannabis from medical cannabis does not change the primary connotation of the word, or the fact that in our view it comes prima facie within the scope of the federal prohibition.

As I am sure you are aware, the policy manifest in the prohibition has been established by the federal government and can only be changed or modified by the federal government. It may be that further discussions and policy developments lead to a change in federal policy, but until then the prohibition must be enforced as worded.

I would further note the LCRB has not approved cannabis retail store licences that proposed the use of the word recreational in their business name or signage and indeed several applications have had that request denied. Fairness dictates that the same result prevails in this context.

Finally, I note that the Approvals in Principle provided by the LCRB to your client both approved specific wording of proposed signage, in which the word "recreational" did not appear. The Approvals in Principle also advised that any alteration or modification, of the name or signage in any way, required prior approval from the LCRB. No proposed alteration to the approved signage was ever submitted to LCRB for approval. Having failed to do so, the responsibility for having nevertheless made the alterations lies with your client.

It is unfortunate that your client has incurred costs with respect to their signage, but the LCRB is not in position to accommodate your request and will require all store signage to refrain from containing the word "recreational".


