Resident Manager is for sure required for the owner is not in Canada. A Resident Manager can be put on the liquor licence even if the owner is in Canada (or the province or even the town the establishment is in) – if they wish to have one. I have in quotes, a portion of the resident manager application which explains Resident Manager's well:

"*Resident manager: LCLB may consider an individual a resident manager if the person is employed to carry on the business of the licensee by being primarily responsible for the day to day operation of the establishment. A resident manager may be employed in an executive capacity by the licensee and have responsibilities that generally consist of supervising and/or directing human or other resources.

To be **officially** approved as a resident manager by the LCLB, an individual must be an employee of the licensee who is primarily responsible for the day to day operation of the establishment and who is not in a contractual third party operator agreement with the licensee. An approved resident manager must be a resident of British Columbia; be 19 years of age or over; and be an individual not a corporate entity or partnership. The resident manager does not assume liability for the overall operation and activities of the establishment on behalf of the licensee.

If a licensee resides outside of B.C. a resident manager must be present.* If the licensee is not on-site (involved in the day to day activities of the establishment) a resident manager is required. A resident manager is subject to the same suitability assessment as the licensee.





- 27.2 Dividends: The shares of the Company have the following special rights and restrictions with respect to receipt of dividends:
 - (1) Solvency Requirement: Dividends must not be paid on any class of shares if there are reasonable grounds for believing that:
 - the Company is unable to pay its debts as they become due in the ordinary course of its business; or
 - (b) the payment of the dividend would render the Company unable to pay its debts as they become due in the ordinary course of its business.
 - (2) Common Shares: In each year at the discretion of the directors, dividends may be paid on the common shares out of all profits or surpluses available for distribution, provided that dividends must not be paid on the common shares if to do so would reduce the amount by which the aggregate fair market value of the assets of the Company exceeds the aggregate liabilities of the Company to an amount that is less than the aggregate redemption amount of the outstanding class A shares.
 - (3) Conditional Dividends: If the Company is not a "small business corporation" as that term is defined in the Income Tax Act (Canada), then in each calendar year at the discretion of the directors dividends may be paid on the class A shares out of all profits or surpluses available for distribution but such dividends in respect of the class A shares may not exceed an amount determined for each day in the period in the particular calendar year in which the Company was not a small business corporation equal to the product obtained when the following are multiplied together:



- the Company is unable to pay its debts as they become due in the ordinary course of its business; or
- (b) making the payment or providing the consideration to repurchase or redeem its shares would render the Company unable to pay its debts as they become due in the ordinary course of its business.
- (2) Priority Restriction on Redemption: No shares of any particular class may be redeemed if to do so would reduce the amount by which the aggregate fair market value of the assets of the Company exceeds the aggregate liabilities of the Company to an amount that is less than the aggregate redemption amount of all issued shares of all other classes which have rights on liquidation that are equal or in priority to the rights of the class of the shares to be redeemed (as that priority is set out in section 27.4).
- (3) Not Redeemable: The common shares are not redeemable.
- (4) Redeemable Shares: The class A shares are redeemable.
- (5) Redemption at Option of the Company: The Company may redeem the whole or any number of the issued class A shares on payment for each share to be redeemed of the redemption amount and no more provided:
 - (a) that not less than 21 days' notice in writing of such redemption is given by mailing such notice to the registered holders of the shares to be redeemed specifying a date and place or places of redemption; or
 - (b) the holders of the shares to be redeemed waive any notice required to be given under this paragraph which waiver and a waiver given after the redemption will cure any default in giving such notice.
- (6) Payment of Redemption Amount: If notice as required of any redemption is given by the Company and an amount sufficient to redeem the shares is deposited with any trust company, chartered bank of Canada or lawyer's trust account as specified in any notice given on or before the date fixed for redemption, the holders thereof will thereafter have no rights against the Company in respect of such shares except upon the surrender of certificates for such shares to receive payment for them out of the monies so deposited.

 - (2) Priority Restriction on Redemption: No shares of any particular class may be retracted if to do so would reduce the amount by which the aggregate fair market value of the assets of the Company exceeds the aggregate liabilities of the Company to an amount that is less than the aggregate redemption amount of all issued shares of all other classes which have rights on liquidation that are equal or in priority to the rights of the class of the shares to be redeemed (as that priority is set out in section 27.4).
 - (3) Not Retractable: The common shares are not redeemable at the holder's option.
 - (4) Retractable: The class A shares are redeemable at the holder's option as provided for in this section 27.6.
 - (5) Redemption at Option of Holder: Subject to the provisions of the Business Corporations Act, the Company will, upon receiving notice from a shareholder holding class A shares, redeem the number of class A shares registered in the name of the shareholder which are specified in the notice by paying to such shareholder for each preferred share to be redeemed the redemption amount of the share and no more provided:
 - (a) that not less than 21 days' notice in writing of such redemption must be given to the Company by the shareholder seeking to have the class A shares redeemed, such notice to be delivered by mailing to the registered office of the Company a notice specifying the number of class A shares to be redeemed and surrendering the necessary number of share certificates for cancellation; or

- (b) the Company waives any notice required to be given under this paragraph which waiver, whether given before or after the redemption, cures any default in giving such notice.
- (6) No Requirement for Pro Rata Redemption: Notwithstanding anything in these Articles to the contrary, any redemption of shares by the Company upon receipt of a retraction notice from any shareholder holding class A shares need not be made on a pro rata basis among every shareholder who holds class A shares.
- (7) Partial Redemption: If a part only of the class A shares represented by any certificate are to be retracted, then a new certificate representing the shares which are not to be retracted shall be issued at the expense of the Company.
- 27.7 Preferred Additional Rights and Restrictions: The class A shares have the following additional special rights and restrictions.
 - (1) Section 51, 85 or 86 of the Income Tax Act: The class A shares will only be issued as consideration for the acquisition of property by the Company in circumstances where the transferor of such property and the Company may have agreed to effect the transfer of such property pursuant to the provisions of section 51, 85 or 86 of the Income Tax Act.
 - (2) Aggregate Redemption Amount: The aggregate redemption amount of the outstanding class A shares at any particular time is the difference between:
 - (a) the sum of:
 - (i) the initial aggregate redemption amount of the class A shares issued in connection with a purchase and sale transaction to which section 51, 85 or 86 may apply will be the amount by which:
 - A. the aggregate fair market value of all the property acquired by the Company in the transaction to which section 51, 85 or 86 may apply and in respect of which the class A shares were issued,

exceeds

B. the aggregate fair market value of all the consideration (other than any class A shares in the Company or a right to receive any such shares) received from the Company by the transferor of such property,

as determined by the directors of the Company at the time of the issuance of the class A shares; and



 (ii) any subsequent increase to the initial aggregate redemption amount of the class A shares that the directors may, in accordance with the terms of any agreement between the Company and the holders of class A shares, determine from time to time;

and

- (b) the sum of:
 - the aggregate redemption amount of the class A shares that have been previously redeemed;
 - (ii) any subsequent decrease to the initial aggregate redemption amount of the class A shares that the directors may, in accordance with the terms of any agreement between the Company and the holders of class A shares, determine from time to time; and
 - (iii) the aggregate amounts previously paid by the Company on account of a reduction of capital of the class A shares as permitted by the Business Corporations Act.
- (3) Redemption Amount of Particular Share: The redemption amount of each preferred share at any particular time will be the quotient obtained by dividing the aggregate redemption amount for the class A shares at that time, as determined under paragraph 27.7(2), by the number of outstanding class A shares at that particular time.
- (4) Limitation on Issuance: Class A shares will only be issued in respect of a purchase and sale transaction to which section 51, 85 or 86 may apply if no other class A shares are outstanding in respect of any other purchase and sale transaction to which section 51, 85 or 86 may apply.
- (5) Paid-Up Capital: The paid-up capital of each class A share is its par value which is \$0.01 per share.
