Thank you and your members, along with many others, for sharing your concerns regarding the impact of COVID-19 on the hospitality and tourism sectors, and your perspectives on allowing for the purchase of liquor product at wholesale price.

Please know that government recognizes the impact that the COVID-19 pandemic is having on all British Columbians, including the hospitality sector. Together, we have worked to respond swiftly to support the Provincial Health Officer and Minister of Health in the sustained and effective response to this global pandemic. I know British Columbians—myself and my colleagues included—recognize restaurants and businesses for their contributions to this effort and are well prepared to support our local establishments in the economic re-start and recovery ahead.

As a result of our collaboration with the Business Technical Advisory Panel (BTAP) as industry advisors, our government was able to move quickly to support the hospitality sector as it worked to adapt to the parameters set out by the Provincial Health Officer. Among other measures, we introduced a regulatory change to temporarily allow all food-primary and most liquor-primary licensees to deliver sealed, packaged liquor products alongside the purchase of a meal.

Prior to the pandemic, government had been carefully considering and prioritizing recommendations made by BTAP, including potential changes to the wholesale liquor pricing model. The BC Liquor Distribution Branch (LDB) and ministry staff have worked as quickly as possible to prepare a plan, and work is ongoing. The implications of any and all BTAP recommendations must be, and will continue to be, considered in the context of overall provincial priorities including public health and safety.

I appreciate your taking the time to write, and invite you to share this letter with your members if you feel it would be helpful. Please let them know that government will do as much as we can to support the hospitality and tourism industries that have been so impacted by this crisis. We will be sure to notify BTAP, industry, and indeed all British Columbians of any additional relief measures made during this challenging time on an urgent basis.

BCWI CEO Update

Hospitality Wholesale Update

The Province has announced temporary wholesale pricing allowing hospitality liquor licensees (e.g. restaurants, bars and licensed tourism operators) to

purchase beer, wine and spirits at BC Liquor Stores (BCLS) and pay only the wholesale price - not the current wholesale price, plus a retail mark-up (estimated to be approx. 20%) set by the BC Liquor Distribution Branch (BCLDB).

The measure is meant to provide financial support for hospitality businesses in their COVID-19 recovery and will be in place from the end of July 2020 until March 31, 2021, when the program will be reviewed. See official announcement.

The BCLDB has <u>confirmed</u> the changes will take six to 12 weeks to complete, in two phases:

- By July 20, hospitality customers will be able to buy liquor through the BCLS at the wholesale price.
- Suppliers, manufacturers and agents that direct deliver to hospitality customers will also have to change their pricing model to sell at wholesale price.
- By September 1, hospitality customers will have access to the wholesale price list made available via an online hospitality portal.

IMPORTANT: Manufacturers deadline for making August (Period 5) wholesale price changes is this **Friday**, **June 19th**.

As announced last week, hospitality customers will be able to purchase liquor at the LDB Wholesale price beginning July 20, 2020. This temporary regulatory change – which will be in effect until March 31, 2021 – was approved to provide support to the hospitality operators (bars, restaurants, hotels, etc.) significantly impacted by the COVID-19 pandemic. To implement this change, the hospitality price, also known as LDB Established Retail price, will be updated with the new price equal to the LDB Wholesale Price effective July 20th in all systems and LDB pricelists. The Direct Sales Web Reporting application (DSWR) will also start using the new price for all hospitality sales effective July 20, 2020 to ensure consistency, accurate reporting and compliance in sales pricing in the industry. If by your manufacturing agreement you can free-price some of your sales to hospitality customers, you will continue to be able to do so and override the pricing in DSWR. All suppliers who sell directly to hospitality customers will now be able to control their hospitality price by adjusting the wholesale price. However the earliest price change can be in effect on August 2nd, 2020. Vendors, agents and manufacturers now have until 5 p.m. on June 24th, 2020 to make any changes to their wholesale price for Period 5, which begins August 2nd. 

Dear Miles Prodan:

Thank you for your email of July 14, 2020, sharing your perspective on government's decision to allow hospitality licensees to temporarily purchase liquor products at wholesale price.

Our government recognizes that the hospitality industry has been one of the hardest hit during the pandemic; more than 190,000 British Columbians who rely on this sector, directly or indirectly, have been impacted by the measures introduced to limit the spread of COVID-19.

Allowing hospitality licensees to purchase beer, wine and spirits at reduced cost will provide much needed financial support for businesses like restaurants, bars and tourism operators. This temporary measure will be in place from the end of July 2020 until March 31, 2021. During this time, government staff will conduct a thorough review of hospitality pricing to determine efficacy of the program, and will engage industry members such as yourself in the process.

In making this change, the BC Liquor Distribution Branch (LDB) considered the potential implications of publishing the prices of exclusive, direct-delivered products in the LDB Wholesale hospitality price list. After consulting with the British Columbia Wine Institute (BCW) and other members of the Business and Technical Advisory Panel (BTAP), LDB Wholesale omitted these items from the Hospitality Product Catalogue that went live on July 20, 2020.

The new temporary pricing model is just one of several changes introduced by government to help the liquor industry, which includes permitting wineries and other manufacturers to directly deliver to retail customers from their off-site storage locations, until October 31, 2020. This temporary measure aims to assist BC manufacturers to mitigate the negative economic impact of COVID-19.

Accelerated work continues on several other important BTAP recommendations that could also have positive impacts on businesses affected by the pandemic. The valuable collaboration of the BCWI will be sought and considered during these deliberations. The implications of any and all recommendations must be, and will continue to be, considered in the context of overall provincial priorities and impacts to the industry as a whole.

I appreciate your taking the time to write, and your continued engagement on BTAP.

I do understand that this hospitality price reform was not in the direct interest of the BCWI membership given a number of the concerns you have outlined in your correspondence;

however, I was very grateful to see BCWI support for this BTAP endorsed COVID-19 initiative regardless. I am sure that the BCWI realized, as government does, that BC wines and our tourism industry alike depend on a vibrant restaurant and hospitality sector. This sector desperately needs support right now. Thank you again for taking this global perspective and directly supporting our hospitality industry by doing so.
