Thanks for writing to me about the issue of money laundering in British Columbia. I was very glad to receive Dr. Peter German's full report into money laundering in April, and, after a necessary but lengthy delay, to release it to the public in late June.

The report, as you know, details the system-wide failure of regulation that enabled the laundering of in excess of \$100,000,000 of the proceeds of crime in BC's casinos, earning us international scrutiny as the home of the "Vancouver model" of money laundering.

Dr. German has set out more than 40 recommendations which government has accepted in order to ensure the public and the international community can have confidence in how we operate casinos in our province.

However, simply because his initial recommendations as implemented have reduced suspicious cash transactions by one hundred times, from a peak of \$20m in July of 2015 to \$200,000 in May of this year, the money has gone somewhere. In addition, we have concerns that there are similar activities taking place in our real estate market based on leads generated both by journalists and during Dr. German's review.

We are currently preparing terms of reference for a second, broader, review of money laundering allegations related to our real estate market. We are also expecting the results of two major police investigations into money laundering in the province over the coming months.

You have asked about the need for a public inquiry into this matter. The Premier has indicated that he is open to the possibility of a public inquiry if necessary to ensure accountability for activities that took place in relation to money laundering in British Columbia. He shares my concern that public inquiries can be too slow to catch up to fast moving crime.

To date we have continued to choose the approach of a public review that allows British Columbians to understand what is happening, but achieves speed and efficiency at the cost of making formal findings of fault. This enables us to move quickly on reforms to close the door on dirty money, but I understand your dissatisfaction with a process that doesn't permit the finding of fault. We will continue to evaluate the benefits of this approach against a process like a public inquiry that could lead to formal findings of misconduct as we continue this work.

Thank you for writing to me about this important issue. Our efforts continue to ensure that British Columbia is not a comfortable home for gangs and criminals to launder the profits of their crimes, and I greatly appreciate your support for this important work.

Okay, here's an update/explanation:

Facial recognition technology has been used at ICBC for several years. It's primary use is to detect impersonations by making sure the face in the most recent picture is not a duplicate of any ID already in the system. It isn't a retina scan.

ICBC's understanding is that he has not had a driver's license with them before. That would mean he isn't in the system and they wouldn't have something to compare to anyway. At this point he has a paper health card with his personal health number on it but ICBC does not think it can do anything more for him.

The identity proofing standards are not meant to be an inconvenience. Identity proofing is strict and uniformly applied because the BC driver's license has evolved beyond a mere licence to drive to become the de facto source of identification for many residents. It allows access to a range of benefits, from government assistance and programs, to credit and other services. It is taken as proof of residency in BC and authorization to be in Canada.

For those reasons, ICBC need to be sure the person receiving the DL has the correct foundation documents that prove their identity. For persons born outside of Canada, those foundation documents have to come from the Federal government as they would be the only ones to be able to vet the information. ICBC cannot be the one to establish a person's government identification as they don't have the skills or knowledge to confirm information from other jurisdictions.

Okay, here's an update/explanation:

Facial recognition technology has been used at ICBC for several years. It's primary use is to detect impersonations by making sure the face in the most recent picture is not a duplicate of any ID already in the system. It isn't a retina scan.

ICBC's understanding is that he has not had a driver's license with them before. That would mean he isn't in the system and they wouldn't have something to compare to anyway. At this point he has a paper health card with his personal health number on it but ICBC does not think it can do anything more for him.

The identity proofing standards are not meant to be an inconvenience. Identity proofing is strict and uniformly applied because the BC driver's license has evolved beyond a mere licence to drive to become the de facto source of identification for many residents. It allows access to a range of benefits, from government assistance and programs, to credit and other services. It is taken as proof of residency in BC and authorization to be in Canada.

For those reasons, ICBC need to be sure the person receiving the DL has the correct foundation documents that prove their identity. For persons born outside of Canada, those foundation documents have to come from the Federal government as they would be the only ones to be able to vet the information. ICBC cannot be the one to establish a person's government identification as they don't have the skills or knowledge to confirm information from other jurisdictions.
