“After the mismanagement of ICBC by the previous government that led to billion dollar losses, our government is requiring ICBC to be fiscally prudent before issuing rebates. That’s why we need to know more about how this fiscal year shakes out before making decisions on a rebate.

If ICBC does end up with a surplus as a result of the pandemic, combined with money saving reforms we have already implemented, we have passed a law requiring that surplus must be used to benefit drivers. It could be through a rebate, a capital build that helps keep future rates low, or some combination of the two.

This private insurance industry lobby group that says they’ll do a good job on car insurance in our province by theoretically providing rebates is the same lobby group that is trying to explain to British Columbians why strata insurance rates in our fully private market are climbing by 30% and more with no accountability. They’ll do no better on car insurance than they’re doing right now on strata insurance. Under our reforms coming in May of next year, drivers in BC will see some of the lowest rates and best benefits in the country.”

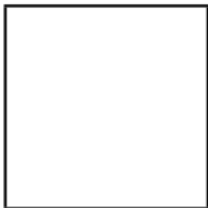
