#### Background

This is a follow-up to a media request from January 11, 2021.

### REQUEST:

I'm working on a story about a dispute between a landlord selling a home and a tenant unwilling to vacate the property. The closing date on the home is January 31, and it appears the dispute won't be resolved until well after that. The current owner is being told it may be March before a hearing can be scheduled. I am trying to track down details of the backlog at the RTB for eviction hearings and for direct orders for removal. How long does it take to get an eviction hearing/or a direct removal order? I would also like to know if this sort of dispute is tracked. How often do tenants hold up sales of

#### properties?

A woman who has tenants who weren't paying rent and it was going through the RTB but she couldn't afford the mortgage with the renters not paying so she was selling the house. The tenants made it difficult to get realtors and appraisers in, so a hearing has been scheduled for removal. From what reporter understands the hearing won't be until March but the closure on the sale is the end of the month. So the owner's concerned that this will affect the sale of her house. It's a whole house rental. And the buyers are buying it for their own use and intend to live in it.

Reporter thinks there are instances where a direct removal can be issued and there may be issues with COVID right now so it can't be done right now, and hearing is taking much longer than usual because of the pandemic.

Largely this is a story about bad tenants who are making this woman's life really hard but reporter would like to know if there's a larger issue with tenants not complying with orders or if there is a backlog of the RTB being able to deal with troublesome tenants or landlords.

#### **RESPONSE:**

#### **Provided Background**

- While the Residential Tenancy Branch (RTB) is unable to comment on specific cases, generally speaking when a tenanted home is sold the tenant is not evicted. Rather, the tenancy would be ported from one landlord to the next.
- However, in instances in which the new owner intends to use the rented space for their own use (or the use of a close relative), the new owners must provide two months' notice to the tenant before the eviction can take place.
- In many cases, displaced tenants would also be eligible for financial compensation paid by the landlord.
- The ban on issuing evictions for non-payment of rent ended August 18, 2020. This means that tenants must pay rent in full on the day it is due or they can be evicted.
- A landlord may issue a Notice to End Tenancy for unpaid rent or utilities if:
- o The tenant failed to pay rent that was due before March 18, 2020; or
- o The tenant fails to pay full rent due after August 17, 2020 (for most renters that would be September 1, 2020)
- A landlord must not issue a Notice to End Tenancy for unpaid rent or utilities that came due during the specified period of March 18, 2020 to August 17, 2020 unless the landlord has given the tenant a repayment plan for the unpaid amount and the tenant has defaulted on the repayment plan.
- If a resolution between the tenant and landlord cannot be reached, they may contact the RTB to schedule a hearing.
- The current waiting time to schedule such a hearing is approximately 13 weeks.

#### Recommendation - provide background

- Because RTB is only responsible for hearing disputes and rendering decisions (and not enforcement), we are unable to provide the data requested.
- We can confirm that wait times for hearings average 13 weeks and that decisions are rendered within 30 days.
- Once a decision is rendered it is the responsibility of the applicant to proceed with enforcement.



Dear Neighbour,

We wanted to inform you the Province is extending the lease for the Travelodge hotel, located at 123 Gorge Road East, Victoria, until December 31, 2021. We appreciate this is a change to our original plan to stop using the hotel when the lease was due to expire on March 31, 2021. This step is necessary to ensure that the over 90 current residents staying at the hotel are not displaced onto the street.

We want to reassure you that no new residents will move into the facility after the end of March and all residents will be transitioned to other housing options by the end of the year.

The Victoria Cool Aid Society will continue to operate the hotel as part of the lease extension, and the current Community Advisory Committee will remain active. We remain committed to working with the community to reduce any impacts on the neighbourhood. The health and safety of the building's residents is being improved through new fire upgrades and BC Housing is supporting these initiatives, including exterior clean-ups and landscape upgrades. The existing Travelodge resident clean teams will continue their work to help ensure the neighbourhood is clean.

BC Housing will continue to work closely with the City of Victoria and other community partners to investigate housing options as part of the ongoing housing strategy. Most recently, the Save-on-Foods Memorial Centre (SOFMC) temporary shelter was reactivated in partnership with GSL, providing 45-beds. The SOFMC is part of a partnership commitment to offer current campers in Victoria indoor spaces by March 31, 2021, in order to close encampments in the city's parks, including Cecilia Ravine. As these new spaces open, people experiencing homelessness will be offered housing options that meet their needs.

"We are looking into the issue of homelessness in Parksville and Qualicum Beach, and the lack of shelter options available for the community experiencing homelessness there.

I'm wondering if BC Housing can provide a statement as to what work the province has been doing in the community to ensure people have adequate shelter, where there are cold-weather shelter beds available in the Parksville-Qualicum beach area, and whether or not the availability of shelter beds meets the demand. I'm also curious about how many people you estimate to be unhoused in the area.

I'm also aware that Parksville Mayor Ed Mayne has been insistent that cold weather shelters and supportive housing is solely the province's jurisdiction, so if you can respond to that, that would be great.

#### Suggested Response: BCH provide background

Emergency Weather Response (EWR) shelters are a partnership initiative that is driven by the community. There are currently no EWR spaces in Parksville or Qualicum Beach. There are many reasons why a community may not have

an EWR, including limited non-profit capacity and reduced space capacity due to COVID-19 and physical distancing requirements.

However, BC Housing has secured 16 Emergency Response Centre spots in Parksville. These are leased spaces in a hotel where people who are experiencing or at-risk of homelessness can access shelter and physically distance during the pandemic.

The Province and BC Housing recognize the additional need for shelter spaces and will continue to work with community partners in the Oceanside community to find additional housing options. The homelessness crisis is a complex issue that requires coordinated solutions involving all levels of government.
