Richard,

On behalf of Cheryl and myself, **we wanted to confirm your support for the following actions being identified in the Declaration on the Rights of Indigenous Peoples Act Draft Action Plan and attributed to the Ministry.**

Cheryl and now I sit on the ADMs Reconciliation Table and have been asked to confirm DM support for actions previously identified. This is part of the process of preparing a 5 yr draft plan which will then be part of a broader consultation process with Indigenous peoples. The entire plan (attached for reference is the latest draft) is not being approved at this point. As you can see these actions reflect initiatives already part of the Ministry's work or accountabilities. Cheryl's team and JSB have been engaged and we see no issues.

We will sort out who needs to be listed first with PSSG on some of the items. To being cautious, we could ask that the highlighted item below be left with just MIRR.

Jessica Wood is looking for our confirmation so they can pull together the broader document – so if you able to confirm today that would be appreciated. I apologize for the timing but it something that got a bit lost in the transition.
