 - e. Advancing accessibility initiatives (e.g., home modifications)
 - f. Developing organizational strength and excellence
- 2. Opportunities to work together to improve accessible housing in British Columbia.

Key Messages:

- Building a Better BC for People with Disabilities is the provincial 10-year action plan to make BC more accessible for people with disabilities.
- BC Housing is anticipated to launch the BC Rebate for Accessible Home Adaptations Program in February 2021. This program will require an Occupational Therapist (OT) assessment for specific adaptations.
- The Province recognizes there is a need to create more options for those struggling to find safe, affordable, and functional housing that meets occupants' needs. This includes BC's most vulnerable who need intensive care and supportive housing.

BACKGROUND:

Canadian Association of Occupational Therapists – BC Chapter

CAOT-BC is a provincial chapter under the national CAOT that represents
occupational therapists at the provincial level by working with the provincial
government and local occupational therapist employers and funders.

British Columbia Building Code (BCBC)

- The 2018 BCBC is based on the 2015 National Building Code (NBC).
- The Province is committed to reducing building code variations to achieve consistent codes and standards throughout Canada.
- The BCBC provides the minimum requirements to make buildings accessible.
- In December 2020, the updated digital Building Accessibility Handbook was published to support code users to apply the BCBC accessibility requirements.

Housing Programs

 Housing programs and services for people with disabilities receive more than \$5 billion in funding each year. These programs are offered through government, crown agencies, and corporations.

DISCUSSION:

The Building and Safety Standards Branch is collaborating with the Federal Government and inter-ministry partners, including the Accessibility Secretariat to ensure the next edition of the BCBC will make new buildings more accessible for all people.

Government is making an historic investment of \$7 billion over 10 years to build 36,900 units of affordable housing. More than 23,000 of these new units are now open, under construction, or in the approvals process, in nearly 90 communities across the province.

The Community Housing Building BC – Community Housing Fund facilitates the development of mixed income, affordable rental housing projects across all regions of the province. Persons with disabilities are identified as a priority target group of this program.

BC Housing has redesigned and rebranded the program formerly known as the Home Adaptations for Independence as the BC Rebate for Accessible Home Adaptations Program (BC RAHA), which will be launched in February 2021.

The BC RAHA offers a maximum lifetime grant of \$17,500 for a qualifying household/unit, with no cost-share requirement. The program is income-tested, based on BC Housing's low- and moderate-income limits.

Maximum rebates are available for the most common types of accessibility adaptations, ensuring that applicants receive equal funding for the same types of adaptations. Only adaptations not on the program schedule will require an estimate.

Under the new program, an OT assessment will be required for certain adaptations. Applicants who pay for a private OT assessment will be given a rebate to help cover the cost.

Accessibility requires a holistic approach that considers many diverse needs to make BC more inclusive for everyone.
