When I inspected the documents, they were public court lists, blank forms, old CLE pages (these are public – mostly about proper wording of orders), two sticky notes that contained an employee's first name and a note (the note did not contain client information), a photocopy of a marriage certificate, and a court list that had counsel work email addresses (which can be searched via an internet search).

It appears that that some court documents that had been placed in individual recycle bins had been emptied into our trash bin rather than the confidential shredding bins. We have followed up with our janitorial services to ensure the contents of individual recycle bin are not emptied and the staff will be reminded that they must ensure documents are placed in the secured shredding.

We have spoken with the janitorial group and we will be addressing this with the staff. Alvin are there any other steps that I should be taking?

s.22 Lately, the access to new lawsuits has

been delayed by up to three weeks, which is extremely concerning. What used to be a routine, basic, daily event allowing next-day access to the court's daily business, the delays have been getting worse and worse. The "small fee" is not small when we're talking about hundreds of files that are being arbitrarily withheld from the media for weeks at at a time, subject to the registry's whim, or "operational constraints." My company, Courthouse News, has run into similar issues in other courts, including in California, where we've litigated the issue of "no-access-before-process" policies. A ruling from the 9th Circuit Court of Appeals can be read here:

https://cdn.ca9.uscourts.gov/datastore/opinions/2020/01/17/16-55977.pdf

I'm aware that the pandemic has created a number of challenges for court registries, but mitigation efforts should not come at the expense of timely, routine disclosure of public interest information. We're literally talking about moving a stack of files from one side of a room to another, with no operational resources needed other than someone to move them on a daily basis from one desk to another.

I've been in nearly constant communication with registry leadership about the issue, and am happy to share any past correspondence to give the CSB more context about my ongoing struggle to ensure and preserve the court's tradition of access granted to reporters.

Thank you for your email of May 12, 2021, addressed to the Honourable David Eby, Attorney General and Minister Responsible for Housing, regarding court delays and facility concerns at the Vancouver Law Courts and the New Westminster registry. I am responding in my capacity as Assistant Deputy Minister of Court Services Branch.

I am sorry to hear that your recent experience at the New Westminster court registry was a negative one. Court Services Branch (CSB) is committed to ensuring barrier-free access to courtrooms and court services across British Columbia. Senior staff at the New Westminster court registry have confirmed that a chair is often present at the location that you have described. Please note that due to COVID-19 protocols seating has been reduced at this registry. Because of this reduction, members of the public do, on occasion, move chairs for their convenience. There are no plans to permanently remove chairs from this section of the New Westminster registry. If you attend this registry in future and find that a chair has been moved, staff will be happy to assist you in locating and moving a replacement.

CSB is committed to ensuring adequate resources to manage the justice system, reduce delays, and improve the timeliness of court matters. As courts gradually increased in-person appearances and opened registry services in the summer of 2020, there was a significant volume of information to be data entered that staff continue to work through. Processes have been put in place to manage this data entry backlog. It is anticipated that the service, and access to information, that you were accustomed to prior to the pandemic will once again be achieved.

Additionally, in order to reduce potential barriers to court access, the Vancouver Law Courts provide a free media table, allowing daily access to new files once they have been created. If a new civil file is no longer available on this table, it can be accessed through the registry's records department for a small legislated search fee. This table operates as a courtesy to members of the media and is subject to operational constraints. Please rest

Hi Angela,

The court clerks have brought the below email to our attention. In reading the email it appears their main concern is judges allowing parties to remove their masks in the courtrooms. I feel their concerns were probably amplified with the email they received from the union (below) concerning airborne particles. The court clerks are also asking for an opportunity to have an open discussion with the judiciary about requiring masks in the courtrooms. I have reached out to Brad Buck, Director of Safety, to see if he had any recent comments or insight into the information the union sent out to employees regarding airborne transmissions.

Brad was aware of the union email and indicated that the information around aerosols and airborne particles has not really changed since last year and that all our safety protocols in place should prevent any transmission of COVID in the CR. Brad suggested however, I speak to David Hay from PSA who is very involved with COVID health and safety in the workplace.

In speaking to David, he provided me with a lot of information around airborne transmission and re-assured me that in addition to all of our safety measures in place -health checks, distancing, plexi, handwashing, masks, and ventilation, the clerks are at a low risk of contracting the virus and should be protected even if someone removes their mask. He did say however, that unless there is a valid reason to remove the mask they should remain on in the CR. David has had considerable involvement with the courts and judiciary around COVID health and safety protocols and he added that being a clerk can be stressful and to have to worry about someone not wearing a mask is adding stress to their day. I can say that recently we had an incident where masks were not always being worn by parties in the CR and one of the parties tested positive for COVID. Another recent occurrence was in a CR where masks are not always worn and one of the counsel was informed in the morning their sibling who they are in close contact with tested positive for COVID. Instead of standing the case down, the judge allowed the counsel to remain and had them sit in a separate area. These are just a few recent incidents that the clerks have brought to our attention.

David also referred me to the recently updated FAQ's. In particular #25 and #26 which speak to airborne transmissions and ventilation. I have attached these above.

I am not sure what the next steps should be regarding the court clerks request to meet with the judiciary and wanted to seek your input as this maybe something you want to discuss at the executive table or with the ADM. I am prepared to meet with the clerks to discuss the information provided by PSA on airborne transmissions however, I don't know if it

will completely alleviate their concerns about judges allowing parties to remove their masks. I do not have numbers on how many judges are allowing mask removal however, I can say we also have a number of judges who are very diligent in ensuring parties keep their masks on when in the CR.

Thanks for your assistance with these concerns.

As the COVID-19 pandemic continues, our understanding of the virus is rapidly evolving. It is now widely recognized that airborne transmission of SARS-CoV-2 can occur under certain conditions. The Public Health Agency of Canada (PHAC) recently updated its guidance to acknowledge that SARS-CoV- 2 is spread through aerosols (smaller droplets that can hang in the air for periods of time). Further, PHAC has updated their guidelines for Long Term Care Facilities and Home Care settings to include guidance on ventilation at these worksites to control for airborne transmission of the virus.

We are in the third wave of the pandemic. While case counts are starting to decline, hospitalizations due to COVID are at an alarming high, largely due to the increase in the presence if variants. In light of these developments, and in keeping with the precautionary principle and best practices, we encourage all workplaces to review your COVID-19 Safety Plan (CSP) with a specific eye to airborne transmission and ventilation needs.

To assure the most up-to-date practices are in place, employers must fully and seriously consider the risk of airborne transmission of COVID-19 in their worksites. This includes re-evaluating processes that require close contact with high-risk individuals. The CSP should be updated as needed, taking into account the variants as a higher risk, with the hierarchy of controls in mind⁴:

- The most effective control is to allow for remote work or other alternative work arrangements that minimize the number of workers and the number of customers and clients at a given workplace, and this should be implemented wherever possible.
- Where workers are required to attend the workplace, the employer must ensure that additional measures are implemented to minimize risk, and that their effectiveness is monitored. This includes looking at:
 - Effectiveness/efficiency of ventilation in enclosed spaces (<u>for best practices click here</u>)⁵;
 - Minimizing occupancy limits in areas where people may congregate;
 - Limits to the duration of close contact with other individuals where possible.
- These measures should also be applied as much as possible where workers are attending clients' homes. Risk assessments and direction from your supervisor must take into account any additional risks due COVID-19.
- Travel between health regions for work should be limited as much as possible. This includes where community health workers are performing home care visits.
- While Personal Protective Equipment (PPE) is the least effective measure to
 protect workers, following the Hierarchy of Controls, throughout the pandemic
 BCGEU has consistently advocated for the appropriate usage of masks,
 both indoors and in public spaces. As such, we recommend that where
 workers are required to be at the workplace, that:
 - Appropriate, high quality masks, and training on their use be provided to workers by the Employer.
 - Employers should have a policy and safe work procedures for interacting with customers, clients and others that require masks when they are interacting in-person with workers.
 - For interactions with clients who are considered exposed to, or suspected or confirmed to have COVID-19:
 - PPE consistent with a **minimum** of Droplet and Contact Precautions (e.g., gloves, a gown, a medical mask and eye protection) should be worn.
 - An N95 or equivalent respirator be worn in place of a medical mask where possible.

As a worker, you have rights under the Workers Compensation act⁶:

The Right to Know about all known or foreseeable health and safety risks;

- The Right to Participate in your workplace OHS program: this applies to all workers, not just OHS representatives;
- *The Right to Refuse Unsafe Work: Please see the refusal procedure here 7;
- And your have the Right to Protection against Prohibited Actions. This means you cannot be punished for raising health and safety issues in the workplace.

 - The court clerk and sheriffs staff that were directly involved in the situation will also receive support from VPD Victims Services, if they choose.

Subject: Executive Update from Lori Wanamaker: B.C.'s Restart Plan and the BC Public Service



B.C.'s Restart Plan and the BC Public Service

Good afternoon.

Today, the Premier announced <u>B.C.'s four-step plan</u> to guide the province out of the pandemic over the months ahead. As we start to see the positive impact of the vaccination campaign, this is an encouraging step and gives us all some confidence that we can look forward to a more positive summer if we all continue to do what's asked of us for just a little longer.

For the BC Public Service, the restart plan does not mean any immediate change in how we are working. While the Provincial Health Officer is lifting the recommendation to work from home, if you have been working remotely you can continue to do so at this time. If you choose to return to the workplace, you can do so. Note that existing safety protocols remain in place and must continue to be followed until further notice.

Assuming the pandemic outlook and the restart plan progress as anticipated, we will look to the start of Step 3 of the plan as a transition point for the public service. The restart plan has July 1 as a target date for Step 3, and at this point we will encourage employees to return at least part-time on a voluntary basis through the summer. We will communicate more about this transition prior to July 1, but to be clear we do not plan to require a return to the workplace at this time. The BC Public Service Agency will work with ministries to ensure workplaces are ready and able to accommodate those who return, adapting our safety measures where needed to remain aligned to updated public health and WorkSafeBC direction in the weeks ahead.

The restart plan for Step 3 anticipates workplace capacity limits being lifted on July 1, meaning we could welcome back everyone to their regular workplace. But we are choosing to take this voluntary approach through the summer while we finalize a new long-term model for how we work.

We have been working during the unique circumstance of a public health emergency since March of last year. While it has been a prolonged experience, it was always temporary and it appears we are finally nearing the end. Along the way, we have learned a great deal about the flexibility and resilience of the public service. The priority for the BC Public Service as an employer now is to draw on those lessons – including the experiences many of you have shared with us – to shape a sustainable model for how we work that effectively balances

our obligations to the public, our accountabilities as an employer, and our desire to offer a positive employee experience.

We are aiming to introduce this new model in time for the planned transition to Step 4 of the restart plan in early September. If you haven't already done so, I encourage you to participate in the <u>online engagement activity</u> underway until the end of this week. It has been great to see the level of participation to-date and there are still a few more days to review and rate the many thoughts and ideas shared by colleagues across the public service. This will help inform the approach we take for the fall and, again, you can expect further updates between now and September.

Beyond the impact to how we work, I know the restart plan also has significant implications for so many of you in supporting communities and stakeholders in the months ahead. This is the next step in a remarkable cross-government effort by the entire public service since the onset of the pandemic. Your efforts are deeply appreciated by our entire executive team and by government. Thank you for continuing to demonstrate the true strength, resilience and professionalism of the public service for the benefit of all British Columbians.
