# ISSUE:

In accordance with section 6 of the *Administrative Tribunals Act* (ATA) the Chair of the Surface Rights Board (SRB) must consult with the Minister before making a temporary 6-month term appointment.

# **DECISION REQUIRED/ RECOMMENDATION:**

Agree to support the SRB Chair's request to appoint Cheryl Lynn Vickers as Vice Chair, and Erin Lan-Ying Frew, Zahra Hassan Jimale, and Dale B. Pope, QC (full legal name) as members to the SRB for a six-month term to uphold existing service standards.

# **SUMMARY:**

# Introduction: Cheryl Vickers, Dale Pope, Erin Frew and Zahra Jimale

I am submitting a request for Cabinet consideration to appoint four qualified candidates as Vice Chair and Members to the Surface Rights Board ("Board"). Cheryl Vickers is requested for a re-appoint as Vice Chair, and Dale Pope, Erin Frew and Zahra Jimale are requested for re-appointments as Members; all per s. 6 of the Administrative Tribunals Act ("ATA").

# Background

As you know, the Tribunal is managing a three-fold increase in complaint volume. Among other things, this has resulted in a substantial backlog at all stages of our process, including hundreds of unassigned applications awaiting member decision. At the same time, we are working to implement standardized systems to more efficiently and accessibly manage all aspects of the Tribunal's workflow, including the assignment and output of decisions for members.

The Tribunal is in the process of onboarding new tribunal members following a competition. In the meantime however, the Tribunal needs experienced members who can quickly move through interim procedural issues while also issuing more complex interim decisions without the need for training. The Tribunal onboarded a former Tribunal Member, Marlene Tyshinski, last year for this purpose. She worked together with a dedicated Case Manager to develop an efficient system for managing COVID-related complaints, which accounted for roughly 30% of the Tribunal's volume increase. # **SUMMARY:**

- On September 16, 2022, LABC provided Ministry staff with their monthly budget forecast which included s.17 for fiscal 2022/23.
- In alignment with the Memorandum of Understanding (MOU) between the BC Government and LABC, the MAG/LABC Working Group have discussed s.13; s.17

#### **BACKGROUND:**

- Section 18 of the Legal Services Society Act states that LABC must provide a budget for the Attorney General's approval when directed.
- Each year, the Attorney General sends a letter to the LABC Board Chair outlining the approved budget for the year and requesting a comprehensive Budget Management Plan (BMP). Some of the key elements in this plan include:
  - A proposed allocation of the approved budget across tariff services and administrative expenditure categories (e.g. departmental budgets, capital and amortization forecast, technology spending);
  - A detailed listing of all LABC programs with costing for each;
  - A forecast of caseload volumes for the year (i.e. estimated legal aid applications/contracts); and
  - A budget pressure mitigation plan with options to manage any pressures, giving priority to tariff services ahead of ahead of administrative spending.
- Once approved by the Attorney General, the BMP sets the foundation for all budget management activities and the MAG/LABC Working Group (composed of staff from the Ministry and LABC) monitor any service delivery or budget related issues throughout the year.
- The role of the Working Group and its budget management related procedures are detailed in the MOU; this includes providing direction for how the Working Group should engage "if, in any fiscal year, it appears that a deficit or a surplus is likely to result from the provision of provincially funded services".

# **DISCUSSION:**

LABC had struggled for many years with a lack of funding and with a shared objective to improve access to justice, the BC Government has provided significant funding increases in recent years to help restore services cut by the previous government with a total increase of \$40.297M over LABC's 2016/17 budget; This includes an increase of \$7.469M in fiscal 2022/23 alone.

- However, the COVID-19 Pandemic and the associated court slowdowns have continued to impact the demand for legal aid services.
- On September 16, 2022, LABC provided Ministry staff with their monthly budget forecast which included the following details:
