And, lastly, all engagement activities must be completed by September 30, 2023.

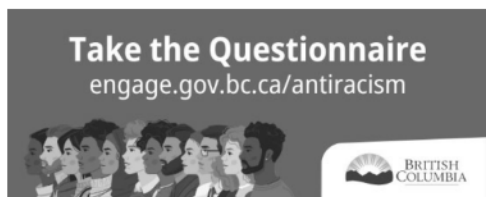

The in-person session will be about 3 hours and hosted in a space to allow assembly in a circle and in small groups. The facilitators, 2 or more BIPOC youth aged 18-30, will present the ground rules for discussion and establishing a culturally safe experience. A quiet support room with a trained trauma-informed professional will be available. The facilitators will initiate a larger group discussion based on guiding questions relevant to anti-racism legislation and climate and environmental issues. Following a break, we will regroup into smaller, facilitator-led discussions. Each breakout will receive a discussion question related to the larger group questions. Following this, the group will regroup in the circle and share what was discussed.

The online session(s) will last for approximately 2 hours in a webinar format with a panel and input from the participants gathered via chat, questions, and other comments during the call, and via email and a short survey afterwards. The panel will be made up of a moderator and 2-3 BIPOC youth who will share their experiences, answer questions, address comments, and reflect on learnings from the first session. At the onset of the session, the moderator will cover ground rules to create a culturally safe and accessible experience for everyone.

We will advertise both sessions via our social media (Instagram, Twitter and Facebook) and email newsletter. We will also conduct outreach within our current circles of BIPOC youth, including asking our existing Justice, Equity, Diversity and Inclusion (JEDI) Advisory committee members. We will also reach out directly to BIPOC and LGBTQ2S+ organizations that work with youth.

These sessions will be free to those who attend. Participants in the in-person event will receive an honorarium of \$50. The venue will be selected for physical accessibility. Space will be provided to leave and receive support if the discussion becomes overwhelming or distressing. Participants will be asked to fill out an accessibility form to ensure that other barriers to participation will be addressed, and reasonable accommodation will be provided.

Organization Capacity

Be the Change currently has 13 staff members, including summer program assistants who are able to work on an engagement project. Be the Change continually engages teachers and students around our work in various ways. We run multiple workshops and Professional Development trainings throughout the year to thousands of participants. In 2021-22, we produced a climate

education reform survey to inform the development of a provincial-wide network of students and educators in order to leverage their actions in a collective way. This survey was distributed to over 2,000 teachers in the province via email and advertised via social media. The budget for this project was \$2,000 and was funded through individual donors. We received over 350 responses to this survey, which exceeded our expectations for responses. Because of COVID-19, the choice was made to only engage via an online survey as opposed to in-person focus groups.

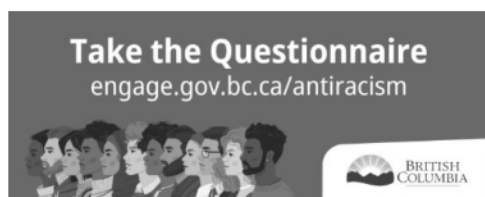

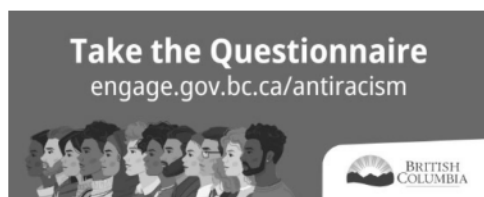

For this project, we plan to conduct 10 engagement sessions/activities, using a practical approach to combine face-to-face outreach and online engagement. We will use both Mandarin and Cantonese to facilitate targeted groups to inform the anti-

racism legislation and policy related to systemic racism in government policies, programs, and services.

We will work with the ministry and a lead engagement consultant in a coordinated manner to achieve the goals of encouraging and supporting community members to respond to the online Anti-racism legislation public questionnaire. Our 10 planned engagement sessions and activities will include,

- 2 Zoom calls: to raise awareness and encourage audiences to take part in the online questionnaire, with a special focus on senior citizens, and youths with who we have previous close engagements.
 - 2 Focus Group: to offer face-to-face outreach about the engagement, and to provide mobile devices for respondents to self-complete the questionnaire.
 - 3 Social media promotions: to disseminate information about the benefits of responding and partaking in the engagement, and to assist in building trust and marketing the online responses to increase participation, with hyperlinks to the questionnaire site.
 - 3 promotion booths in the public space: to offer face-to-face engagement, and to provide tools for respondents to self-complete the questionnaire.
- Phone calls will follow up when necessary

Through these outreach activities, we expect to enroll 300 attendees who will provide their input in the questionnaire.

Stop Anti-Asian Hate Crimes Advocacy Group Association of Canada (SAAHCAG) is a community organization to promote social harmony, fight racism, and build connections in Canada. It is incorporated in B.C., as a not-for-profit and non-partisan association of Canadians with Asian heritages.

As a newly established community organization emerging in response to the rising of anti-Asian discrimination and racism during the COVID pandemic. It had started operating and organizing activities in line with its mandate, despite the formal incorporation being completed in Dec. 2021.

Since its founding, the SAAHCAG has been active in engaging the Asian communities and delivering events in line with the mandate and objectives of the organization, for example:

- We have successfully hosted, 60 online public lectures, 16 community events, and 8 in-person youth civic engagement programs. One of the community events was a one-day summer "Concert in the Park", with over 1,300 attendees.
- We have successfully raised over \$60,000 from community donations;
- We have 20-plus regular active volunteers supporting various activities of the organization;
- We have a focus on the Chinese community and an extensive connection with Asian communities at large; and
- We have been recognized as a significant community contributor in BC, including a nominee for the Breaking Barriers Award

of BC Multiculturalism and Anti-Racism Award 2022 and 2023 from the BC Government.

This year, we won the BC Multiculturalism and Anti-Racism Grant of \$5000 to run a project to showcase the community's efforts in promoting inclusion and equality and fighting anti-Asian racism.
