# Re: Freezing contracting out until Democratic TransLink Board in place

The HandyDART Riders' Alliance would like you to return TransLink to local democratic control as soon as possible. The Request For Proposals (RFP) for the long-term contracting out of HandyDART must also be put on hold until TransLink has a new board. We wish we could give you more time to become familiar with your new position, but this is an urgent issue that cannot wait.

The existing TransLink board and management (apparently micro-managed by BC Liberal Government political staff) has chosen to push ahead with a rushed RFP to contract HandyDART out for a *minimum* of 3-5 years.<sup>12</sup> This would mean being locked in to contracting out, likely to a multinational corporation, for practically the full term of your government. We see the poor quality of HandyDART service

associated with contracting out as a serious human rights violation, and filed a human rights complaint against then Premier Clark.<sup>3</sup>

We requested that TransLink do a Multiple Accounts Evaluation of bringing HandyDART in house. But the process was aborted and no Multiple Accounts Evaluation (MAE) report was ever completed, even though the financial analysis clearly states that it is intended to be only one component of a MAE.<sup>4</sup> The Public Sector Comparator was never completed as designed, and a new board may well want to see this work completed with quality of service and safety taken into account.

On June 23 we spoke to the TransLink Board and asked that they put the RFP process on hold until a party had won the confidence of the Legislature and could appoint a Minister. Instead, days after the NDP won the confidence of the Legislature, TransLink issued a RFP for HandyDART "Call Centre and Passenger Trip Delivery" with a closing date of September 7, 2017.

The present TransLink Board are de-facto BC Liberal Party political appointees, who seem to just rubber stamp the decisions made by the Liberal Minister and their political staff. We do not have any confidence in this board.

We understand that your government may want to take the time to thoroughly review the whole mandate and governance of TransLink, and that this could take considerable time. However, we urge you to restore majority control of the

TransLink board to elected Mayors and councillors as soon as possible (even if this is an interim step in a longer process).

Will you instruct TransLink to put this RFP on hold until an elected TransLink board is in place? And will you expedite the process of re-establishing a TransLink board with a majority of local elected representatives?

I am forwarding this email to you as I understand you are the parliamentary secretary in charge of Translnk.

I have a 10 document body of evidence to support our community's request that 216 from Hwy 1 to 88 not become a truck route . Our local government has put this request forward much to the outrage of the residents that will be affected . I have two letters from Dr. Christopher Carlsten whereby he it is his expert opinion that this will create a real threat to human health . Then there are the Develop with Care Guidelnes recommending a very large buffer zone in the case of heavy traffic / truck traffic . We will have NO buffer zone . There is the opinion of Graeme Cross who is a senior engineer with MOTI that 216 should be limited to local traffic only .. this was obtained through a FOI request if you would like the document . I also have a letter form the president of the Francophone Schools of BC asking that Dr , Car;sten's opinion be honored . He is asking for a HIA as the certificate being used for this project is 10 years old and was not done anywhere near the schools in question . One of the schools being impacted is L'Ecole Des Voyageurs . Keep in mind that diesel exhaust is 100 x for toxic than gasoline exhaust .

As per my previous email dated June 27 here are the signatures and petitions I refer to regarding our community's opposition to a truck route from Hwy 1 north to  $88^{th}$  ( see scanned documents ) We have 1724 people opposed to this part of 216 becoming a truck route . I am happy to send you any documents as referred to as our growing body of evidence that you may want to examine .

We have been engaging with the MOTI. Now the new BC Government is formed we will continue to engage with them. The community of Walnut Grove in north Langley respectfully requests you do not provide funding to our Township at this time. We ask that this decision wait until the new ministers are announced and we are able to engage with them specifically the Minister of Transport, Claire Trevena.

Semis travelling within 25 ft of elementary and preschools as well as homes in not in keeping with Health Guidelines . Our concerns are air and noise pollution . One heavy truck's noise = 32 cars .. enough to cause hearing loss over time as well as other health issues .

We therefore ask that you wait until such time as our community is able to proceed and interact with the provincial government before funding this potentially harmful development. As you can see by reading Dr. Carlsten's recent letter his concerns regarding this project and its health threats have increased. I also welcome Translink to further engage with him should you require additional information supporting the threat trucks will present to the health & safety of our community especially the school children.

We will be requesting the Ministry re-examine the project as it stands and will be asking for a health impact study as Dr. Carlsten's recommends. We will also be asking the new government to re-examine the timeline for 192 north westbound as a truck route. This location will not have the health impacts associated with 216 north. There is also the idea of improvements to the 200<sup>th</sup> St interchange to make it more effective for truckers. 1. It is sinking 2. There are rapid cycling traffic lights allowing one truck at a time through. 3. The westbound part of Hwy 1 leading to this has a dip and hill that creates problems for truckers as it makes their engines work very hard thereby using more fuel. I can provide you with more information as I have obtained this information by consulting with truckers.

Should you wish to visit the site to actually see how close the road will be to the schools and homes, parks and playgrounds I am happy to meet with you. We are asking for sustainable development and sadly a truck route at this location does not offer this. If we had the recommended buffer zone I would not be writing to you as our community would be safe and protected. Local commercial vehicles as usual are welcome.

Title: HandyDART Service

**Issue:** The HandyDART Riders' Alliance's request that the Request for Proposals for the delivery

of HandyDART transit service recently issued by TransLink be placed on hold.

#### **SUMMARY:**

 MVT Canadian Bus is a contractor that provides HandyDART service in Metro Vancouver on behalf of TransLink. This contract expires in June 2018.

- The HandyDART Riders' Alliance believes that service would be improved if TransLink delivered HandyDART services directly, as it does with SkyTrain and the broader bus network, rather than through a contractor.
- TransLink worked with stakeholders in 2016-17, including the HandyDART Riders' Alliance, to complete a review of HandyDART policies and operations.
- TransLink is now seeking a contractor to provide HandyDART service for 2018 to 2020. A
  Request for Proposals was issued on July 4 and closes on September 7.
- The decision to issue the Request for Proposals and the responsibility for the delivery of the HandyDART service rests with the TransLink Board of Directors.
- One of the government's election commitments was to "... work with TransLink and BC Transit to find long and lasting solutions to improve HandyDART service, reduce trip denials, and ensure that seniors and people with disabilities get the rides they need".
- Ministry staff are taking the following actions:
  - preparing the attached response letter to the Riders' Alliance for the Minister's review (see Attachments A and B); and,
  - engaging with the Ministry of Transportation and Infrastructure (responsible for BC Transit) in order to prepare a summary for the two Ministers' consideration on actions that could be taken to fulfill the election commitment.

## BACKGROUND:

HandyDART is a door-to-door, shared ride service for passengers with physical or cognitive disabilities who are unable to use conventional transit services without assistance. The service is offered 365 days per year. It is provided through TransLink in Metro Vancouver and BC Transit in the rest of the Province.

TransLink provided 1.1 million HandyDART trips in 2016. As part of Phase One of the Mayors' Council Vision, TransLink will be offering an additional 85,000 trips in 2017, with a further 86,000 additional trips by 2019 (a total increase of 15% over three years). The Vision calls for a further 15% service increase (over 2016 levels) during the 2020-2026 period.

The HandyDART Riders' Alliance (Alliance) is a group of HandyDART riders and stakeholders advocating for better HandyDART and accessible transit service in Metro Vancouver. The Alliance recently launched a human rights complaint against TransLink and the Province, alleging discrimination in the form of inadequate HandyDART service. s.13



In June 2016, at the direction of its Board of Directors, TransLink commenced a review of HandyDART operational policies and service structure to address customer concerns. The goal of this review was to provide recommendations to TransLink's Board to improve service quality and responsiveness and make the best use of all of TransLink's accessible transit services.

Working with a Stakeholder Advisory Committee composed of HandyDART customers and advocates, including the HandyDART Rider's Alliance, TransLink identified key policy areas for change. The consensus recommendations resulting from this review were endorsed by the TransLink Board on March 30, 2017. A summary of the recommendations and their current status are included in Attachment C.

The HandyDART service is primarily provided through a contractor with service quality standards specified by TransLink in the contract. (This is augmented by the use of taxis for approximately 11% of trips.) The current contract with MVT Canadian Bus was recently extended by six months and now expires on June 30, 2018.

#### DISCUSSION:

On July 4, 2017 TransLink issued a Request for Proposals (RFP) for "Custom Transit Services – Call Centre and Passenger Trip Delivery". The RFP is open until September 7, 2017. The proposed operating agreement is for an initial term of three years with two options to extend, each for a period of one year.

The Alliance argues that the delivery of the HandyDART service by a contractor results in a poorer quality of service than would be the case if it was delivered directly by TransLink and that the RFP is being "rushed out the door". The Alliance is now requesting that the Province instruct the TransLink Board to put the RFP on hold until an elected TransLink Board is in place. (The Alliance's letter and a draft response e-mail to the letter are provided as Attachments A and B.) The letter also addresses the Alliance's concerns about TransLink's governance.

TransLink has already acted on the recommendation to bring the customer relations functions in-house. The HandyDART contract extension was intended to provide TransLink with additional time to receive and evaluate RFP responses. This will enable them to validate some of the findings that emerged during their review process regarding the costs for providing some aspects of the HandyDART service (e.g. service delivery through a single turn-key service provider vs multiple providers or even bringing the service inhouse). This extension will also allow more time to ensure a smoother transition to a new call centre (either contracted or in-house) and ride delivery service provider(s) should that be the outcome of the RFP process.

While the Province does not have a role in operational TransLink issues such as the timing of issuing RFPs, government has committed to working with TransLink and BC Transit to find long and lasting solutions to improve HandyDART service. The platform document committed to "... work with TransLink and BC Transit to find long and lasting solutions to improve HandyDART service, reduce trip denials, and ensure that seniors and people with disabilities get the rides they need".

In addition, when Premier Horgan met with the Metro Vancouver Alliance, he committed to provide funding through a special grant to increase HandyDART service hours by 20% over four years for all TransLink and BC Transit HandyDART services. TransLink's 2017 HandyDART operating budget is \$51,778,449.s.13,s.17 s.13,s.17



To start this process, the Ministry proposes to collaborate with Ministry of Transportation and Infrastructure staff to jointly develop a summary of actions for the two Ministers to consider that could fulfil the government's commitment for HandyDART services delivered by TransLink and BC Transit.

# Re: Freezing contracting out until Democratic TransLink Board in place

The HandyDART Riders' Alliance would like you to return TransLink to local democratic control as soon as possible. The Request For Proposals (RFP) for the long-term contracting out of HandyDART must also be put on hold until TransLink has a new board. We wish we could give you more time to become familiar with your new position, but this is an urgent issue that cannot wait.

The existing TransLink board and management (apparently micro-managed by BC Liberal Government political staff) has chosen to push ahead with a rushed RFP to contract HandyDART out for a *minimum* of 3-5 years.<sup>1 2</sup> This would mean being locked in to contracting out, likely to a multinational corporation, for practically the full term of your government. We see the poor quality of HandyDART service associated with contracting out as a serious human rights violation, and filed a human rights complaint against then Premier Clark.<sup>3</sup>

We requested that TransLink do a Multiple Accounts Evaluation of bringing HandyDART in house. But the process was aborted and no Multiple Accounts Evaluation (MAE) report was ever completed, even though the financial analysis clearly states that it is intended to be only one component of a MAE.<sup>4</sup> **The Public Sector Comparator was never completed as**

designed, and a new board may well want to see this work completed with quality of service and safety taken into account.

On June 23 we spoke to the TransLink Board and asked that they put the RFP process on hold until a party had won the confidence of the Legislature and could appoint a Minister. Instead, days after the NDP won the confidence of the Legislature, TransLink issued a RFP for HandyDART "Call Centre and Passenger Trip Delivery" with a closing date of September 7, 2017.

The present TransLink Board are de-facto BC Liberal Party political appointees, who seem to just rubber stamp the decisions made by the Liberal Minister and their political staff. We do not have any confidence in this board.

We understand that your government may want to take the time to thoroughly review the whole mandate and governance of TransLink, and that this could take considerable time. However, we urge you to restore majority control of the TransLink board to elected Mayors and councillors as soon as possible (even if this is an interim step in a longer process).

Will you instruct TransLink to put this RFP on hold until an elected TransLink board is in place? And will you expedite the process of re-establishing a TransLink board with a majority of local elected representatives?

# **Attachment C: HandyDART Service Review and Current Status**

## **HandyDART Service Review**

There are five functions of HandyDART service delivery:

- 1. Registration: Application review and assessment, registration functions.
- 2. Customer Feedback: Responding to customer complaints and commendations.
- 3. Call Centre: Reservations, scheduling, dispatching, and responding to same-day issues.
- 4. Delivery rides: Operating dedicated HandyDART vehicles and non-dedicated vehicles
- 5. Assets: Owning and maintaining fleet and facilities.

HandyDART service is delivered under a 'turn-key' contract. While TransLink's subsidiary Coast Mountain Bus Company (CMBC) undertakes the registration function and TransLink owns or leases the assets, the remaining functions are delivered by MVT Canadian Bus Inc., under contract to TransLink. This model and contract have been in place since 2009. Prior to 2009, the service was delivered by eight different organizations (a mix of private and not-for-profit). Excluding registration, the functions of HandyDART service have never been delivered "in-house" by TransLink.

In June 2016, the TransLink Board committed to undertake a review of the policies and delivery model for HandyDART, focused on two key areas:

- 1. HandyDART policies that influence the customer experience and the availability of trips; and,
- 2. the service delivery model.

The review included building on past work and existing research, expert input on industry best practices and a peer review of other Canadian agencies, and extensive public and customer engagement. An Advisory Committee was established as a task force that included representation from the stakeholder community and customers, including HandyDART Riders Alliance. The Advisory Committee identified 19 recommendations that were adopted by the TransLink Board on March 30, 2017. The policies recommendations are specific actions to:

- Improve customer experience by:
  - o improving reservation convenience;
  - o reducing wait and travel times; and,
  - o improving taxi driver training, accountability and customer service.
- Improve availability of trips by implementing:
  - o a Family of Services Approach;
  - o a Travel Training Program;
  - o improvements to accessibility of the conventional transit system;
  - an enhanced eligibility process; and,
  - o processes to explore HandyDART funding partnerships.

Based on the recommendations of the Advisory Committee, the TransLink Board adopted the following recommendations regarding the delivery model:

- TransLink retain responsibility for the HandyDART Registration function.
- TransLink assume responsibility for the Customer Feedback function.
- Validate the findings of the Public Sector Comparator to determine if:



- Call Centre is provided by TransLink Enterprise or contractor; and,
- Delivery of Rides is contracted to one or more contractors.
- Require proponents to offer employment opportunities to existing HandyDART employees on a preferred basis.
- Extend existing contract with MVT Canadian Bus, Inc. for six months (to June 30, 2018).

As part of this process, a Public Sector Comparator analysis was undertaken to assess what the cost would be to the public of different HandyDART delivery options, including contracting out and in-house delivery. The Public Sector Comparator analysis estimates that contracting out both the call centre functions and the delivery of rides is the most cost effective way to deliver the service. However, there may be some benefit of having the call centre functions in-house.

Recognizing the importance of achieving policy objectives in a cost effective way, it is prudent to undertake a procurement process to validate the findings of the financial analysis and reserve the final decision on the number of dedicated contractors to operate the vehicles and who is best to deliver the call centre until TransLink has that information. Multiple contractors may encourage smaller and local companies to submit proposals.

A Request for Proposals for the call centre and service delivery functions was issued on July  $4^{th}$  and closes on September  $7^{th}$ . The review and decision process is expected to take several months. It is currently anticipated that a formal decision from the Board regarding the future delivery model will be made at its December  $6^{th}$  meeting.

#### **Current Status of Recommendations:**

To date, TransLink has taken the following actions to implement the recommendations resulting from the HandyDART service review:

- work is underway to bring the customer feedback function in-house as soon as possible;
- implemented an extended booking window for next-day HandyDART trips, moving the cut-off time from noon to 4:00 PM;
- added HandyDART customer wait times to the TransLink Accountability Centre;
- made changes to the dispatching function to improve "on time" performance; and,
- adjusted the 10-minute advance message of the vehicle arrival to improve accuracy.

With the current implementation schedule, TransLink anticipates many of the remaining recommendations will be implemented by late 2017 or early 2018.

**Issue:** Mayors' Council/TransLink Priorities

#### **SUMMARY:**

 Mayors Roberston and Hepner are the Chair and Vice-Chair of the Mayors' Council on Regional Transportation. Both mayors also sit on the TransLink Board. They are interested in meeting with the Minister to provide information on Mayor's Council priorities and opportunities to work with the Province to implement the Mayors' Council Vision.

- Priority issues for discussion will likely include:
  - 1. **Golden Ears Bridge Toll Removal** The need for the Province and the Mayors to work together to remove tolls from the Golden Ears Bridge and agree on a compensation strategy.
  - Pattullo Bridge Replacement Provincial process for determining its commitment to pay for a
    portion of the bridge, seek federal funding, and to work with TransLink on appropriate options
    to address the financial impact of foregone toll revenues.

4. **Funding the remainder of the Mayors Council Vision** – Update on the major projects and timelines for discussions between the federal and provincial governments and TransLink on Phase 2 of the vision.

#### BACKGROUND:

In 2014, the Mayors' Council approved a 10-year transportation plan for Metro Vancouver. The *Regional Transportation Investments: a Vision for Metro Vancouver* (Vision) outlined proposed transit and transportation investments for Metro Vancouver, including increased bus, SkyTrain, SeaBus and HandyDART service, rail rapid transit for Surrey and Langley, a new Pattullo Bridge, and the Millennium Line Broadway Extension.

In November 2016, the Mayors' Council released its Phase One Investment Plan to fund the 10-Year Vision. Phase One investments included an increase to HandyDART and bus service and an increase to rail service in 2018, pre-construction work on the Millennium Line Broadway Extension and Surrey rapid transit, a new SeaBus, and major road network cycling and walking upgrades.

The Phase One Investment Plan is funded through a contribution of \$370 million from the Federal government, \$246 million from the Provincial government and funding from regional sources including property taxes, increases to transit fares and surplus property sales. Phase One also identified a new regional Development Cost Charge, which requires legislative change to enable.

The Phase Two Investment Plan is scheduled for Mayors' Council review in early 2018. It will contain major capital investments including the construction of the Millennium Line Broadway Extension and Surrey Newton-Guildford Rapid Transit projects, capacity improvements for the Expo and Millennium SkyTrain Lines and the replacement of the Pattullo Bridge.

### **DISCUSSION:**

## **Golden Ear Bridge Toll Removal:**

The government announced a commitment to remove tolls on the Port Mann and Golden Ears Bridges to increase affordability in the Lower Mainland. The Province has committed to work with the Mayors' Council and TransLink to address revenue shortfalls resulting from this decision. The Province is currently in the process of reviewing the process for immediate toll removal and the mechanisms to replace any lost revenue, as well as potential long term strategies. TransLink would like to take a proposal to the joint Mayors Council/Board Investment Subcommittee on Thursday, August 17 for review.

#### **RECOMMENDED RESPONSE:**

- I appreciate your support to date on this initiative and look forward to having an agreement shortly on the removal of tolls.
- We recognize that TransLink does have a significant investment and liabilities for the bridge.
- We recognize that there is a need for detailed discussion among provincial, TransLink and Mayors Council members as we work out a long term solution for financing the bridge.

## Pattullo Bridge Replacement

The Vision proposes that the Pattullo Bridge be replaced by the end of 2022 with a new four-lane bridge (with the option to expand to six lanes). s.13,s.17

committed to fund 40% of the cost of this project. Work is still underway regarding options for the scope of the project (mainly associated with the connections on the Surrey side of the bridge).

The timelines for replacing the bridge are driven by the deteriorating condition of the existing structure. TransLink requires an approved funding plan in place by late-2017 in order for procurement to proceed on a schedule that permits the new bridge to open by January 1, 2023. TransLink planned to fund its share of the bridge replacement through the use of tolls. With the Province's commitment to remove tolls on bridges in Metro Vancouver, TransLink is now looking to the Province to make up for the funding shortfall for this project.

#### RECOMMENDED RESPONSE:

- The Province has committed to funding 40% of the Vision, including the Pattullo Bridge.
- My understanding is that TransLink will be providing a final business case to the province at the end of August.
- My commitment is to have answers for the Mayors' Council on funding this fall.
- This would meet the Mayors' timeline for an October decision.
- This timeline will also allow so time for the federal government to initiate their new infrastructure funding programs.

## Phase 1 Development Cost Charge:

The Mayors' Council proposed a new regional transit Development Cost Charge (DCC) as part of its Phase One Investment Plan. s.13,s.17

## Funding the remainder of the Mayors Council Vision:

The Provincial government has committed to funding 40% of the total capital costs of the Vision, including the major rapid transit expansion projects and the replacement of the Pattullo Bridge. The Province has also committed to working with the Mayors' Council on a sustainable regional funding strategy, including potentially enabling new regional revenue sources. The Mayors are hoping for a confirmation of the Province's positions on funding by the end of 2017.

#### RECOMMENDED RESPONSE:

- The Province has committed to funding 40% of each phase of the Vision.
- We plan on working with the Mayors Council and Federal government to secure funding agreements to support the Phase 2 Investment Plan.
- Finalizing the design and costs for major projects such as the Millennium Line Broadway Extension and the Surrey Newton-Guildford Rapid Transit projects aids in this effort.

#### **Definitions:**

**Denial**: A trip denial occurs when a customer makes a booking request and HandyDART is unable to provide the trip, typically due to capacity constraints.

**Refusal**: A trip refusal occurs when a customer makes a booking request and HandyDART is able to find a solution, but it is not acceptable to the customer (e.g. customer would arrive too early for an appointment).

**Unaccommodated Standbys**: A standby trip request is made when the customer requests a next-day trip outside of the booking window (up to 7 days in advance and 4:00PM the day before the desired trip). If HandyDART is unable to find a solution for the last minute trip, it is recorded as an unaccommodated standby.

**No Show and Cancel at the Door**: A cancellation is recorded as a Cancel at the Door if the vehicle arrives and the customer cancels upon its arrival. A cancellation is recorded as a No Show if the vehicle arrives, the customer is not at the location, and HandyDART staff is unable to make contact with the customer by phone.

**Other Cancellations**: All other cancellations that take place in advance of the customer's scheduled pick up time. This includes trips that could not be completed due to inclement weather.





Thank you for your email regarding your concerns about TransLink's contracting of HandyDART services. As Minister responsible for TransLink, I am pleased to respond on behalf of the Honourable Mike Farnworth, Minister of Public Safety and Solicitor General. I apologize for the delay in responding.

HandyDART is a vital service offered by TransLink that many people rely on for their day-to-day commute and for staying connected to their communities. In addition to delivering HandyDART services, TransLink's transit fleet is fully accessible, and continues to improve through the implementation of the Access Transit program. The Access Transit program was established to ensure that accessible transit is integrated into all plans, projects and programs in partnership with key stakeholders.

In 2016, TransLink began a comprehensive review of HandyDART policies and services to improve the system. This review included engagement with stakeholders in the HandyDART community. The key recommendations that resulted from this review were approved by the TransLink Board of Directors in March of this year. TransLink has indicated that work is already underway implementing some of these recommendations and that others will be implemented later this year or in early 2018.

I recognize your concern with the Request for Proposals (RFP) to deliver the HandyDART ride service function that was recently issued by TransLink. While the Province of British Columbia does not have a role in operational TransLink issues such as the timing of issuing RFPs, government has committed to working with TransLink and BC Transit to find long and lasting solutions to improve HandyDART service.

To support this process, Bowinn Ma, Parliamentary Secretary for TransLink, has met with representatives from the HandyDART Riders' Alliance to hear their concerns and suggestions about the future of HandyDART. The meeting was informative and I am working with Ms. Ma to ensure HandyDART services are meeting client's needs.

I am writing to convey to you a motion approved by the Mayors' Council at its July 27, 2017 meeting. That motion "requests the new provincial government to announce that it will launch a review of the *South Coast British Columbia Transportation Authority Act* (SCBCTA) to consider governance changes."

As you know, governance changes to make TransLink accountable to elected local leaders have been a priority of the Mayors' Council since its members were removed from the TransLink Board in 2007. This view remains unchanged and strongly held today.

With regular public Translink board meetings, two mayors serving as directors, and the new joint committees and joint meetings of the Mayors' Council and TransLink Board, there is a new, more constructive governance arrangement. But these governance improvements stop short of elected officials having direct accountability for the annual operating budget.

The Mayors' Council's next meeting is on September 21, 2017. The Council will be interested in hearing your response to this request.



Thank you for your email addressed to the Honourable John Horgan, Premier, regarding your concerns about the choice of light rail transit (LRT) for the South of Fraser communities. As Minister responsible for TransLink, your correspondence has been forwarded to me for reply and I apologize for the delay in responding.

In 2014, the Province of British Columbia amended TransLink's legislation to give the Mayors' Council on Regional Transportation more responsibility for approving TransLink's long-term strategies and investment plans. The Mayors' Council includes representatives from every municipality, electoral district and a Treaty First Nation in Metro Vancouver. This ensures that locally elected representatives, who best understand the region's needs, will guide transit planning and delivery.

In 2014, the Mayors' Council approved a 10-Year Vision for Transit and Transportation in Metro Vancouver and the Province has since committed to funding 40 percent of the cost of the vision's projects. I thank you for making a commitment in Surrey last fall to sit down with the Mayor's Council and help determine the best technology to use for rapid transit expansion in Surrey and Langley. My hope is that you will carry out that commitment and determine that street-level LRT technology, for several reasons, is not the best solution.

I have previously written to you expressing my concerns about deploying LRT technology in Surrey, a city which will soon be larger than Vancouver.

It would be a travesty not to extend the much faster and more reliant and cost-effective Skytrain along Fraser Highway to Langley. Secondly, if Skytrain is deployed to Langley, it makes no economic sense for Surrey to even consider LRT technology for a 10-km line from Guildford to Newton. Therefore, the Fraser Highway route should be implemented with Skytrain technology as phase one of the plan, and then see what falls-out later for phase two.

Attached for your information is a letter to the editor of the Surrey Now-Leader, which I penned today in response to their front-page story on Sep 15, 2017. The mayor of Surrey may now be bending on this issue as she is quoted as saying "it doesn't matter which technology choice they choose, but there will come a time when they need to get going". Your government has a critical role in the technology selection process and it is important not to rush in order to make the right decision.

It is requested that the Provincial Government ensures that tax dollars do not get wasted. It is strongly recommended to extend Skytrain, the most cost-effective rail transit system, throughout Surrey and to Langley.

Dear Members of the Legislature Assembly,

The cost of building rail rapid transit has increased substantially to the point that it is not feasible under the present funding format.

Prior to the formation of Translink the funding for rail rapid transit was provided by the province and federal governments and that format should continue.

A funding solution is needed for the Skytrain Millennium Line extension along the Broadway corridor and Surrey LRT (Surrey-Newton-Guilford).

The Skytrain Expo Line was built at a cost of 29 million dollars/km, the Skytrain Millennium Line was built at a cost of 60 million dollars/km and because of the delay the cost has increased to 131 million dollars/km on the Skytrain Evergreen Line.

I would also like to suggest that funding be found for extending the Millennium Line to UBC. The tunnel boring machine would be in place for the initial extension, and it may cost less in the long run if it continues to UBC.

As for rail rapid transit expansion along the Fraser Highway the following facts indicate that extending the Skytrain Expo Line has the most benefits.

- 1. The Surrey Rapid Transit Alternative Analysis report says that "RRT generates the most quantifiable benefits" along the Fraser Highway (RRT is Skytrain).
- 2.If you compare the cost of the latest rail rapid transit expansion in Calgary (Calgary West LRT was 178 million dollars/km),

Portland (Portland-Milwaukie LRT was 127 million dollars US/km, 173 million dollars CAD/km), and Metro Vancouver (Skytrain Evergreen Line was 131 million dollars/km).

Skytrain cost less to build than LRT.

- 3.Skytrain can have higher frequencies, has faster travel times, and there would be seamless transportation from Langley to New West, Burnaby, and Vancouver.
- 4.If a high speed rail from Seattle and Portland is built, then terminating in Langley would cost considerably less. Langley is only 16km from the border where as Vancouver International Airport is 44km and

Scott Rd Skytrain station is 33km from the border. Extending Skytrain to Langley provides a Skytrain connection to Vancouver and other parts of the Lower Mainland.

The attachment shows what is possible for rail rapid transit in the Lower Mainland.

# **Lower Mainland Rail Rapid Transit**

With the increasing population and traffic congestion in the Lower Mainland the need to expand rail rapid transit becomes ever more pressing. This document focuses on connecting most of the city centres in the Lower Mainland with rail rapid transit.

## Millennium Line (Skytrain)

This line would extend west from the existing Millennium Line and run underground along the Broadway and 10<sup>th</sup> Ave corridor to UBC.

# **Evergreen Line (Skytrain)**

The line would split south of Lincoln station on Pinetree Way and run east along Lougheed Highway and 226th St to the Haney Place Transit Exchange.

The line would also extend south along the Golden Ears Way across the Fraser River, along 200th St, and merge with the Expo line east bound towards downtown Langley. The line would also split at Willowbrook Mall and run along the Langley Bypass and merge with the Expo Line west bound towards the new Willowbrook Transit Exchange.

# Expo Line (Skytrain)


This line would extend along Fraser Highway, Industrial Ave, Acacia Cr, 56th Ave, 206th St, Fraser Highway, Trans Canada Highway, South Fraser Way, and Bourquin Cr to the Bourquin Transit Exchange.

## Surrey LRT


This line would start at Guilford Mall area and run along 104th Ave, City Pkwy, King George Highway, Highway 10, Langley Bypass, 196<sup>th</sup> St, and end at the new Willowbrook Transit Exchange. A station at Surrey Central would allow passengers to transfer to the Expo Line.

The line would also extend south along 152 St from Highway 10 to White Rock Centre Transit Exchange. This would allow trains to run direct from White Rock to Newton, Whalley, and Guilford as well as direct from White Rock to Cloverdale and Langley.

#### **Travel Times**

Extending the existing Expo Line along the Fraser Highway to Langley would provide faster travel times.

## **Funding**

Rail rapid transit is far too costly for a local transit authority. Funding needs to be secured from one or both of the provincial and federal governments.

#### Additional Facts

- Surrey Rapid Transit Alternatives Analysis report (March 2013) says that on the Fraser Highway "RRT generates the most quantifiable benefits." RRT is Skytrain.
- The **Skytrain Evergreen Line** is 10.9 km long with an **average speed of over 44.5 km/hr**. The line is elevated, underground, and on the surface (fenced) fully segregated from traffic and fully automated. The cost was \$1.43 billion dollars which works out to \$131 million dollars/km.
- The Portland Milwaukie LRT Line is 11.75km long and has an average speed of 28 km/hr. The line is mainly on the surface. The cost of the line was \$1.49 billion US dollars which works out to \$127 million US dollars/km (\$173 million CAD dollars/km).
- The Calgary West LRT Line is 8.2 km long and has an average speed of 33.5 km/hr. The line is underground, elevated, and on the surface with level crossings. The cost of the line was \$1.46 billion dollars which works out to \$178 million dollars/km.
- The cost of the Skytrain Expo Line was 29 million dollars/km and the cost of the Skytrain Millennium Line was 60 million dollars/km.
- The travel time from downtown Langley to Waterfront on Skytrain would be 62 minutes. If the line was surface LRT from Langley to Waterfront the travel time would be 87 minutes (32km/hr).

# TransLink approves 51 projects to receive \$23 million

Funding goes to road, cycling and pedestrian projects along region-wide Major Road Network

October 13, 2017

NORTH VANCOUVER, BC — TransLink is pleased to announce the final list of 51 capital projects across the region approved to receive a portion of \$23 million in funding this year. Projects will improve road, cycling and pedestrian infrastructure, and reduce congestion across Metro Vancouver.

These investments will improve transportation infrastructure for people whether they drive, bike, walk or take transit. Projects include the West Keith Road Multi-Use and cycling path in North Vancouver; roadway widening, streetlights and new bike lanes in Delta; separated bike lanes along 100 Avenue in Surrey; and the Willingdon Linear Park, a new park and multi-use path on Willingdon Avenue in Burnaby.

This annual release of funds also includes more than \$41 million to operate, maintain and rehabilitate the MRN. Each municipality decides how to best use the funds for a range of activities, including street cleaning and snow removal, maintaining streetlights, traffic signals and signs, patching potholes, and repaving. Funding is provided per kilometre of the MRN within each municipality.

In total, nearly \$65 million has been committed in 2017. But this is just the beginning of our road investments. Over the next two years the Mayors' 10-Year Vision commits more \$130 million to keep the MRN in a state of good repair, reduce congestion and help people and goods move safely across the region.

The Major Road Network consists of more than 600 kilometres of arterial roads that carry the bulk of the region's commuter, transit and truck traffic. TransLink is the first North American transportation authority to be responsible for roads, bridges, walking and cycling in addition to public transit.

TransLink is pleased to announce that nearly \$65 million has been committed to the Major Road Network in 2017. Funding includes \$41 million for to the operations, maintenance and rehabilitation of the Major Road Network (MRN) and \$23 million for 51 capital projects across the region to improve road, cycling and pedestrian infrastructure, and reduce congestion across Metro Vancouver. This is just the beginning of our road investments. Over the next two years the Mayors' 10-Year Vision commits more \$130 million to keep the MRN in a state of good repair, reduce congestion and help people and goods move safely across the region.

# Operations, maintenance and rehabilitation (OMR) of the Major Road Network

I thank you for making a commitment in Surrey last fall to sit down with the Mayor's Council and help determine the best technology to use for rapid transit expansion in Surrey and Langley. My hope is that you will carry out that commitment and determine that street-level LRT technology, for several reasons, is not the best solution.

I have previously written to you expressing my concerns about deploying LRT technology in Surrey, a city which will soon be larger than Vancouver.

It would be a travesty not to extend the much faster and more reliant and cost-effective Skytrain along Fraser Highway to Langley. Secondly, if Skytrain is deployed to Langley, it makes no economic sense for Surrey to even consider LRT

technology for a 10-km line from Guildford to Newton. Therefore, the Fraser Highway route should be implemented with Skytrain technology as phase one of the plan, and then see what falls-out later for phase two.

Attached for your information is a letter to the editor of the Surrey Now-Leader, which I penned today in response to their front-page story on Sep 15, 2017. The mayor of Surrey may now be bending on this issue as she is quoted as saying "it doesn't matter which technology choice they choose, but there will come a time when they need to get going". Your government has a critical role in the technology selection process and it is important not to rush in order to make the right decision.

It is requested that the Provincial Government ensures that tax dollars do not get wasted. It is strongly recommended to extend Skytrain, the most cost-effective rail transit system, throughout Surrey and to Langley.
