Province steps up with modular housing for the homeless

VANCOUVER – People will soon have access to safe, affordable housing thanks to a provincewide program to help municipalities tackle homelessness. The program will provide hundreds of new modular housing units in communities from Vancouver to Surrey to Smithers, Premier John Horgan announced today.

"People can't begin to feel safe and secure until they have a place to call home," said Horgan. "We're partnering with local governments to help those who don't have a home, to help them live in dignity and give them a chance at a better life."

The B.C. government has committed \$66 million toward 600 units of modular housing, which will be situated on land provided by the City of Vancouver. The modular units will be staffed 24/7 by non-profit housing providers and will include support services to help people in need stabilize and rebuild their lives.

"There are too many people living on the street in Vancouver and across the province," said Selina Robinson, Minister of Municipal Affairs and Housing. "These modular units will provide interim homes in the short term while we act on the more permanent housing solutions that are needed. These are an important first step in developing the comprehensive housing strategy British Columbians need."

Each building will include approximately 50 self-contained units, complete with individual kitchen and bathrooms, shared laundry, indoor and outdoor amenity spaces, plus programming space.

"The number of people living in poverty and experiencing homelessness has been ignored for far too long," said Shane Simpson, Minister of Social Development and Poverty Reduction. "That is why we are taking urgent action to provide these supportive modular-housing units to make sure that people in need have a safe place to go."

Temporary modular housing provides a rapid response to address homelessness. The intention is to have a number of the units up and running by this winter.

"It's fantastic to see the Province step up to help solve homelessness with support to deliver 600 units of temporary modular housing in Vancouver," said Gregor Robertson, mayor of Vancouver. "The City is ready to work quickly to make sure these temporary homes are built as soon as possible to get our most vulnerable residents off the streets and into safe, secure housing until more permanent options are available."

This is part of the Province's plan to construct 2,000 modular units over two years throughout B.C. by working in partnership with interested communities. The first 1,000 units are expected

to be in operation by early 2018.

BC Housing is in discussion with a number of other communities that are in immediate need of modular housing for the homeless, including Surrey and Smithers.

"We are very excited about this initiative and its potential for our community, as it could fill a current gap in our housing spectrum by providing much-needed support for people with multiple barriers," said Taylor Bachrach, mayor of Smithers. "We are looking forward to working with the Province on this initiative and are hopeful that it will be a good fit for Smithers."

In addition to modular housing, BC Housing is working with communities to finalize plans to build 1,700 new units of affordable rental housing that were announced in the 2017 Budget Update.

Quick Facts:

- The B.C. government has set a target to build 114,000 new units of affordable housing throughout B.C.
- As part of the 2017 Budget Update, the Province announced that it will invest:
 - \$291 million to support the construction of 2,000 modular housing units for people who are homeless and more than \$170 million over three years to provide 24/7 staffing and support services.

Advice to the Minister of Municipal Affairs and Housing

Q1: Where will the 600 units be located?

- BC Housing is working with the City of Vancouver to explore vacant, underutilized sites.
- It will be up to the City to rezone these sites or to provide temporary use permits or licenses for the temporary modular units.
- To date, we have identified 20 potential sites and we are working together on next steps.

Q2: What is the timeline for the modular units in Vancouver? How many units will be ready by this winter?

• Approximately 80-120 temporary modular homes will be up and running by this winter and the remaining units will be in place by early 2018.

Q3: Will any services or supports be offered to residents?

- BC Housing is allocating operating funding to ensure the buildings have a 24/7 staffing and a meal program.
- Staff will connect residents to community-based health care services.

Q4: How will people be identified for this housing?

 BC Housing will work with its non-profit providers and their outreach workers to identify and connect with those who are homeless or at risk of becoming homeless, and refer them to appropriate services and housing.

Q5: How long will people be able to stay in the modular housing?

- This will be a tenant's home for 5-10 years, or until more permanent housing is found.
- The non-profit housing provider will work with each tenant to identify more permanent housing
 options as they become available.

Q6: Where will the units be coming from? Are they being purchased from a certain manufacturer?

- The modular units are being purchased from a modular housing manufacturer.
- We are currently in negotiations and details have yet to be finalized.

Q7: How much will it cost to build each modular unit?

 The costs will vary depending on site preparation, servicing requirements and specification of the building.

Q8: Will this be temporary housing – how long will the modular housing stay in place?

• It will be located on a specific site between 5-10 years before being relocated to another underutilized site, pending redevelopment.

Q9: What other communities will receive modular housing and when?

- Surrey and Smithers are communities that are getting ready to partner with us.
- Other communities with available land are invited to contact government. Meanwhile, BC
 Housing is already in discussion with a number of other communities that are in immediate
 need of modular housing for the homeless.
- We will be excited to share details once other sites are finalized.
- Our goal is to have 1,000 units up and running by 2018 2000 over two years.

Q10: What else are you doing to address homelessness in Vancouver?

Background:

- On Sept. 11, 2017, in the B.C. Budget Update, the Province announced \$291 million to support the construction of 2,000 modular housing units for people that are homeless and more than \$170 million over three years to provide 24/7 staffing and support services.
- These units support the development of a homelessness action plan and will count towards the Province's commitment to build 114,000 units of affordable housing.
