Good morning,

As you will have seen, it is my real pleasure to confirm that I'll be continuing in my role as Deputy Minister for the newly minted Ministry of Municipal Affairs and Housing (with continued responsibility for TransLink). That said, even with continuity, comes change!

First, our **Arts, Culture and Sport** colleagues, including the BC Athletic Commissioner, are moving to the new Ministry of Tourism, Arts and Culture. While this dynamic team will be missed here at CSCD (now MAH – seriously, we need acronym help!), I am also excited on your behalf at the prospect of your greater connection with the Film, Creative BC and Tourism files, which enjoy strong connections with Arts and Culture and Sport. It has been such a pleasure to work with you and experience the true contributions you make to communities across the province. I hope our ministries will continue to actively engage with one another as we keep in mind the valuable impact your work has on organizations throughout the province and on the communities which benefit from their activities. I previously worked with Sandra Carroll when we were each at the Ministry of Transportation, and I'm confident you are in great hands as you transition to the new ministry under her leadership.

And second, I am very pleased to welcome the **Office of Housing and Construction Standards** to our rebranded ministry. This division is led by Greg Steves, ADM, and includes teams delivering on Building and Safety Standards, Residential Tenancy, and Housing Policy, and including oversight of and liaison with BC Housing. Combined with our existing role in supporting local governments and in working with TransLink in its service of the transit and transportation needs of the Metro Vancouver region, we are now well positioned for strong collaborations respecting the significant range of housing related initiatives we will be collectively working on. I'm very excited to bring our teams together as we forge the path ahead!

These changes will bring some restructuring to our ministry. While I do not anticipate any initial physical movements of staff, we will work with the new Ministry of TAC, and with the OHCS team, to make sure the teams are appropriately connected and supported. I do anticipate making space available for Greg at 800 Johnson to facilitate his access to our executive, and I hope to bring him around soon to introduce him to you. Beyond this information, please be patient as the executive, under Tracy Campbell's capable leadership, works through this transition. If there are areas you want to make her aware of, please work with Tracy and her team. Our goal will absolutely be to ensure as smooth a transition as possible.

I have had initial conversations with our new Minister, the Honourable Selina Robinson, and she is very excited to take on this new challenge. I will be getting a clearer sense of how MSR would like to handle briefings and of her availability, and as we begin to schedule more time with her to bring her up to speed on our many files, I and the executive will

explore with her the depth and breadth of the work underway and to come here in the ministry. We will look for opportunities to keep you connected to this work and to the perspectives of the Minister, and I hope to invite Minister Robinson to come to our facilities to meet with staff directly if her schedule allows for that.

I have thoroughly enjoyed my time in this Ministry to date, and am absolutely looking forward to the opportunity to work alongside each of you as we prepare for a new agenda with new priorities and challenges. As always, change brings many questions... so please feel free to send any you may have my way or to your respective executive members.
