s.22 is experiencing difficulty with his district in regards to utilities, specifically water. I've summarized his 3 issues below (#2 is his main concern)

1. He pays for water services with a cheque and has proof of payment for previous bills. He recently received a notice of disconnection due to non-payment which he went in to dispute. After providing proof of payment to the office he was told they would look into it. Several days later he received a notice of cancellation and as he was feeling quite ill he decided he would pay the bill to be safe. When he was feeling better he went to follow up on this double payment and it sounds like he has not had a resolution to this.
2. After disputing the cancellation s.22 was told his rate would be increasing from \$188.10 to \$566.80 to reflect billing for a single family unit. s.22

s.22

The existing infrastructure was

put in when they were built in the 60s and was approved by the district at that time. The way that it is set up is that to get water for one unit you have to provide water to all the units. In order to change this s.22 would need to tear up the entire yard and replace the entire system s.22 does not feel that it is right that the district can increase his fees when the existing infrastructure was approved and would need to be upgraded at his expense.

3. s.22 is doing some renovations on the property and asked that the district shut off the water for the duration of these renovations. He figured while the water was shut off he would figure out how to deal with the increased water bills. He was told that the district could cut off the service but would continue to bill him regardless of whether he is receiving the utility or not. s.22 does not think that this is fair and does not believe the district should be allowed to charge him for a service he is not accessing.

s.22 was referred to MAH by ENV and hopes we will be able to call him back and advise him on what he can do in this situation. If program area is unable to respond can you let me know who I should forward this to?

Hey all just wanted to give you a heads up about this caller as I just missed a call from him and suspect he may begin calling us regularly. (Ian and Lia I've cc'd you in case he calls the DMO directly or while we have our phones forwarded)

He has many complaints about his hearing with the RTB all of which I discussed with him in great detail yesterday. I advised it is not the role of the ministry to intervene or influence decisions made by arbitrators and that once an arbitrator has made a decision it is legally binding and the ministry cannot reverse the call. He has a complaint in with the ombudsperson which I advised was a good place to start if he felt he did not receive fair treatment from the RTB and Kathy Elder provided him with information on starting a judicial review of the decision if he felt so inclined.

The RTB will be responding to him in an email as he requested yesterday about the process for arbitrator complaints and what actions they take when a complaint is made but as the response is going to be an email it will likely take them a little while to craft. I've encouraged him to contact the RTB for any suggestions on next steps as the MO is not as familiar with the processes and will not be able to provide him with guidance. I also told him to contact the office of the ombudsperson should he have any questions about the status of his complaint there. Finally I advised him that I would share his feedback with the Minister and her staff but that was really all we could do on our end.

s.22 has called in again and believes she did not get a call back. I reiterated the information about hiring more arbitrators and additional funding which has gone to the RTB to address wait times for hearings.

It sounds like s.22 may not recall the information that Rose provided to her in their earlier call. She provided some updates to our previous call including:

- Tenant did not may rent on March 1, on March 3 the tenant advised she would not be paying rent in March and was taking it as her free month. s.22 was under the impression the free month had to be the last month of tenancy.
- s.22 advised she has requested that the tenant provide updates on RTB filings etc by registered mail but the tenant refuses to comply with that request
- s.22 also feels that the system is set up in favor of the tenants as all information she puts on file has to be signed supported (with witnesses/dates/times etc) yet, in s.22 opinion,

- the tenant has been able to submit 3 pages of unsubstantiated evidence

---

Spoke with s.22 regarding s.22 current tenant. She had some complaints about how the arbitrator conducted the hearing, and was upset about the long wait time for a hearing. She stated that the purpose of the call to the minister's office was not to receive a call back from the residential Tenancy Branch, but for the purpose of voicing her opinion on changes the government should do to make it fairer for a landlord who may be owed several months' rent.

Discussed with her the option of judicial review if she feels that the decision was unfair, or the arbitrator made an error in law and that the minister or any other government official cannot change the decision.

I gave her info on how the branch is hiring more arbitrators that will hopefully help with the wait times for hearings.

Also provided her with information about the importance of tenancy agreements as stated in the act, and that she can go to our website to get a tenancy agreement and a condition inspection report.

Also discussed notices to end tenancy and the different reasons to end a tenancy, and compensation to tenants that receive a 2 month notice

s.22 advises that she called a few months ago and did not receive a call back, I was unable to locate a call summary in my logs so am unsure as to what conversation did/did not take place.

s.22 advises that s.22 rent out a home and currently there is a tenant who has been late or who has refused to pay rent in October, November and December. On December 10<sup>th</sup> s.22 gave the tenant an eviction notice. Their file proceeded to arbitration on Feb. 20 where it sounds like the decision was not in s.22 favour. s.22 does not feel that this decision is proper and feels that "the RTB is not following their own rules". She feels that the tenant was not reprimanded for failing to pay rent and s.22 is frustrated as she feels the tenant's actions are threatening the ownership of s.22 home. She was angry that no one would provide her with advice on her case.

I advised s.22 that it is not the place of the Ministry or RTB to provide advice on how to present a case and if she was looking for this kind of information she would have to seek legal counsel. I also told s.22 that arbitrators review all evidence provided by both sides to come to a decision that may or may not be in her favor. She has asked for a call back with information on next steps / how she can appeal this decision.

She also had several complaints about the arbitrator for her hearing. s.22 felt that the arbitrator spent most of the time reprimanding s.22 for "no reason" and that they did not deal with the fact that the tenant refuses to pay rent. I advised her that while I could understand that this was her opinion and see that she was frustrated the MO is in no position to comment as we do not have the details of the case.

I advised her I could pass along her concerns regarding her hearing to the RTB for

review/consideration and that I could ask RTB staff to call her back and provide information on available next steps or how she can appeal the decision.

Could I get a call summary for this one in case she phones back after speaking to the RTB?

I am a spokesperson for the Mesachie Lake Citizens who have had their dedicated, volunteer FireChiefs (27 and 9 years service!) fired without cause nor notice on January 24,2018, our firehall closed due to 'public safety concerns' and then an unqualified firefighter appointed Chief by the CVRD the following week and the firehall reopened with no discussion of whatever their 'safety concerns' were. We are very concerned with this huge public safety issue in our community. We understand that you will be in Duncan on March 9 for the Missing Middle Workshop and we humbly request a meeting with you to discuss this issue.

We have petitioned, written and had delegation status with the CVRD. They continue to hide behind 'personnel' issues, in spite of not having followed their own Corrective Action/Progressive Discipline Policy nor BC Employment Contract law

regarding 'just cause' and 'reasonable notice' for these terminations. We are holding a public demonstration at their office tomorrow on AntiBullying Day. Please could you make a few minutes to hear our community worries and concerns regarding our safety being compromised. We are very upset about being endangered by the CVRD's reckless decision making regarding the Mesachie Lake Volunteer Fire Department.

Thank you for taking the time to listen to our complaints yesterday. As promised, I am forwarding the communications with the RTB from the initial stages of the hearing process. As

they outline, we had a clear belief from the outset that this hearing was headed in a grave direction in terms of arbitrator bias and failure to adhere to rules of procedural fairness. As discussed with you, those fears were proven correct, and the arbitrator in this matter performed abhorrently, with a callous disregard for the legislation under which he is delegated his authority, and with a clear bias. As also discussed, we have now in his written decision **unequivocal evidence** of fabrication of facts, and multiple other errors that render this decision not only negligent, but critically abusive of his authority.

Dear Jovi,

I think it is necessary at this point to clarify that the Arbitrators under your directorial staff are dealing with real people, real lives, and real financial effects resulting from their decision making.

I have in my past experiences with your staff noticed an alarming lack of knowledge/sophistication in their handling of hearings, and am deeply disturbed by the apparent absolute authority allowed them in the hearing process, and the fact they seem far too aware of their lack of oversight and any consequences that may result from their actions . There is a statute in place for a reason, diligently created by the legislature, with real rules that should be closely adhered to, but in my experiences rarely is it respected as it should be by your Arbitrators.

In the matter at hand, this is blatantly obvious. As such, and due to the importance of the concept of procedural fairness, I can not let this continue.

I am certain your Directors prefer to be contacted themselves in lieu of my approaching the Ministry directly, and I'm confident they will see the error we refer to. We can not proceed in a hearing that at its outset is being callously mishandled. That would be a waste of our time, and your resources. Procedural errors at the embryonic stage of the hearing need to be addressed before they impair the entire process, and we have a chance to do so here and there is no risk of bias when one is simply ensuring the evidentiary rules in the statute are followed.

As such, I do not need to explain that this is a far more pressing matter than the regular emails you receive, and I do not consider 13 days, even if we count from your preferred date, to be insufficient time to deal with this.

Dear Information Officer Jovi,

Thank you for your reply.

I understand the issues surrounding tampering or bias, and in no way am seeking to offend those concepts.

However, the process of Judicial Review at the Supreme Court level does NOT exist to be used as you have purported. Judicial Review at the SC is not some sort of readily accessed "failsafe" or proxy for the RTB. Parties before you can not be simply told to go visit the Supreme Court if we do not do things right here at the RTB. Judicial Review can not be used to repeatedly "fix" errors made at lower levels of adjudication when those errors could be easily avoided/corrected by



simple responsibility on the part of the governmental branch/individual decision maker and their overseers. The resources of the courts, and the Province itself are not to be squandered by the RTB being unwilling to ensure the basic tenets of the RTA are being followed. I am certain your Director's would agree that there is a level of competency that is expected during a hearing, and although I certainly understand the broad application of the RTA that is allotted the adjudicator's, they are not permitted to flout the rules within the statute, nor are they allowed to contradict information they have put forward will constitute an interim decision in the matter at hand.

In the matter I have contacted you about, <sup>s.22</sup> heard on November 1, 2017, there has been a critical failure to consider the statute and the rules for provision of evidence, as well as a complete failure of the adjudicator presiding, a Mr. Molnar, to adhere to his own instruction.

Specifically, Mr. Molnar after allowing only tenant testimony in this matter to date (the landlord's have had no opportunity to speak currently) has put the matter forward to November 23, 2017 as previously indicated to you. He has been recorded on audio tape minutes before the conclusion of the initial hearing twice indicating he would be disallowing the presentation of any additional documentary evidence in the matter. Then, with no determinative new information before him that potentially could have compelled a change of heart, he inconceivably indicated he would allow the tenant's to file further **witness statements** in the matter, when the tenant's, similar to the landlord's have had several months to do so previously.

The RTA is clear on the rules and deadlines for submission of evidence, and the landlord's have with great effort and cost worked within those rules to provide their evidence on time as required. The tenant's, having been afforded the exact same timeframe, were required to do the same. In this matter, there is an additional level of equality in terms of submission timeframes and evidentiary rules mandated, in that BOTH the landlord and tenant are applicant and respondent's within the matter. Thus BOTH parties were required to meet identical rules and timeframes for filing.

The adjudicator in this matter has however decided he will ignore these rules, and has put forth an interim decision as follows:

"The tenant as are at liberty to file material in response to the material filed by the landlord on October 23, 2017. The tenants must file any

responding material with the Residential Tenancy Branch and provide the landlord with a copy of it on or before November 16, 2017."

Please note, the orally submitted allowance of *witness statements* as stated by Mr. Molnar on November 1st has now morphed into the allowance of documentary evidence as a whole as witnessed in the words of the order. That is terribly irresponsible. Please also note, BOTH parties submitted material on October 23, 2017 as stated...so why is the landlord not allowed to submit additional material, and where is the equality in this decision? Certainly there is no need to review a single detail of this file for the Director to see this is gross misconduct.

This interim decision, and the preceding hearing conversations, are what are prompting this email inquiry. I have already indicated that the adjudicator himself indicated twice at the conclusion of the preceding hearing of November 1, 2017, that there would be "...no further documentary evidence submissions permitted". When asked by the landlord directly as to how he can allow one party to file further evidence and not the other when the submission deadlines/timeframes/onus are identical for both parties (since both parties are both respondent and applicant in the matter), he simply chose not to answer and continued as if there was no questioning.

This is a grave misapplication of the authority delegated to him as an agent of the director by the RTA, and a critical purposeful ignorance of the evidentiary rules within the Act.

The landlord's voiced the above concerns in this matter from various angles in an attempt to have the adjudicator understand that both parties were subject to the same rules, and have had identical timeframes to file, with no new communications/issues/factors having arisen between the parties or other that would necessitate a filing extension, but were simply ignored. He was also informed that by allowing further submissions, he was allowing one party an unfair advantage by providing a supplementary timeframe and opportunity to bolster their position, and he chose to ignore this as well.

The adjudicator can not simply allow one party an extension to file without extending the same privilege to both. The landlords again iterate that they have had to put forth a monumental effort in order to meet the RTA filing deadlines, and they also have additional information in response to the tenant's filings of October 23, 2017, and would also like the opportunity to reply and respond to the

tenant's most recent filings if the tenant's are being afforded that opportunity, which they clearly are based on the interim decision rendered.

I understand the information set out above appears to be a presentation of matter best left to an adjudicator in a hearing. However, what I put before you is simple...NO adjudicator has a right to ignore the rules of evidentiary submission outlined in the RTA. In this case, Mr. Molnar has indicated directly himself that he has not reviewed the parties submissions in any depth, thus he can not be seen to be massaging the rules in an attempt at advancing a rightful determination of the matter at hand by allowing this extension, as he has only heard one party and does not have a view of the matter before him in full to make such a decision.

Mr. Molnar can not provide a unilateral extension in this manner, and also had a duty to inform the landlord's why and on what basis he is attempting to do so. He has done no such thing.

I am not seeking a supplementary oversight of this matter as a whole. I am asking for your staff to perform their duties as they are obligated by law to do so, and for you to ensure that performance meets the directives of your office as set out by the legislation and the province. I would not normally seek your assistance in an RTB hearing, but in this circumstance of clear wrongdoing I must.

I hope you can see the imbalance in procedure above and can provide some assistance to ensure we are indeed seeking to reach conclusions and render decisions as near the truth as can be possible. No party should have to rely on the Supreme Court of British Columbia to ensure the RTB is acting properly, nor bear the costs involved to do so. By asking those before you to do so, we are advising in direct opposition to the rule of law and the concepts of access.

I await your reply with hope of assistance.

Thank you for your email. Unfortunately it doesn't work the way you might be hoping for.

You can write a letter with your concerns or feedback and we can forward it to the Director's office for one of them to review and get back to you. However you would not be able to submit something only asking for a Director to phone you. They generally reply to your letter with a letter of their own after they read what you have to say.

You can include your letter for a request for a Director to contact you, but it will be at their discretion.

Furthermore, they do not involve themselves in people's cases, as that would be seen as tampering with a case or bias. They will not be helping you with an upcoming hearing, nor would they change anything for your hearing on November 23.

For example, if you are worried about arbitrator bias and you were hoping to change arbitrators before your next hearing, I will tell you that is not possible. If there is arbitrator bias, how it is dealt with is through Judicial Review with the Supreme Court of BC. You can also provide feedback afterwards about the performance of the arbitrator, but nothing will be done before the case is closed for the above reasons of tampering with the case.

Having read all of this, if you still wish to write to our Directors, please write a letter with the details of what you are concerned with. We cannot pass on an email that only says 'Please call me' without explaining the reasons. For example, you wrote that there are "very serious concerns encountered". You'll have to elaborate on what those are.

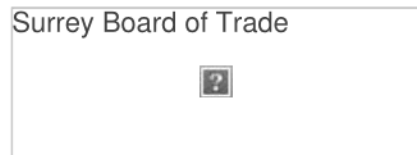

Dear UBID Administrator, UBID Board, Honorable Scott Fraser, Honorable Selena Robinson and Ministry Staff and Office of the Ombudsperson,

Union Bay on Thursday March 1 and Saturday March 3, 2018 hosted two Public "Open Houses" to provide information to Landowners regarding our VIHA mandated water treatment plant.

Several concerns regarding financing costs have been raised by Landowners and some Board Members, questioning the accuracy of the information presented on Poster Board under heading "Estimated Costs" which contains inaccurate numbers presented at both the March 1 and March 3, 2018 Open Houses. This means landowners were given and still have been given inaccurate debt repayment costs. The PDF page titled Estimated Costs has been removed from the website and nothing has replaced it. (see attached pdf.) Therefore Landowners are currently operating with incorrect calculations.

1. The concerns regarding accuracy of financial costs, estimates and projections displayed publicly on website and Open Houses include:

- Printed on the "Estimated Costs" poster board \$2 million were to be borrowed at 3.34% (3 year fixed rate term) for 20 years, UBID pays monthly \$8,559 appears incorrect. A landowner (a recently retired banker) questioned the accuracy of the monthly loan repayment (costs to UBID) noted as being \$8,559 would have had to be approximately, \$3,000 more, at least \$11,400. The incorrect amount was given as \$8,559 at both public meetings. (see attached pdf.- note that the 'estimated costs' page notice is no longer available on the UBID website) See Item 2 below

-Where did the land value of \$750,000 for the KIP donated land come from? - actual value \$1.00 and the estimate came from a telephone call with a realtor according to UBID Administrator. The 2017 Potable Water and Infrastructure Agreement designates the value of the land as \$1.00

-Calculation of CEC costs valued at \$500,00 in initial phase to support debt reduction? Union Bay has no idea if or when the KIP lots will be subdivided

-Concerns that the treatment plant is not being built in accordance to the Oct. 2017 Potable Water and Infrastructure Agreement, KIP is supposed to pay for portions which is not made clear in the publicly presented information.

-The promises made about future water capacity on the public information presented on the website and at the Open Houses - Union Bay does not actually have a comprehensive report regarding the actual capacity of Langley Lake and "proof of the availability of water through a comprehensive hydrologic analysis is absolutely necessary before undertaking investments measured in millions of dollars. p17" as recommended by Provincially Appointed Facilitator Jim Mattison in the August 2017 Report "Clear and Safe Water for Union Bay." Therefore the information presented is speculative.

-The need for the audited financial statements to be posted on line

Item 2. Concerns about how the Public was informed of the March 1 and 3 Open House and the low turnout:

-Both events had a very low turn out (approx. 8 people at March 1 and approx. 20 to 25 people on March 3 excluding UBID staff and board)

- No notice of the actual dates given in the Landowners Update which was sent out to all landowners with our water bill in February 2018.

-Notices printed in the local newspaper had very small print and were placed on the obituary page.

-Notices posted at mail boxes were also in very small print and no notices were placed on smaller mail boxes.

In recent years the Post Office has placed several smaller mail boxes in neighbourhoods. The Kilmarnock area (for example) has three extra mailboxes (Arran Road, Montrose and Kilmarnock) which had no notices posted. People getting their mail from these boxes would never have seen the notices nor received them in the mail via landowner update. The notices (in tiny print) were only posted at two mailboxes (on Spindrift and Argyle). There may be other areas of Union Bay which have the same issue (of smaller boxes with no notices) such as south Union Bay (Mystery Beach - Buckley Bay areas).

For all these reasons it may be prudent to do another Public Information Open House and correct the above omissions and errors making sure that the Public are well informed by mail and on the website. Thus far, as presented, the Landowners of Union Bay have been given inaccurate and potentially misleading financial information, which has neither been acknowledged nor corrected by the Administrator Gord Mason.

This is a massive and very expensive infrastructure project which Union Bay is faced with paying for without benefit of Infrastructure grants and/or municipal financing alarming since interest rates are predicted to be going up.

- a) convert the SCRD to a rural municipality (Minister Robinson, your authority allows you to convert the SCRD into an a rural municipality without having to use a referendum process. Without your authority, nothing will happen.)
- b) add an upper levels commercial route (along the existing powerline -- at least to Sechelt.)
- c) With an RM in place, add a forest operations/planning function based locally. Make it the HQ for Chinook forest administration.
- d) Localise the Forest Practices code to allow for the implementation of short log forestry. You will add 15% or more to the AAC and reinvigorate small manufacturing.
- e) It is imperative to install an Elphinstone Park for the long run enjoyment of the citizenry -- it should have the same stature as Stanley Park -- I envisage that logged over lands could be included as part of the package.

For your information, minor amendments to legislation may be identified from time to time as ones that are appropriate for remedy under the statute revision process undertaken by the Ministry of Attorney General.
