Dear Mr Horgan, Ms Robinson and Ms Beare,

You may be getting a lot of emails supporting the sustenance of the old Salvation Army Temple instead of letting it slide into condominiums or other commercial uses. I certainly hope so.

Vancouver is sorely lacking in Art spaces for its population. I genuinely hope you will do all you can to allow the redevelopment of this amazing building into an arts space. I understand that there are a number of decent sized “studio” rooms in this building as well as the main theatre (auditorium) space.

Currently it is hard to find a space to rehearse in for a reasonable fee. Most places charge about \$35 per hour for studio rehearsal times, which for small non-profits is like \$200 an hour!

I would propose that this building is opened, spruced up, and a certain portion of the space be rented to non-profits with the other portions being used for community recreation. The same kind of proportion could be used for the theatre. With good accoustics, the space would be very desireable for any group using voice (theatre, choirs, experimental groups like mine).

Please, please look into this wonderful resource, which has lamentably been sitting empty for years - a complete shock to me and others in the arts world.
