Hi Kathy and Tyann,

You are aware of the above case whereby a judicial review was initiated and a judge, with no legitimate jurisdiction to do so, overruled a RTB Arbitrator's decision in regard to a notice to end tenancy for a major renovation (vacant possession). The Appellant (Aarti Investments) is appealing the case and the hearing date is set for November 9<sup>th</sup> (Appellant's Factum attached). This has significant implications for the RTA, RTB and, the broader rental housing industry. LandlordBC is in the process of considering seeking intervenor status and it is very likely that we will. It strikes me that RTB/the Government should be very concerned about this situation as well.

The RTB is an expert tribunal that is invested with broad powers and its legislation contains a **privative clause**. This is intended to ensure chamber judges do not have the authority to overrule RTB decisions. This has huge implications for how RTB undertakes its legislative responsibilities. Furthermore, this judgement directly contradicts Bill 12 (May 2018) and renders it of no effect. The judgement is hugely problematic in the context of our industry's ability to responsibly reinvigorate/enhance existing purpose-built rental, much of which is very old and at the end of its functional life.

You will note that I have cc'd Craig Ashburn in the Minister Robinson's office to ensure that she too is aware of this situation.

I would welcome and appreciate any immediate thoughts and/or comments you may have. The deadline for intervenor status is September 4<sup>th</sup>. I've attached the Appellant's Factum for your review as previously mentioned.

Hello Matt and Minister Robinson,

I have taken on a new role at UBC as the Director of our Masters of Public Health program. It's a professional program with a minimum 12-week Practicum (which can be paid or unpaid). In our program, students learn that health doesn't start with health care. Health starts with the conditions into which we are born, grow, live, work and age. Since the problem of housing prices leaving earnings behind is a fundamental factor shaping those conditions, I'm encouraging students to consider pursuing Practicums with the Ministry of Housing, and other housing organizations. Given this, I'm reaching out to ask whether you can imagine any opportunities where a Masters level student with solid quantitative skills could contribute to projects, program development, or policy work in support of your multi-faceted provincial housing strategy.

Learning objectives require that the practicum expose students to opportunities to:

- Identify the information and sources of information necessary for analyzing factors that shape the conditions into which we are born, grow, live, work and age (what we call in our field the "social determinants of health").

- Apply student skills to needs assessment and/or the investigation of an issue/project on which your unit is working.
- While the field experience should include the analysis of quantitative or qualitative data or literature reviews, other opportunities to apply public health principles or knowledge about the social determinants of health are an asset and anticipated.
- Gain experience using commonly available statistical/database computer packages such as R, Epi-Info, SAS, SPSS, Excel, Lotus, D-Base, FoxPro, etc or qualitative software such as NVivo, or other relevant analytic tools for working in your field.
- Communicate information to non-medical and/or professional audiences in written formats, for example, the writing and layout of a report or a part thereof, and/or the preparation of other documents pertaining to work conducted during the practicum. In addition, each student is expected to make an oral presentation to an appropriate audience in the field setting, and an oral presentation at the University.
- Understand the structure, roles, and functioning of one or more agencies that contribute to shaping the conditions into which we are born, grow, live, work and age, including the roles of various professionals, and in particular, the opportunities/roles for public health professionals to collaborate or work within such an agency.
- Acquire in-depth knowledge on specific issues related to the determinants of health, as well as general knowledge about current factors that shape population health in Canadian communities, and strategies to influence those factors.

In sum, the provincial housing strategy is so fundamentally important to the well-being and health of British Columbians, I'm hoping your Ministry would find it mutually beneficial to host a Practicum Student(s).
