We appreciate your recommendation to contact local governments. We have tried to connect with the municipalities whom we know have the largest number of illegal AirBnB's. We have learned during this process, that the municipalities do not have the capacity to deal with the problem effectively. We have also learned that one of their initiatives is to fine the landlords if/when an illegal AirBnB is identified. Unfortunately, this strategy applies no active deterrent for those operating the illegal AirBnB.
