Hi Lisa,

I'm sorry that I haven't sent this to you sooner.

MP Wayne Stetski is hoping to arrange a meeting with the Minister, regarding BC housing (Friday the 26th of October, if possible. If not, it would have to be after the 4th of November).

Recently our office had the opportunity to meet with a variety of different housing organizers and resources within the Cranbrook area. One of the largest messages that came out of that meeting related to BC housing requiring housing organizations to provide substance friendly housing with what was coined as an "all or nothing" approach.

There is a strong need for low-income housing within the area, with nearly nonexistent vacancy rates. Housing organizers agreed that a certain number of the demographic would benefit from housing that allowed substance use, but that not all of the housing should have to have substance friendly requirements.

Organizers also recognized major barriers in providing housing with substance use, including the threat of violence as well as not having the funding and supports necessary to support individuals within that housing.

Wayne is hoping to elaborate more about the issue in his conversation with the Minister.
