Applicants are able to identify public support in a variety of ways:

- Referendum illustrating support for the project and supporting the local financial contribution requirements.
- Public/open house meetings with feedback results
- Non-binding survey results
- Letters of support from public and/or partners/stakeholders
- Partnership agreements
- Memorandums of understanding with partners/stakeholders
- Applications also require Council/Board/Band resolutions in support of the application

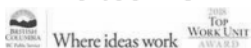

It was my understanding that the subsidy offer would be a “full subsidy” and bridge the difference between our income (PWD) and safe, suitable market rent. I also do not understand why this offer was made when mould remediation to my unit was already approved. As well, I thought that I would receive some details prior to an offer being made. The PDF document, attached, states, “As discussed, there are a series of steps that must be completed”. None of the steps outlined have been discussed with me by Mike Kim or anyone else at BC Housing. The steps required by BCH seem to significantly limit landlords

When Susan Snell visited my unit on December 12<sup>th</sup>, 2018, she mentioned that funding for a new roof, siding and windows is available for my unit and will be done in conjunction with mould remediation. However, there has been no confirmation or communication from BCH or RDHS about the scope and anticipated timeline of remediation and repairs to my unit. I understand that Ladner Willows’, another Red Door Housing Society site, had mould remediation started without delay once mould testing was done. It has been almost 4 months since my unit was tested and no work has begun. This process might just be seen as a job task to BCH and RDHS but it is my family’s health and safety that is paying the price of inaction.

Would you please provide me with news of the scope and timeline of planned remediation?

**The Province has a long standing relationship with the Salvation Army. There is a need for supportive housing in Cranbrook that addresses the needs of the current vulnerable population in a restriction-free environment.**

**BC Housing met with Salvation Army provincial leadership to discuss the project and they were unable to accommodate the restriction-free model as their supportive-housing programs are abstinence based, reflecting the mission and values of the organisation.**

**BC Housing respects this position and continues to fund a continuum of Salvation Army supportive housing programs, including homeless shelters and abstinence-based housing programs, such as the Salvation Army's Grace Manor in Vancouver.**

**BC Housing will continue to look for a site in Cranbrook to create a supportive housing project through the Supportive Housing Fund for individuals experiencing homelessness.**
