Subject: Maple Ridge ruling summary

Hello Craig,

Below is a high level summary on the Maple Ridge ruling, provided by Housing Policy. We will update the IN and upload it to SharePoint ASAP.

In his decision, Justice Grauer granted Maple Ridge all the orders sought:

- Enter, inspect and remove prohibited materials under fire act
- Remove and dispose of abandoned items
- Injunction to prevent occupants & friends from hindering fire safety measures, city work etc
- Occupants have 48 hours to sign up for housing, and/or register as camp resident
- Anyone else will have to leave or have authorization to be in the camp
- Police authorized to arrest etc

Except:

Paragraph 1 (f):

- Remove from the St. Anne Lands any building, structure or recreational vehicle/camper which has been located or constructed upon the St. Anne Lands without the written authorization of a Building Inspector for the City of Maple Ridge...

And Paragraph 3:

- An Order prohibiting any person from:
 - a. Construction any building or structure upon the St. Anne Lands contrary to a written work stop order made by a building inspector for the City of Maple Ridge; or b. occupying any build or structure upon the St. Anne Lands contrary to written Do Not Occupy Order made by a Building Inspector for the City.

And, the Judge declined to "add at this time the requirement sought by the RCMP that the camp be cleared while the contemplated steps are taken."

Judge Grauer noted the cold winter weather and said no one should have to choose between burning or freezing.

Here are the QAs that we did related to the withdrawal management centre part of the project.

Q1: What is the withdrawal management centre?

- The centre will serve as a replacement for the current Vancouver Detox Centre at 377 E. 2nd Avenue.
- The new centre would include a range of enhanced trauma-informed, culturally-appropriate services such as in-patient and out-patient withdrawal management, sobering and at-home withdrawal management (the START program) all offered in one location.
- The centre would also accommodate academic teaching and research, as well as provide a learning hub to support staff development, knowledge transfer and sharing the leading best practices in withdrawal management care and substance use treatment.
- In addition, the project includes 20 beds of short-term transitional housing for Vancouver Coastal Health clients who have completed detox so they can continue receiving access to supports while waiting for placement to longer-term housing or treatment programs for substance use.

Q2: Why does the current Vancouver Detox Centre need to be replaced?

- The current 11,000 sq. ft. site is undersized to meet the growing demands of withdrawal and substance use programs in Vancouver.
- Among other issues, the facility has failing infrastructure, spaces that do not meet minimum criteria and a facility design that doesn't support optimal best practice care.
- Securing a replacement for the Vancouver Detox Centre has long been a priority for Vancouver Coastal Health.

Q3: Will there be an impact on services?

- No beds or services will be lost as a result of the eventual move to the new purpose-built site. If anything, services will be expanded.
- The increased space available at the new centre means Vancouver Coastal Health is able to bring together services that are currently located across multiple sites, so they are in one location to better serve the needs of people with substance use disorders.
- As a result, contracted beds at Salvation Army's Harbour Light Detox centre will be transitioned into the new Vancouver Coastal Health-operated facility when ready. Vancouver Coastal Health will continue to work with the Salvation Army to provide services in the current

location until the new withdrawal management centre is opened in 3-5 years' time to ensure there is no loss of service for people in need.
