Good afternoon, **s.22** -

Thank you so much for taking the time to write to me with your suggestion. Our government is committed to the electrification of our transportation sector so your feedback is well received. BC Transit is already working to add electric buses to its fleet and TransLink will launch their fast-charging electric-battery bus trial this year.

CleanBC, our new provincial climate action strategy, speaks to our province's goals for a cleaner transportation sector. The strategy includes measures to:

- Speed up the switch to cleaner fuels by:
  - Making our fuel cleaner by increasing the low carbon fuel standard to 20% by 2030 and increasing the supply of renewable transportation fuels
  - Making vehicles run cleaner by increasing tailpipe emissions standards for vehicles sold after 2025
- Bring down the price of clean vehicles by:
  - Requiring that just over 20 years from now, every new car sold in B.C. will be a zero-emission vehicle (ZEV)
  - Helping people afford cleaner cars with ZEV incentives and save money on gasoline
  - Making it easier to charge or fuel a ZEV
