Peter,

Thanks for the invitation to contribute some thoughts. Top items on my list would be:

1. Year round services are required for homeless including shelter and supports. We have a 5 month shelter service which helps, but it is still

minimal. People sleep on mats and don't receive any "gateway services" that are provided in a full emergency shelter. From April 1 to October 31 the only provincial contribution to homelessness response is .4 FTE worker and rent supplements for 20 people. We have a huge year round problem. There is no evidence that indicated the homeless challenges are any less at different points in the year. Tent camps are everywhere, plus people in derelict boats and vehicles. Our last homeless count was 131 with of those over 80 absolutely homeless ("living rough"). Our Housing First program has close to 100 open files. The resources allocated to our community are not aligned with the obvious, clear, documented need. We need to be included FULLY in the Provincial Emergency Shelter Program and Homeless Prevention Program.

I still get the astonished reaction from people in other communities that Salt Spring has a homelessness problem. Somehow this sentiment seems to outweigh the actual facts we communicate every hear about homeless count, shelter use, RCMP contact with homeless, etc. when it comes to allocating resources. I find community to community comparisons on the stats and metrics astonishing. (SSI vs. Sechelt, Port Alberni, Campbell River etc.). The province spent over \$ 500,000 this year, combined with a similar amount the feds spent in the designated HPS communities to end up with a million dollar enumeration of homeless rates province wide. I hope this investment in research informs a more intentional, effective and fair allocation of resources.

2. Supportive Housing. Salt Spring and Southern Gulf Islands have no supportive housing units, either through BC Housing or Island Health. There are thousands of provincially funded supportive housing units either through BC Housing or VIHA, but in the South Island they are clustered in Greater Victoria. To add to the challenge we also lack specialized housing beds for mental health and addictions, which means those high need folks end up in our limited rental stock or homeless. Supportive Housing has been a major component of BC Housing over the past few years (2000 modular homes) and many rural underserved communities are benefitting. SSI has not been able to take advantage of this because we don't have and readily available that fits the narrow and specific BC Housing requirements. I expect before long the total 2000 will be allocated and we will be out of luck for many years to come. Can we get an allocation of some units and sort it out as a community where and how to develop them (eg. 1. re-purpose buildings that already have zoning and water, consider Brackett Springs, old RCMP building, SSICS site, 2. introduce a support component into the few existing affordable rentals that are struggling to maintain a quality home for high needs tenants 3. Purchase properties that could suit community housing needs such as multi family as they come on the market instead of watching them all sold and redeveloped into high end homes). The "one size fits all" plan doesn't easily fit here, so let's work with then province to make a plan that works. I think this approach could be broadened to the whole community housing strategy in a way similar to what Columbia Basin has done to custom tailor provincial funding to match community needs and capacity.

Last week I was at a presentation by Selena Robinson at the BCNPHA conference at which she was asked by a room full of housing providers "What do you need from us?" Her answer was "be creative and innovative." I don't think that memo got sent to the folks designing the current solutions! The current programs are narrow and top down at a time when we

should be expanding housing solutions. The natural way to expand solutions is to build from the ground up and invite communities to explore "what works".

3. My other thought is about community organization. We need to do way better at developing an ongoing community strategy, and ideally "speak with one voice" regarding community needs and solutions to those needs. We are scattered, which makes it very easy to be discounted when bring forth solutions to government. There was an idea years ago to form a Housing Council, but what came of that was another Non Profit Society, not a council. It has proven to be the wrong tool for the job. We are more scattered than ever. Time to wipe the slate clean and pull together stakeholders to identify what kind of mechanism and structure we need to do community planning effectively. It may need a bit of funding to thrive, but not much. It shouldn't be a new entity unto itself and yet another mouth to feed. It mainly needs a thoughtful process and design and suits its intended purpose.

A bit long winded as usual, but there are my thoughts of the day ! I hope the meeting goes well.

Hon. Selina Robinson: I just attended the affordable housing conference in

Vancouver and listened to your speech on Sunday morning.

You used the Wizard of Oz and “there’s no place like home” as the theme but I think you overlooked the most important part of that story. It’s about Dorothy and Toto - a dog that she loves more than anything or anyone and would do anything for - including risking her life! (Photo attached.)

I manage a seniors’ building,<sup>s.22</sup> - that has allowed pets for over 40 years. Pets are a very important part of many people’s lives and studies show that children and seniors and people who live alone especially have a better quality of life if they have a pet.

I attended a very informative session at the conference on Pet-Friendly buildings. I wish you had been there and could have heard the facts presented. I was very encouraged to learn that Pacifica Housing has decided to make all of their buildings pet-friendly now. With the proper rules and guidelines in place I am sure they will find good tenants who will be very grateful that they can have pets as part of their life.

s.22 Pets OK BC, a group that is trying to have the legislation changed in BC to what Ontario has had for over twenty years now - that landlords can’t discriminate against pets. They presented a petition to your government months ago with thousands of signatures and are still collecting more. I hope this legislation will happen. The number one reason pets are surrendered is because people can’t find a place to live that allows pets. It is a heartbreaking situation and making the housing crisis even worse. Yes, everyone has a horror story about a dog or a cat and the damage they did but that tenant would have been a bad tenant whether they had a pet or not. It is NEVER the pet’s fault - always the person’s.

s.22 I am aware you may never actually see this email unless someone decides to show it to you. I will mail a hard copy as well and hope you see it and give this matter

your serious consideration. I can't think of anything you could do as Housing minister that would enrich the lives of people in BC more than ensure this legislation is passed. You may have some landlords annoyed with you at first but most of them are never going to vote NDP anyhow - and will probably be quite surprised to find that they may have less problems than they do now with pet restrictions.

I was so glad that you and the Premier made time in your busy schedules to attend the conference. Everyone there appreciated it and also the unprecedented funding you have made available to help with the housing crisis after sixteen years of the BC Liberals doing absolutely nothing. Now if only all of these homes would also allow pets that would be a wonderful lasting legacy for your government - and hopefully ensure re-election with a huge majority!

Following up from the December 7<sup>th</sup> DARWG meeting, I wanted to confirm that the Ministry is working to organize and summarize the feedback participants provided; we anticipate being able to provide a draft to you before the end of the week and propose to circulate to WG participants in the first week of January, in order to solicit feedback in advance of the January technical committee meetings.

At the working group meeting two questions were raised by UBCM that I would appreciate your feedback on:

- The proposed date for the second DARWG (February 22) conflicts with UBCMs Executive meeting and advocacy days – as a result, the UBCM members would not be able to attend. Subject to feedback, it is proposed that the WG meeting date be moved to February 14<sup>th</sup>, and that participants be advised of the change before the end of this week. While dates have been provided in advance to allow for planning, a new February date is far enough out that any potential impact on attendance is expected to be minimal. Changing the date would also support the relationship with UBCM and ensure they maintain a connection and engagement with the process and any proposed actions.
- UBCM has requested that staff be allowed to participate in / observe the DARTCs. We have not identified any concerns with this proposal as it would ensure UBCM is connected to the conversations, and is not expected to impact the scope of the conversations.

On a related matter, following the initial distribution of invitations for the DARTCs, we are proposing



some amendments to the participants based on responses. We will send these under separate cover for consideration shortly.

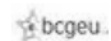
